Opinion

We have audited the financial statements of Northern Minnesota-Wisconsin Area Retail Food Health and Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Description of the Plan

Northern Minnesota-Wisconsin Area Retail Food Health and Welfare Fund (the Plan) was established as a result of collective bargaining agreements between the local union and contributing employers. The Plan is a multiemployer welfare plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides comprehensive medical benefits (Plan A) including medical, prescription drug, dental, vision, death, accidental death and dismemberment (AD&D), and short-term disability benefits for eligible participants and their dependents. In addition, the Plan provides certain health care benefits for eligible retired participants who make contributions to the Plan.

The Plan established an alternative Plan design (Plan B) that excludes the following ancillary benefits: dental, vision, death, accidental death and dismemberment and short-term disability. Participants offered Plan B have the opportunity to purchase the ancillary benefit coverage through payroll deductions with their respective employer.

The Plan covers substantially all individuals working under collective bargaining or other agreements who have fulfilled minimum service requirements. Participants consist primarily of certain grocery store and nursing home workers in Minnesota and Wisconsin. The terms of collective bargaining agreements determine which plan of benefits (Plan A or Plan B) will be offered, including eligibility for single and family coverage.

The Plan utilizes a "1-2-3" lag month reporting process for eligibility, regardless of the plan of benefits for which the participant is eligible, as follows:

1. Work month is the month that contributions are required on the participant's behalf.
2. Report month is the month that the Plan receives the required contributions on the participant's behalf, which is the month following the work month.
3. Coverage month is the month following the report month.

To become initially eligible for benefits, participants must have reached the level of monthly contributions required by each collective bargaining agreement. Coverage begins on the first day of the month following the month during which the participant meets this eligibility requirement, as described above. Participants maintain eligibility as long as their employer continues to make the required contributions on their behalf.

Note 1. Description of the Plan (continued)

Medicare eligible retired participants are offered enrollment in a fully insured Medical Supplement program. Retirees who elect coverage through the Plan are charged the cost of coverage through a monthly premium set annually by the Board of Trustees.

Continuation of health care benefits to persons who could otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (COBRA), has been adopted by the Plan.

Participants should refer to the summary plan description for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Investments - Investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of investments are reflected on a trade-date basis.

Contributions Receivable - Employer contributions due and not paid prior to year end are recorded as contributions receivable. Deficiencies established through payroll compliance audits are recognized upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of participants covered and the monthly contribution rates set forth in the collective bargaining agreements. Employers are required to remit contributions monthly.

Benefits - The Plan is primarily self-funded for medical, prescription drug, dental, vision, AD&D, and short-term disability benefits. Medicare eligible retiree medical and prescription drug benefits are provided under a non-experience rated group insurance policy with UnitedHealthcare.

Prescription Drug Rebates - The Plan utilizes a pharmacy benefit manager (PBM) who periodically makes rebates to the Plan based on the Plan's actual utilization pattern of specific drugs. Rebates due from the Plan's PBM are recorded when earned.

Note 2. Summary of Significant Accounting Policies (continued)

Subrogation Settlements - Claims that are reimbursed pursuant to subrogation matters are recorded upon settlement. Subrogation matters involve third parties from whom the Plan seeks reimbursement for claims paid by the Plan.

Stop-Loss Insurance - The Plan maintains a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. Under the terms of the contract, individual participant claims incurred in excess of specific limits within the contract year are reimbursed to the Plan. During the years ended December 31, 2024 and 2023, the contract limit was \$635,000. Reimbursements for claims exceeding contract limits for the years ended December 31, 2024 and 2023 amounted to \$314,464 and \$0, respectively.

Benefit Obligations - Benefit obligations are estimated by the Plan's actuarial consultant in accordance with accepted actuarial principles, based on paid and incurred claims cost studies, Plan benefits, claims experience, and other data as considered necessary.

The obligation for future earned coverage represents an estimate of claims which will be due the following year for the participants who had been credited with sufficient hours prior to December 31 to maintain eligibility after year end. The obligation has been estimated using the total weekly projected cost per participant multiplied by the total weeks of future earned coverage, as determined by the Plan's consulting actuary and the Plan's eligibility records.

Reclassifications - Certain reclassifications have been made to prior year amounts to conform to the current year presentation.

Estimates - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan.

Note 4. Tax Status

The Plan received a notice of exemption dated October 16, 1980, in which the Internal Revenue Service advised that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the original notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Concentration of Cash

Cash consists of monies held in checking accounts. The Plan maintains its cash balances with financial institutions deemed to be creditworthy. Balances are insured by the Federal Deposit Insurance Corporation up to \$250,000 per financial institution. Although balances may at times exceed insured limits, Plan management believes its credit risk to be minimal.

Note 6. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

Level 1 Measurements

U.S. Treasury securities are traded in active markets on national and international securities exchanges and are valued at closing prices on the last business day of each period presented.

The fair values of the exchange-traded funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Note 6. Fair Value Measurements (continued)

Level 2 Measurements

Corporate obligations are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. To the extent that quoted prices are not available, fair value is determined based on a valuation model that includes inputs such as interest rate yield curves and credit spreads. Securities traded in markets that are not considered active are valued based on quoted market prices, broker or dealer quotations, or alternative pricing sources with reasonable level of price transparency. Securities that trade infrequently, and therefore have little or no price transparency are valued using the investment manager's best estimates.

The certificate of deposit is valued at cost, which approximates fair value.

Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could be material. The current economic environment has increased the degree of uncertainty.

Note 7. Funding Policy

The Plan is primarily funded by employer contributions as specified in the collective bargaining agreements. Monthly employer contribution rates for the majority of participants under the Plan ranged from \$1,725 to \$1,750 for family coverage and from \$740 to \$765 for single coverage during the years ended December 31, 2024 and 2023.

Participant contributions are also allowed to provide benefits under COBRA. COBRA monthly rates ranged from \$736 to \$1,829 during the years ended December 31, 2024 and 2023, depending on the participant's coverage options.

As described in Note 1, eligible retired participants are allowed to self-pay monthly contributions for fully insured benefit coverage. Retiree self-payment monthly rates ranged from \$254 to \$286 during the years ended December 31, 2024 and 2023.

Note 8. Major Employers

Contributions from two employers accounted for approximately 82% and 81% of total contributions for the years ended December 31, 2024 and 2023, respectively. In the event these employers were to suspend contributions, the Plan would terminate coverage to the employers' participants as required in the Plan document. The Plan would retain the risk of meeting fixed administrative expenses until the appropriate adjustments were made.

Note 9. Participant Contributions

Employers withhold a portion of the monthly contribution through payroll deductions. Employers may at times remit contributions to the Plan more than 90 business days after the following month, which does not meet the timeliness requirements as prescribed by U.S. Department of Labor regulations.

The Plan has a collection program that pursues legal action against delinquent employers. As part of its collection program, the Plan regularly collects contributions, liquidated damages, interest and attorney fees from delinquent employers.

Note 11. Related Organizations

The Plan is related to a pension plan and a local union, both of which are tax-exempt.

Note 12. Party-in-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain employees of the Plan's third-party administrator are covered under the Plan through a collective bargaining agreement between the Plan and the third-party administrator. Total contributions received under this arrangement were \$152,695 and \$160,540 during the years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions, which Plan management believes are exempt from the prohibited transaction rules of ERISA.
