Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Crossing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of The Crossing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for more complete information.

General

The Plan is a defined contribution plan, established January 1, 2014, covering all employees of The Crossing (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees are eligible to begin making salary deferral and Roth contributions upon attainment of age 21. Participants are eligible to receive the Employer safe harbor matching contribution and profit sharing contribution upon attainment of age 21 and completion of three months of service. Participants are also required to complete 1,000 hours of service to receive the profit sharing contribution. Entry dates are the first day of each month following meeting the eligibility requirements.

The Plan provides for an automatic enrollment provision. Participants will be automatically enrolled in the Plan at a default salary deferral percentage of 5% of eligible compensation. Participants may change the contribution percentage or elect to opt out of participation at anytime.

Contributions

Participants may defer salary up to 100% of compensation, not to exceed Internal Revenue Service (IRS) limits. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

The Employer makes safe harbor matching contributions equal to 100% of the amounts contributed by each participant, not to exceed the first 5% of compensation. The safe harbor matching contribution amounted to \$247,622 and \$249,181 for the years ended December 31, 2024 and 2023, respectively.

The Plan also provides for a discretionary profit sharing contribution. The profit sharing contribution amounted to \$61,298 and \$67,196 for the years ended December 31, 2024 and 2023, respectively.

Notes To Financial Statements (*Continued*)

Notes Receivable From Participants

A participant may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The maximum number of loans outstanding at any time is two. Notes are for a period not to exceed five years. Loans are secured by the participants' account balance. Notes bear interest at the prime rate, as published in the Wall Street Journal, plus 2%. Notes are repaid through payroll withholdings.

Prior to September 2014, notes issued for the purchase of a primary residence were allowed repayment terms in excess of five years, as determined by the Plan Administrator.

Vesting

Participants are immediately vested in their salary deferral and Roth contributions, rollover contributions, and Employer safe harbor matching contributions plus actual earnings thereon. Participants vest in the Employer profit sharing contribution 20% each year, becoming 100% vested after five years. Participants also become 100% upon death or becoming disabled.

Forfeitures

Participants who terminate their employment and are less than 100% vested will forfeit the nonvested portion of their account. Forfeited nonvested accounts may be used for any permissible method (restore forfeitures, reduce Employer contributions (or reallocate as additional Employer contributions) or to pay Plan expenses) under Plan provisions. At December 31, 2024 and 2023, no forfeitures were available for future use. No forfeitures were used to fund Employer contributions or Plan expenses during the year ending December 31, 2024. Forfeitures totaling \$9,052 were used to fund Plan expenses during the year ending December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's salary deferral and Roth contributions, rollover contributions, the Employer's contributions and an allocation of the Plan's earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

THE CROSSING 401(k) PLAN

Notes To Financial Statements (*Continued*)

Payment Of Benefits

A participant is eligible to receive a distribution from their vested account upon termination of employment, death, becoming disabled, or attaining normal retirement age (65). Benefits are made in the form of lump sum cash payments.

In-Service Withdrawals

Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

Active participants who experience a qualifying financial hardship may withdraw all or part of their elective deferral accounts only, excluding related earnings. Hardship withdrawals will be approved only if they conform to the Plan and established IRS safe harbor provisions.

Administrative Expenses

The Plan pays certain expenses, including third party administrator and contract administration fees. All other expenses are paid by the Employer.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Notes To Financial Statements *(Continued)*

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Ascensus LLC, as agent for Ascensus Trust Company, and furnished to the Plan Administrator. 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds And Money Market Fund

Valued at the daily closing price as reported by the fund. Mutual funds and money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

5. Transactions With Parties In Interest

The Plan's investments are managed by Vanguard. Fees incurred by the Plan for investment management services are included within the net change in fair value of investments as they are paid through revenue sharing rather than a direct payment. During 2024 and 2023, the Plan also paid fees to Vanguard for certain administrative functions totaling \$36,432 and \$31,373 for the years ended December 31, 2024 and 2023, respectively. In addition, certain Plan participants have outstanding loans with the Plan as of December 31, 2024 and 2023.

These transactions qualify as exempt party in interest transactions under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Income Tax Status

The Plan adopted a non-standardized pre-approved plan document sponsored by Ascensus LLC. Ascensus LLC received an IRS opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself did not receive a determination letter. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan and the related trust are tax-exempt as of the financial statement date.

8. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
