NOTE 1. DESCRIPTION OF THE PLAN

The following description of Platinum Nine Holdings dba NW Ambulance, LLC 401(k) Plan, provides only general information. Participants should refer to the Plan Document and related Adoption Agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution 401(k) plan covering substantially all employees of Platinum Nine Holdings dba NW Ambulance, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended, and is designed as an ERISA Section 404(c) plan. Accordingly, the participants, and not the Plan fiduciaries, are responsible for investment decisions relating to their participant account assets under the Plan.

The Plan was amended and restated effective January 1, 2022, to comply with regulatory requirements. The Plan was amended and restated effective July 1, 2023, in connection with changes in service providers. Changes made with the 2023 restatement are integrated into the information below, as relevant.

Eligibility – Employees are immediately eligible to participate in the Plan. Participation begins of the first day of the month following meeting the service requirement. The Plan does not include employees who are nonresident aliens or residents of Puerto Rico.

Contributions – The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code. Participants are permitted to elect to contribute from 1% to 90% of their eligible compensation, subject to statutory limits. Participants may elect to make either pre-tax or after-tax "Roth" contributions based on eligible compensation as defined in the Plan. The Plan allows participants that have attained the age of 50 to make catch-up contributions. The Plan includes an automatic enrollment feature. Unless a participant elects a different rate, the automatic enrollment feature provides for a 1% contribution rate.

Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Plan provides that the Company will make a matching contribution equal to 100% of employee salary deferrals of up to 5% of eligible compensation measured on a pay-period basis.

The Plan provides that the Company may also make discretionary matching contributions or annual profit-sharing contributions to eligible participants. There were no discretionary matching or profit sharing contributions for the years ended December 31, 2024 and 2023.

Vesting - Participants are immediately vested in their pre-tax account, amounts rolled over from other qualified plans, and any earnings thereon. The Company's matching and profit-sharing contributions, and any earnings thereon, are fully vested using a cliff vesting schedule after three years of continuous service. Participants are 100% vested in all accounts upon reaching normal retirement age, death, or disability.

Participant accounts - Each participant's account is credited with the participant's contribution, Company contributions, and allocations of Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants may direct their investments into a variety of mutual funds. The net asset values of the mutual funds are based on quoted market prices.

Notes receivable from participants - Participants may borrow from their participant accounts a minimum of \$500 up to a maximum equal to the lesser of one-half of their vested account balance, excluding Roth deferral accounts and related earnings thereon, or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loan repayment terms are five years or less, except loans used to acquire a primary residence may be repaid over thirty years or less. The loans are secured by the participant's vested account balance. Loans bear interest at Prime Rate as reported by the Wall Street Journal.

A participant may have only one loan outstanding at any time. The loans are secured by the participant's vested account balance and bear interest at a rate commensurate with prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. If a participant terminates, their loan plus accrued interest becomes due and payable to the Plan.

If a participant terminates or fails to make payments when due, the loan will be in default. Upon default, the entire principal balance and interest will become due and payable to the Plan. The amount of the outstanding loan will be treated as a distribution. No allowance for uncollectable notes receivable from participants was considered necessary as of December 31, 2024 or 2023.

Payment of benefits – Upon termination of service due to death, disability, retirement or termination of employment, a participant, or their beneficiary in the case of death, will receive a benefit equal to the value of the participant's vested interest in his or her account in the form of a lump-sum payment, installment payments, or a direct rollover to an eligible retirement plan. If the participant's account balance is \$5,000 or more, the Participant may choose to defer receiving payment until required under Required Minimum Distribution rules and regulations.

If the vested account balance of a terminated participant is less than \$5,000, the Plan may automatically distribute the funds. If the balance is over \$1,000 the funds will be rolled over into an individual retirement account for the benefit of the participant. If the balance is \$1,000 or less the amount will be paid in a lump-sum distribution.

Participants that have attained age 59 ½ may withdraw participant contributions in their account while still employed by the Company.

Participants that incur a financial hardship, as defined in the Plan, may request to receive a distribution. Hardship distributions are made subject to approval by the Company in a non-discriminatory manner.

Forfeitures - Forfeitures of terminated participants' non-vested account balances can be used to pay plan expenses and/or to reduce the Sponsor's matching contributions. Forfeited non-vested account balances were \$111,935 and \$61,334 at December 31, 2024 and 2023. During the year ended December 31, 2024, forfeited non-vested accounts were utilized to reduce employer matching contributions by \$54,148 and pay plan expenses of \$37,390. During the year ended December 31, 2023, forfeited non-vested accounts were utilized to reduce employer matching contributions by \$74,271 and pay plan expenses of \$7,660

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by its investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees may be charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document and related Adoption Agreement.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by applicable laws and regulations are recorded as excess contributions payable. The amounts have been recorded as reductions to contributions for the years in which the contributions were made. In addition, during the year ended December 31, 2024, the balance includes \$53,369 of contributions related to a duplicate remittance of contributions for a pay period. The amount was returned in 2025.

Payment of benefits - Benefits to participants and beneficiaries are recorded when paid.

Expenses - The Plan provides that certain expenses of the Plan may be paid by the Plan or the Company. Expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are included within net appreciation of fair value of investments. General administrative expenses not paid by the Company are allocated to participant accounts based on net assets. Participant specific expenses related to participant notes receivable and distributions are charged to specific participants' accounts. During the years ended December 31, 2024 and 2023, the Company paid significant costs of administering the Plan.

Subsequent events – Plan management has evaluated subsequent events up to October 15, 2025, the date when the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data through correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund to the custodian. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered actively traded.

NOTE 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in all account balances. Plan assets will be distributed to the participants after payment of expenses properly chargeable to the trust fund. The accompany financial statements have been prepared assuming the Plan will continue as a going concern.

NOTE 5. FEDERAL INCOME TAX STATUS

Effective January 1, 2022, the Plan adopted a Non-Standardized Pre-Approved Profit-Sharing Money Purchase Plan with CODA developed by ADP. ADP received a favorable opinion letter for their plan which was dated October 6, 2020, and which states that the plan as submitted is acceptably designed and in compliance with Section 401 of the Internal Revenue Code.

Effective July 1, 2023, the Plan adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA developed by Ascensus LLC (Ascensus). Ascensus received a favorable opinion letter for their plan which was dated June 30, 2020, and which states that the plan as submitted is acceptably designed and in compliance with Section 401 of the Internal Revenue Code.

The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. With certain exceptions, the Plan is no longer subject to examination by U.S. federal tax authorities three years after the filing date.

NOTE 6. RISK AND UNCERTAINTIES

The Plan allows participants to direct contributions into funds of various investment securities. The underlying securities of these funds are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain underlying securities and the level of uncertainty related to changes in the values of the funds, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 7. CERTIFICATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Ascensus, LLC, an authorized representative of Ascensus Trust Company and Newport Trust Company, collectively the custodian of the Plan, has certified as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the activities reported in the statements of changes in net assets for the years then ended, and the supplementary Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Ascensus and its affiliates, as well as certain other service providers, may receive fees from the Plan or from the investments for providing certain administrative recordkeeping services. These transactions, therefore, represent party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. Any investment fees are offset against Plan investment income and losses as presented in the statement of changes in net assets available for benefits. The prospectus of each investment should be referred to for details regarding the various types and amounts of investment fees charged.

NOTE 9. COMPLIANCE

As a result of the changes in service providers during 2023, Plan management failed to obtain the bonding or insurance coverage for 2024 as required by ERISA. No adjustments have been made to these financial statements as a result of this noncompliance with applicable rules and regulations. Upon recognition of this oversight, subsequent to year-end Plan management obtained required coverage.

The Plan did not satisfy the required nondiscrimination tests for the years ended December 31, 2024 and 2023. Certain highly compensated employees in the Plan had excess contributions and related net earnings totaling \$22,966 and \$17,006, respectively, which were returned in the subsequent year to satisfy relevant nondiscrimination rules and regulations.

During the year ended December 31, 2024, the Company failed to remit \$31,755 of participant salary deferrals and loan repayments in a timely manner in accordance with applicable rules and regulations. During 2025, the Plan Administrator concluded that the necessary corrections had been made.
