Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i- Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of the Irdeto USA, Inc. Savings Plan (the Plan). Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan adopted effective July 1, 1995 and amended effective October 1, 2012, covering substantially all employees of Irdeto USA, Inc. and affiliated companies (collectively, the Company or Plan Sponsor). Employees who are leased, residents of Puerto Rico, or are non-resident aliens who do not receive U.S. income or are not characterized as employees on the records of the Company are not eligible to participate. All other employees are eligible to participate in the Plan if they have at least three months of service time with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible participant can enter the Plan on the first day of each month.

Trustee and Administration of the Plan

The Company and certain members of management who are the Plan fiduciaries also act as the Plan administrator, and as such, are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or Trustee). The Trustee holds all the Plan's assets, executes investment transactions, makes payments as directed by Plan participants, and provides recordkeeping and other functions, as defined.

Contributions

Each year, participants may contribute between 1% and 60% of pretax annual compensation, as defined in the Plan, up to the maximum limit as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, during certain designated payroll periods, participants may defer up to 100% of eligible compensation on a pretax basis as long as the total amount of a participant's contribution does not exceed 60% of pretax annual compensation or the maximum limits set by the IRC. Participants aged 50 or older may contribute catch-up contributions of up to the maximum limit as defined by the IRC.

Effective January 1, 2024, the Plan was amended to permit Participants to irrevocably designate that a portion or all of the Deferral Contributions made are Roth 401(k) Contributions that are includable in the Participant's gross income at the time deferred.

The Company makes a matching contribution to the Plan for the benefit of eligible participants who contributed to the Plan during the year. The Company makes a matching contribution in an amount equal to 50% of a participant's compensation contributed to the Plan subject to a maximum of 10% of a participant's annual base compensation. Matching contributions will not include age 50 and over catch-up contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of Plan earnings or losses and charged with transaction-related administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions are also immediately vested.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period, or 50% of their vested account balance. A participant can only have one loan outstanding at any given time. Notes receivable from participants are secured by the balance of the participant's account and bear interest at reasonable rates of interest, as determined by the Plan administrator. Repayment should be made through after-tax payroll deductions. The maximum loan term is five years except for the purchase of a principal residence, which may be repaid over a term not to exceed ten years. As of December 31, 2024, the rates of interest on outstanding loans was 9.5% with various maturities through July 2029.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant or beneficiary may elect to receive their benefits as either a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. Participants with vested account balances of \$1,000 or less will receive an automatic lump-sum cash payout, and balances between \$1,000 and \$5,000 may be rolled into an individual retirement account at the discretion of the Company. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited accounts either to correct excess aggregate contributions or excess deferrals totaled approximately \$4,161 and \$3,958, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. None of the forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make certain estimates and assumptions that affect the reported amounts of assets and changes therein and the disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Administrative Expenses

Administrative expenses recorded in the Plan represent amounts incurred for recordkeeping services and other administrative-type services, including expenses related to the processing of participant loans and distributions, which are directly paid from each respective participant's account as permitted by the service agreement with the Trustee, and are paid by the Plan. Otherwise, the Company pays substantially all other administrative expenses of the Plan. Any expenses paid by the Company are excluded from these financial statements.

Revenue Credits

The Plan's trust agreement with Fidelity provides for a participant revenue credit arrangement, whereby the Trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds based on a defined formula or the employer may direct to use revenue credits to reimburse the employer for administrative expenses. The amount allocated for the year

ended December 31, 2024, was \$39,310. The amount disclosed in the statement of changes in net assets available for benefits as administrative expenses is the excess of Revenue credit after adjusting the administrative expenses of \$26,809.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common and Collective Trust (CCT) - CCTs are valued at NAV per unit, as determined by the Trustee at year-end, which includes an indirect investment in fully benefit-responsive investment contracts. The NAV is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective

trust, the investment adviser reserves the right to temporality delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of NAV or reflective of future fair value. Furthermore, while the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different estimates of fair value at the reporting date.

Participant-directed withdrawals of Fidelity Managed Income Portfolio Class 1 Fund units may be made on any business day. Participant-directed exchanges to another investment option may be made on any business day as long as the exchange is not directed into a competing fund (money market funds or certain other types of fixed-income funds). Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund may occur. Withdrawals directed by a plan sponsor must be preceded by 12 months' written notice to the MIP CL 1 Fund Trustee. The MIP CL 1 Fund Trustee may, in its discretion, complete any such Plan-level withdrawals before the expiration of such 12-month period. Additionally, the MIP CL 1 Fund Trustee may defer completing a withdrawal directed by a participant or plan sponsor where doing so might adversely affect the MIP CL 1 Fund portfolio. The MIP CL 1 Fund Trustee shall make the payments available as quickly as cash flows and prudent portfolio management permits. Further, there are no unfunded commitments as of December 31, 2024 and 2023.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended

December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments Institutional Services Company, Inc. and a common and collective trust managed by Fidelity. Fidelity is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Any transactions involving these investments are on the open market at fair value or contract value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under the prohibited transaction rules.

For the year ended December 31, 2024, administrative expenses include expenses paid directly by participants for participants loan and other transaction-related fees and qualify as party-in-interest transactions. The amount of revenue credit allocated for the year ended December 31, 2024 was \$39,310 as stated in Note 2. The amount disclosed in the statement of changes in net assets available for benefits, as administrative expenses of \$26,809. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. Notes receivable from participants also reflect party-in-interest transactions. However, these transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their Company contributions.

8. Tax Status

The Plan document is a pre-approved defined contribution plan. The Internal Revenue Service (IRS) informed FMR LLC by a favorable opinion letter dated June 30, 2020, that the pre-approved plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not

be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

In accordance with ASC 855, *Subsequent Events*, the Plan has evaluated subsequent events from the date of the statement of net assets available for benefits through October 15, 2025, the date the financial statements were available to be issued. During this period, no material recognizable subsequent events were identified.

Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year ended December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. Description of the Plan

The following description of the Irdeto USA, Inc. Savings Plan (the Plan). Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan adopted effective July 1, 1995 and amended effective October 1, 2012, covering substantially all employees of Irdeto USA, Inc. and affiliated companies (collectively, the Company or Plan Sponsor). Employees who are leased, residents of Puerto Rico, or are non-resident aliens who do not receive U.S. income or are not characterized as employees on the records of the Company are not eligible to participate. All other employees are eligible to participate in the Plan if they have at least three months of service time with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible participant can enter the Plan on the first day of each month.

Trustee and Administration of the Plan

The Company and certain members of management who are the Plan fiduciaries also act as the Plan administrator, and as such, are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or Trustee). The Trustee holds all the Plan's assets, executes investment transactions, makes payments as directed by Plan participants, and provides recordkeeping and other functions, as defined.

Contributions

Each year, participants may contribute between 1% and 60% of pretax annual compensation, as defined in the Plan, up to the maximum limit as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, during certain designated payroll periods, participants may defer up to 100% of eligible compensation on a pretax basis as long as the total amount of a participant's contribution does not exceed 60% of pretax annual compensation or the maximum limits set by the IRC. Participants aged 50 or older may contribute catch-up contributions of up to the maximum limit as defined by the IRC.

Effective January 1, 2024, the Plan was amended to permit Participants to irrevocably designate that a portion or all of the Deferral Contributions made are Roth 401(k) Contributions that are includable in the Participant's gross income at the time deferred.

The Company makes a matching contribution to the Plan for the benefit of eligible participants who contributed to the Plan during the year. The Company makes a matching contribution in an amount equal to 50% of a participant's compensation contributed to the Plan subject to a maximum of 10% of a participant's annual base compensation. Matching contributions will not include age 50 and over catch-up contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of Plan earnings or losses and charged with transaction-related administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions are also immediately vested.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period, or 50% of their vested account balance. A participant can only have one loan outstanding at any given time. Notes receivable from participants are secured by the balance of the participant's account and bear interest at reasonable rates of interest, as determined by the Plan administrator. Repayment should be made through after-tax payroll deductions. The maximum loan term is five years except for the purchase of a principal residence, which may be repaid over a term not to exceed ten years. As of December 31, 2024, the rates of interest on outstanding loans was 9.5% with various maturities through July 2029.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant or beneficiary may elect to receive their benefits as either a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. Participants with vested account balances of \$1,000 or less will receive an automatic lump-sum cash payout, and balances between \$1,000 and \$5,000 may be rolled into an individual retirement account at the discretion of the Company. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited accounts either to correct excess aggregate contributions or excess deferrals totaled approximately \$4,161 and \$3,958, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. None of the forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make certain estimates and assumptions that affect the reported amounts of assets and changes therein and the disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Administrative Expenses

Administrative expenses recorded in the Plan represent amounts incurred for recordkeeping services and other administrative-type services, including expenses related to the processing of participant loans and distributions, which are directly paid from each respective participant's account as permitted by the service agreement with the Trustee, and are paid by the Plan. Otherwise, the Company pays substantially all other administrative expenses of the Plan. Any expenses paid by the Company are excluded from these financial statements.

Revenue Credits

The Plan's trust agreement with Fidelity provides for a participant revenue credit arrangement, whereby the Trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds based on a defined formula or the employer may direct to use revenue credits to reimburse the employer for administrative expenses. The amount allocated for the year

ended December 31, 2024, was \$39,310. The amount disclosed in the statement of changes in net assets available for benefits as administrative expenses is the excess of Revenue credit after adjusting the administrative expenses of \$26,809.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common and Collective Trust (CCT) - CCTs are valued at NAV per unit, as determined by the Trustee at year-end, which includes an indirect investment in fully benefit-responsive investment contracts. The NAV is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective

trust, the investment adviser reserves the right to temporality delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of NAV or reflective of future fair value. Furthermore, while the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different estimates of fair value at the reporting date.

Participant-directed withdrawals of Fidelity Managed Income Portfolio Class 1 Fund units may be made on any business day. Participant-directed exchanges to another investment option may be made on any business day as long as the exchange is not directed into a competing fund (money market funds or certain other types of fixed-income funds). Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund may occur. Withdrawals directed by a plan sponsor must be preceded by 12 months' written notice to the MIP CL 1 Fund Trustee. The MIP CL 1 Fund Trustee may, in its discretion, complete any such Plan-level withdrawals before the expiration of such 12-month period. Additionally, the MIP CL 1 Fund Trustee may defer completing a withdrawal directed by a participant or plan sponsor where doing so might adversely affect the MIP CL 1 Fund portfolio. The MIP CL 1 Fund Trustee shall make the payments available as quickly as cash flows and prudent portfolio management permits. Further, there are no unfunded commitments as of December 31, 2024 and 2023.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended

December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments Institutional Services Company, Inc. and a common and collective trust managed by Fidelity. Fidelity is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Any transactions involving these investments are on the open market at fair value or contract value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under the prohibited transaction rules.

For the year ended December 31, 2024, administrative expenses include expenses paid directly by participants for participants loan and other transaction-related fees and qualify as party-in-interest transactions. The amount of revenue credit allocated for the year ended December 31, 2024 was \$39,310 as stated in Note 2. The amount disclosed in the statement of changes in net assets available for benefits, as administrative expenses of \$26,809. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. Notes receivable from participants also reflect party-in-interest transactions. However, these transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their Company contributions.

8. Tax Status

The Plan document is a pre-approved defined contribution plan. The Internal Revenue Service (IRS) informed FMR LLC by a favorable opinion letter dated June 30, 2020, that the pre-approved plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not

be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

In accordance with ASC 855, *Subsequent Events*, the Plan has evaluated subsequent events from the date of the statement of net assets available for benefits through October 15, 2025, the date the financial statements were available to be issued. During this period, no material recognizable subsequent events were identified.
