Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of T. A. Systems, Inc. Integrated 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of T. A. Systems, Inc. NOTE A - DESCRIPTION OF PLAN

The following brief description of the T.A. Systems, Inc. Integrated 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan allowing elective deferrals for substantially all eligible non-union employees of T.A. Systems, Inc. (the Company) who are over the age of 21 and have completed three months of consecutive service. Eligible employees must meet the same requirements to become eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The SECURE 2.0 Act was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates. The Plan is required to operate in compliance with the mandatory provisions as of their effective date. The Plan Administrator will determine which optional provisions to elect and will amend the Plan document accordingly. As of December 31, 2024, the Plan Administrator has not adopted any optional provisions.

Contributions:

The Plan provides for employee salary 401(k) pre-tax contributions up to the maximum tax deferred limitations established by the Internal Revenue Code. The total annual participant voluntary contribution is limited to \$23,000 for 2024. An additional \$7,500 contribution is allowable for those employees that are age 50 or older for 2024. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. On January 1, 2024, the Plan document was amended to allow participants the opportunity for Roth elective deferrals.

The Company also makes a nondiscretionary 100 percent safe harbor matching contribution up to the first three percent of employee deferrals and 50 percent of the employee's contributions up to the next two percent. Profit sharing contributions may be contributed to eligible employees who have completed one year of service at the discretion of the Company's board of directors.

Participant Accounts:

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting:

Participants are immediately 100 percent vested in employee salary, rollover contributions, and Company safe harbor matching contributions and any income or loss thereon. Vesting in the Company's profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants are 20% vested in matching contributions after 2 years and an additional 20% each year thereafter until they become fully vested after 6 years of service.

Notes Receivable from Participants:

Participants may borrow from their accounts subject to certain maximum and minimum amounts as prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Benefit Payments:

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Forfeitures:

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions. There were no amounts forfeited for 2024 and 2023. No employer contributions were reduced from forfeited nonvested accounts in 2024 and 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition:

Shares of pooled separate accounts are valued at estimated fair value, which have been determined based on the unit values of the funds. Unit values are determined by John Hancock Life Insurance Company by dividing the fund's net assets at fair value by its units outstanding at the valuation date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Participant Notes Receivable:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment funds from (to) the participant notes fund. Generally, loans must be paid back within 5 years. The loans are secured by the balance in the participant's account and bear interest similar to those rates offered in commercial lending, determined at the date of the loan, which rate applies throughout the entire term of the loan. Principal and interest are paid ratably through monthly payroll deductions.

Benefit Payments:

Benefits are recorded when paid.

Administrative Expenses:

Various administrative costs are paid by the Company.

Use of Estimates:

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events:

Management evaluated all activity of the Plan through October 15, 2025, the date the financial statements were available to be issued and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C - CERTIFIED INFORMATION

In accordance with section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditor's examination with regard to statements or information prepared and certified by John Hancock Life Insurance Company, the custodian of the Plan. We have been informed by the plan administrator that the custodian holds the Plan's investment assets and executes investment transactions. The custodian has certified as to the completeness and accuracy of the investments and notes receivable from participants it holds, changes in new assets arising from said investment and notes receivable from participants activity as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the schedule of assets held for investment purposes as of December 31, 2024.

NOTE D - INVESTMENTS AT FAIR VALUE

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC 820) establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs). The three levels of the fair value hierarchy under FASB ASC 820 are described in the table below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Pooled Separate Accounts: Pooled separate accounts are valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV. The fair value amounts presented in the table below are intended to permit reconciliation to the amounts presented in the statements of net assets available for benefits.

NOTE E - PLAN TERMINATION

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

NOTE F - INCOME TAXES

In a letter dated June 30, 2020, the Internal Revenue Service has informed the Plan that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In accordance with accounting principles generally accepted in the United States, the Plan Administrator is required to evaluate tax positions taken by the Plan and to recognize a tax liability if the organization has taken an uncertain position, that more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the record keeper as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions. Recordkeeping, custodial and other expenses paid by the Plan were incurred with parties-in-interest as defined in Section 3(14) of ERISA.
