The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - PLAN DESCRIPTION

The following description of the La Rabida Children's Hospital 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all employees of La Rabida Children's Hospital (the Hospital or Plan Sponsor). Employees are immediately eligible for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### **Contributions**

Eligible employees may contribute up to 80% of pre-tax or after-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other various qualified plans. For employees hired after August 1, 2011, and employees hired prior to August 1, 2011 who were not eligible for or participating in the La Rabida Employees' Retirement Plan, with at least one year of service as defined in the plan document, the Hospital makes a matching contribution and a non-elective contribution. Participants must be employed at the end of the year to be eligible for the non-elective contribution. The matching contribution is equal to 100% of the first 1% of salary reduction contribution and 50% of the next 2% of salary reduction contribution. The non-elective contribution is equal to 3% of the eligible participant's compensation, as defined. Contributions are subject to certain Internal Revenue Service limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Hospital matching contributions and Hospital non-elective contributions, as applicable, and plan earnings, and charged with administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account amongst the investment options offered by the Plan and may change their investment options at any time.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Hospital matching and non-elective contributions plus actual earnings thereon is based on years of continuous service. A participant is fully vested after three years of service. Full vesting also occurs at the normal retirement age of 65.

##### **Payment of Benefits**

Upon termination of employment, death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, an annuity or installments. In-service distributions and hardship withdrawals are also permitted in certain circumstances.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1% for notes from account balances with Talcott Resolution Life Insurance Company (TRLIC), formerly named Hartford Life Insurance Company and Empower Retirement, LLC (Empower) or Metropolitan Life Insurance Company (MetLife). Note terms cannot exceed five years. Participants may only have one note outstanding at any time. Principal and interest on notes issued through TRLIC are paid directly by the participants to TRLIC. Principal and interest on notes issued through MetLife are paid through payroll deductions.

#### ***Forfeitures***

Forfeitures of Hospital matching and non-elective contributions are used to offset administrative expenses or reduce non-elective contributions. The balance of forfeitures was \$73,035 and \$50,741 at December 31, 2024 or 2023, respectively. Forfeitures in the amount of \$57,278 and \$26,633 were used to reduce administrative expenses during 2024 and 2023, respectively.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Hospital has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in Hospital matching and non-elective contributions and earnings thereon.

### **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for investments in fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount that Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. The Plan Sponsor's Finance Committee determines the Plan's valuation policies utilizing information provided by the investment custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Risks and Uncertainties***

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### ***Administrative and Investment Management Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

#### **NOTE 3 - CERTIFIED INFORMATION**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, as an agent of Empower Life & Annuity Insurance Company of New York, and MetLife, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value, investments at contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 or 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

#### **NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Shares of registered investment companies:* Valued at the daily closing price as reported on the active market in which the individual securities are traded (Level 1).

*Insurance company separate accounts:* Participation units held in the separate accounts are based on the net asset value (NAV) per share, as a practical expedient, to estimate fair value. The investment objectives of the underlying mutual funds are consistent with the investment objective identified in the names of the funds such as asset allocation, growth funds, bond funds, international funds, large cap funds, mid cap funds, small cap funds and specialty funds. Each separate account provides for daily redemptions by the Plan with no advance notice requirements and there are no unfunded commitments. These separate accounts are closed to participants deferring or transferring money into these accounts although participants are able to transfer their account balances out of these separate account investments at any time.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - INSURANCE COMPANY GENERAL ACCOUNT**

The Plan holds a traditional fully benefit-responsive investment contract with TRLIC (Issuer) totaling \$1,915,619 and \$2,189,079 as of December 31, 2024 and 2023, respectively. TRLIC maintains the contributions in its general account. This contract is an evergreen product as it has no maturity date. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly and may not be less than 3%. TRLIC's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Under the contract, there are no events or conditions that would cause distributions from the contract to be payable at amounts below contract value. The contract does not place any limitations on the Issuer to terminate the contract. If the Issuer were to terminate the contract, distributions would be paid out at contract value. In the event that the Hospital terminated the contract, contract value would be paid out over a period of five years. No events are probably of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

**NOTE 6 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain plan investments are managed by TRLIC, one of the Plan's service providers; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to TRLIC and MetLife, another Plan service provider, qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

The Hospital provides administrative services to the Plan and does not receive any compensation from the Plan for these services. The Hospital also pays certain administrative expenses of the Plan.

**NOTE 7 - INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The Plan has been amended since its adoption. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Code, and therefore is exempt from income taxes.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state, or local tax authorities. The plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statement. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 15, 2025, the date the financial statements were available to be issued and determined that no additional disclosures are necessary.
