We have performed audits of the financial statements of TIME Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF PLAN

The following description of the TIME Savings and Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan’s provisions and eligibility requirements.

General

The Plan is a defined contribution plan covering all eligible employees of TIME USA, LLC (the “Company” or “Plan Sponsor”), a subsidiary of TIME, LLC. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal”) serves as the Plan trustee and custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Participants should refer to the Plan document for a complete description of the Plan’s eligibility requirements.

The Plan was amended effective January 1, 2023 to allow CO2 employees to participate in the Plan. The plan was amended and restated effective January 1, 2024 to remove part-time employees from the excluded list.

Contributions

Full-time and part-time employees that are scheduled to work more than 1,000 hours are eligible to begin contributions to the Plan at any time. Participants may contribute to the Plan on a pre-tax basis or Roth (after-tax) basis. Participants may elect to contribute up to 75% of their annual pre-tax compensation, as defined by the Plan and limited by the Internal Revenue Code (the “Code”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an automatic enrollment provision whereby all newly eligible employees who have not signed up for the Plan or affirmatively elected not to participate are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants who do not make a different deferral election, will have their deferral rate increased by 1% annually up to 10%.

The Company will make a matching contribution equal to 100% of the elective deferral contribution made on behalf of each participant during each plan period up to the first 4% of compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollover contributions, Company matching contributions, and allocations of plan earnings and charged with withdrawals and an allocation of plan losses and expenses. Allocations of Company contributions, investment income and administrative expenses are based on participants’ compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested accounts.

Vesting

Participants are immediately vested in their contributions, the Company’s matching contributions, and investment earnings.

Forfeitures

Forfeitures may occur as a result of Company matching contributions that relate to excess amounts, as defined by the Plan. In accordance with the Plan’s provisions, the Plan could elect to use forfeitures to reduce future employer contributions or pay administrative expenses. There were no forfeitures as of

December 31, 2024 and 2023. No forfeitures were used to reduce employer contributions during the year ended December 31, 2024.

Payment of Benefits

Upon termination of service due to termination of employment, death, disability, retirement, a participant or beneficiary may elect to receive a lump-sum amount equal to the participant's vested interest in his or her account. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59½ or due to hardships, as defined in the Plan document. When a participant terminates employment with the Company, the full value of his or her account balance can be rolled over to an eligible retirement plan. If the vested account balance is \$7,000 or less and the participant does not make an election to roll over the vested balance, it will be automatically paid in a single lump-sum cash payment.

Notes Receivable from Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or one-half of their vested account balance reduced by any outstanding loan balance or \$10,000. The minimum loan amount is \$1,000. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term of up to 15 years. The loans are secured by the balance in the participants' accounts and bear interest at Prime rate + 1%. One loan may be granted during any one-year (12-month) period. A maximum of two loans are allowed to be outstanding at any one time. Loans are repaid ratably through payroll deductions. If the loan is not repaid, it will automatically be treated as a distribution to the participant after 60 days.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a description of fair value measurements.

The change in the value of investments and realized gains or losses are reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis as earned.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those

changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Plan Termination

Although it has not expressed any such intent, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain other fees related to the administration of the Plan are paid from plan assets and fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - TAX STATUS

The Plan has adopted a volume submitter plan sponsored by Principal Life Insurance Co., the recordkeeper of the Plan. The volume submitter plan provider has obtained an advisory letter from the Internal Revenue Service dated June 30, 2020 as to the volume submitter plan's qualified status. The plan has been amended since receiving the letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes the Plan is qualified and the related trust is tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdictions. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There were no changes in methodologies used at December 31, 2024 and 2023:

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund - The fair value of the investment in the collective trust fund is determined by the fund trustee based on the fair value of the underlying securities within the fund, which represents the NAV of the shares held by the Plan at year end. For this fund, NAV is considered to be the readily determinable fair value and is supported by the unit prices of actual purchase and sale transactions.

Plan participants can transact daily with no redemption restrictions. The fund requires for withdrawals directed by the Plan Sponsor, not the participants, to be preceded by a 12-month written notice. There are no unfunded commitments.

Pooled separate accounts - The fair value of units held in pooled separate accounts are valued at the NAV as reported by the investment manager of the accounts daily by the fund with the ability to redeem daily at that price. For these funds, NAV is considered to be the readily determinable fair value and is supported by the unit prices of actual purchase and sale transactions. These NAV generally represent amounts at which units are redeemed on a regular basis. The pooled separate accounts allow one transfer per 30-day period. The transfer restriction applies to all Plan directed transfers out of this investment, including non-scheduled rebalancing activity. Once the number of allowed transfers is met, the Plan is not allowed to transfer back into this investment option until the holding period elapses. Contributions into the investment options are not impacted.
