Notes to Financial Statements

Note 1. Description of Plan

The following description of Trew, LLC 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all full-time employees of Hilmot, LLC; Trew, LLC; and Tech King Operations, LLC (collectively, the Company). In order to participate in the Plan, employees must complete 90 days of service and must also be age 21 or older. Effective January 1, 2020, all employees hired on or after this date are automatically enrolled in the Plan at a 3% deferral rate upon meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participant contributions to the Plan are made by employees within the limitations stipulated in Section 401(k) of the Internal Revenue Code (IRC). Eligible employees may contribute any whole percentage of their compensation to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company's safe harbor matching contribution is equal to 100% of the first 3% of eligible participant compensation plus 50% of the next 2% of eligible participant compensation. The Plan also allows for discretionary profit-sharing contributions. Safe harbor employer contributions are available to those meeting elective deferral eligibility requirements. Profit-sharing employer contributions are available to those who complete 1,000 hours of service during the year and are employed on the last day of the plan year. No profit-sharing contributions were made for the plan year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the employer's contributions and the Plan's earnings. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes receivable from participants: Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess, if any, of their highest outstanding balance of loans in the last 12 months and the outstanding balance of loans from the Plan on the date the loan is made, or 50% of the participant's account balance. All loans must be repaid within five years unless the loan is obtained to acquire or construct the participant's primary residence, in which case, the term of the loan may extend up to 10 years. The loans are collateralized by the balance in the participant's account and bear interest at a fixed rate between 4.25% to 9.50% as of December 31, 2024 and 2023, which is commensurate with local prevailing rates as determined monthly by the Plan Administrator. Payments of principal and interest are credited to the participant's account.

Vesting: Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions plus actual investment earnings thereon. Vesting in the discretionary profit sharing contribution is based on years of continuous service. A participant is 100% vested after three years of credited services with 50% vesting occurring after two years of credited service.

Payment of benefits: Upon termination of service due to death, disability or retirement, a participant is eligible to receive a distribution equal to the vested value of the participant's account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may, under certain conditions, withdraw all or a portion of their account balance without terminating their employment.

Note 1. Description of Plan (Continued)

Forfeitures: Forfeited, non-vested accounts at December 31, 2024 and 2023, totaled \$739 and \$722, respectively. There were no forfeitures used to offset employer contributions or expenses for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of presentation: The accompanying financial statements are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as more explicitly described in the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividends.

Contributions: Participant contributions are recognized when earned. The Company safe harbor contributions are calculated and remitted semi-annually. Any company profit sharing contributions are calculated on an annual basis.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Substantially all of the Plan's administrative expenses are paid by the Plan.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are paid by the participants. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The information related to investments and notes receivable from participants that is included throughout the Plan's financial statements and supplemental Schedule H, line 4a—schedule of assets (held at end of year) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to these plan assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and the supplemental schedule related to the Plan's assets.

The trustee of the Plan, Empower Trust Company, LLC certified to the completeness and accuracy of \$2,006,207 of net appreciation in fair value of investments, \$1,007,100 of interest and dividends, and \$17,695 of interest income from notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets measured at fair value on a recurring basis: The following table summarizes assets measured at fair value on a recurring basis as of December 31, 2024 and 2023, segregated by the level of the valuation inputs within the fair value hierarchy utilized to measure fair value:

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to the net assets available for benefits.

Note 5. Investment Contract with Insurance Company

The Plan has a traditional investment contract with Great-West. This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest invested in the general account assets of Great-West.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on Great-West's ability to meet its financial obligations. Great-West's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5. Investment Contract with Insurance Company (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs and the liberalization of plan withdrawal or transfer rules. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value, is probable. Either the Plan or the insurance company may terminate the contract at any time with 60 days advance written notice. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants will become fully vested and the net assets will be distributed to the participants and beneficiaries in proportion to their account balances.

Note 7. Income Tax Status

The Plan has adopted a pre-approved profit-sharing plan. The pre-approved profit-sharing plan provider has received an advisory letter from the Internal Revenue Service (IRS) as to the pre-approved profit-sharing plan's qualified status. The pre-approved profit-sharing plan advisory letter has been relied upon by the Plan. The Plan has been amended since the pre-approved profit-sharing plan provider received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

Note 8. Related-Party Transactions

Certain plan investments are insurance company general accounts managed by Empower. Empower is the trustee of the Plan; therefore, transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower for plan administrative functions amounted to \$126,293 for the year ended December 31, 2024.

Note 9. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
