INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the AU Health Systems, Inc. 401(a) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AU Health Systems, Inc. We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: DESCRIPTION OF THE PLAN

The following description of the AU Health Systems, Inc. (AUHS) 401(a) Retirement Savings Plan (the "Plan") provides only general information. Refer to Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined contribution plan covering all full-time employees of AUHS (the "Company", "Sponsor", "Employer", or "Plan Administrator"), except for temporary employees or staff leased from Augusta University. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Administration of Plan Assets

Plan assets are held and managed by Variable Annuity Life Insurance Company ("VALIC" or the "Custodian"), the custodian and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Plan Sponsor, and provides certain recordkeeping services. Corebridge owns VALIC, and, throughout these Notes, VALIC may be referred to as VALIC or Corebridge. The Custodian also performs certain plan administration.

Effective January 1, 2019, and corresponding to a reorganization of AU Health System, Inc., this Plan was frozen for new participants and Employer contributions.

In 2022, the Plan Sponsor signed a new adoption agreement changing the name from AU Medical Center, Inc. 401(a) Retirement Savings Plan to AU Health Systems, Inc. 401(a) Retirement Savings Plan.

On August 29, 2023, the Plan Sponsor was effectively acquired by Wellstar Health System, Inc., a Georgia nonprofit corporation.

As of January 3, 2025, the Plan Sponsor transferred the total account balance of each participant's account from VALIC to TransAmerica. The assets were moved on December 31, 2024.

Eligibility

All covered employees prior to January 1, 2019 were immediately eligible to participate in the Plan upon their participation in the related 403(b) Plan sponsored by the Company.

Employer Contributions

During the year ended December 31, 2024, the Company made no Employer contributions due to the Plan being frozen in 2019. Participants direct the investment of their account into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with rollovers, the Company's contributions and earnings on investments in his or her account, and is charged with its allocated portion of the administrative expenses and certain transactions fees. Allocations are based on participant earnings, account balances, or specific participant transaction, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants can borrow from their account a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000, or 50% of their account balance. The loans are secured by the balance of the participant's account. The loan interest rate is determined by the Employer in a nondiscriminatory manner. Principal and interest is paid ratably through payroll deductions or direct payment.

Benefit Payments

The Plan provides for withdrawals upon retirement, termination, disability or death. Normal retirement is on or after age 65. Withdrawals during employment of the participant's vested interest in Employer contributions can be made if the employee has attained age 59½. At termination of employment for reasons other than retirement, death or disability, the accrued benefit would be all of the participant's vested interest in Employer contributions and all related earnings and losses. Payments can be made in the form of a lump sum or installment payments.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's investments generally are reported at fair value, but might also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements and contract value. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investments advisers and Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they were incurred.

Funds In-Transit to TransAmerica

Effective December 31, 2024, Plan management engaged TransAmerica to serve as the Plan's Custodian, replacing VALIC. The funds were in-transit as of December 31, 2024 and were received by TransAmerica on January 3, 2025. Refer to Note 10.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) of fair value of investments.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 15, 2025. See Note 10 for relevant disclosures. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements is obtained by management and agreed to or derived from information certified as complete and accurate by VALIC, the qualified institution:

- a) Total investments, at fair value and contract value, included in the statement of net assets available for benefits at December 31, 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2023.
- c) Investment income and interest income from notes receivable, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All amounts included in Note 5, *Investments Reported at Contract Value*.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: INVESTMENTS REPORTED AT CONTRACT VALUE

In a prior year, the Plan entered into a guaranteed investment contract with VALIC. The options under the VALIC Fixed-Interest Options included a fixed account option. The fixed options were guaranteed by the claims-paying ability of VALIC. The fixed account option totaled \$0 at December 31, 2024 and \$31,498,296 at December 31, 2023.

Prior to the freezing of the Plan, VALIC maintained the contributions to the fixed account option in a general account, which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. This contract meets the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed rate for the fixed option varies by participant and depends on the date the participant established his or her account. Participant accounts set up between January 2023 and May 2023 have a minimum interest rate of 1.9%, June 2023 have a minimum interest rate of 2.05%, between July 2023 and May 2024 have a minimum interest rate of 2.20%, and between May 2024 and December 2024 have a minimum interest rate of 2.35%. These minimums apply to all fixed options under the contract.

Note 6: TAX STATUS

The Plan is designed to qualify under Section 401(a) of the Internal Revenue Code (IRC), as amended. The terms of the Plan were prepared to conform to the sample language provided by the Internal Revenue Service (IRS). The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 401(a).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by VALIC. VALIC is the Custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 8: PLAN TERMINATION

The Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.
