Summary of Significant Accounting Policies Years Ended December 31, 2024 and 2023

Basis of Presentation

The Plan presents its financial statements on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's investment policies utilizing information provided by the custodian and insurance company. See Note 6 for discussion of fair value measurement.

Guaranteed investment contracts held by a defined contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for Plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for plan benefits present the contract value of the guaranteed investment contract. The statements of changes in net assets available for plan benefits include the changes in contract value of the guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains on investments bought and sold as well as investments held during the year.

Receivables and Allowance for Credit Losses

Receivables are stated at the amount management expects to collect from balances outstanding at year-end. The allowance estimate, if any, is derived from a review of the Plan's historical losses in relation to the Plan's historical receivable balances as well as management's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by management. Management has concluded that realized losses on balances outstanding at year-end will be immaterial. Accordingly, no allowance for credit losses has been recorded. There were no write-offs of receivables or recoveries of previous write-offs in 2024 or 2023.

Payment of Benefits

Benefits are deducted when paid.

Expenses

Certain administrative expenses and personnel costs required to maintain the Plan are paid by Geiger Ready-Mix Company, Inc. and Geiger Trucking Company, Inc. (collectively, the "Company") and are excluded from these financial statements. Investment related expenses are included in net appreciation in investments.

1. Description of Plan

The following description of the Plan provides only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all full-time employees of the Company who have at least three consecutive months of service and are at least age 21. The Plan is subject to the provisions of ERISA. The trustee committee is responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's trustee committee.

Each eligible employee may elect to become a participant in the Plan on the January 1, April 1, July 1, or October 1, coincident with or immediately following the date the employee becomes eligible to enter the Plan. A participant specifies the amount of eligible compensation to be contributed to the Plan (participant salary deferral contributions). Effective April 1, 2024, employees hired after April 1, 2024 are automatically enrolled in the Plan at a 3% employee salary deferral rate, unless they opt not to participate or to defer a different percentage of their salary. Participants are also eligible for discretionary employer matching contributions. The Company can also make a discretionary profit-sharing contribution each year. A participant must be employed on the last day of the Plan year and complete at least 1,000 hours of service during the Plan year to share in the profit-sharing contribution. Participants may also roll over amounts representing distributions from other qualified plans (participant rollover contributions). Contributions are subject to certain limitations.

A participant may direct contributions to any of the available investment options. Each participant's directed account is credited (charged) with an allocation of the directed investment's earnings (losses) and credited with an allocation of the following contributions:

- Participant's salary deferral contributions.
- Participant's rollover contributions.
- Employer discretionary matching contributions.
- Employer discretionary profit-sharing contribution. (The allocation of the employer's discretionary profit-sharing contribution to individual participants is based upon the individual's share of the total eligible compensation received during the Plan year to all participants' total eligible compensation.)

Upon becoming a participant in the Plan, an individual is fully vested in the portions of his or her account attributable to participant contributions. Upon death or disability, a participant also becomes fully vested in his or her accounts attributable to employer contributions; otherwise, the participant becomes vested in the employer contributions in accordance with the following schedule:

1. **Description of Plan** (continued)

Upon termination of service, a participant whose vested balance exceeds \$5,000 may elect to receive either a lump sum amount equal to the vested amount or installment payments. Participants whose vested balance does not exceed \$1,000 are paid a lump sum amount. Vested participant balances greater than \$1,000 but less than \$5,000 will be distributed to participants in a direct rollover to an individual retirement account, unless the participant elects to have the distribution paid directly to a specified eligible retirement plan or receive the distribution directly. Under terms of the Plan, normal retirement is the latter of the date the participant attains age 65 or the fifth anniversary of the first day of the Plan year in which the participant commenced participation in the Plan.

Forfeited nonvested amounts are used to reduce future employer matching contributions or employer profit-sharing contributions. For the years ended December 31, 2024 and 2023, forfeitures of \$49,394 and \$79,822, respectively, were used to reduce employer contributions. Unallocated forfeiture account balances were \$63,211 and \$7,844 at December 31, 2024 and 2023, respectively.

2. **Plan Termination**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions.

3. **Income Taxes**

The Plan has adopted a pre-approved plan, which has received an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) indicating that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and tax-exempt as of the financial statement date and no provision for income taxes has been recorded in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

4. **Information Certified by the Plan's Custodian**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023 and net appreciation in fair value of investments and interest for the years ended December 31, 2024 and 2023, was obtained by Plan management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB (NTC), the custodian of the Plan.

The Plan has a fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company (NLIC), a related party of NTC. NLIC maintains the contributions in a general deposit account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

As described in the summary of significant accounting policies, because the guaranteed investment contract (Nationwide Fixed Select Contract) is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for Plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for Plan benefits at contract value at December 31, 2024 and 2023. Contract value, as reported to the Plan by NLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The guaranteed investment contract guarantees principal and a minimum guaranteed interest rate for the life of the participant's account and includes two declared interest rates - a current rate, determined quarterly, and a guaranteed minimum floor rate of 0.50%. The current rate, the guaranteed minimum floor rate, and the minimum guaranteed interest rate are expressed as annual effective yields. After consideration of interest compounding, the interest credited daily yields the current credited rate. Interest was credited and compounded at a rate of 2.11% and 2.45% at December 31, 2024 and 2023, respectively.

The contract does not have a maturity date and continues until all assets have been distributed or no further payments are due. The contract holder can receive a lump sum distribution with a market value adjustment or elect to be paid at book value over a period of years.

6. Fair Value Measurement of Investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used to determine the fair value of investments. There have been no changes in the methodology used at December 31, 2024 and 2023:

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding valuation method described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended December 31, 2024 and 2023, there were no transfers.

7. **Risks and Uncertainties**

The Plan provides participants the option to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuation and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements and the supplemental schedule of assets (held at end of year).

8. **Party-in-Interest Transactions**

Certain Plan investments are managed by NTC, the custodian of the Plan. These investments and the related transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. Tax Favored Benefits Inc. is the third-party administrator (TPA) for the Plan. Fees paid to the TPA and the custodian, as well as fees paid to investment advisors are included in administrative expenses and are party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.

9. **Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
