## Report of Independent Auditor

To the Board of Trustees  
Catawba College Retirement Plan  
Salisbury, North Carolina

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Catawba College Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1—Description of the Plan**

The following brief description of the Catawba College Retirement Plan (the “Plan”) provides only general information about the Plan’s provisions. Catawba College (the “College” or “Employer”) is the Plan sponsor. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan’s provisions, copies of which may be obtained from the Plan sponsor.

*General* – The Plan is a defined contribution plan established by the College on September 1, 1944, and was restated effective January 1, 2019, and amended on January 1, 2022. All employees are eligible for the Plan with the exception of students enrolled and regularly attending classes offered by the College. Employees are eligible to participate in the Plan immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Administration* – The Plan is administered by the College, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The College outsources the recordkeeping function of the Plan to Teachers Insurance and Annuity Association (“TIAA”) and College Retirement and Equities Fund (“CREF”), the “Qualified Institutions” of the Plan.

*Contributions* – For the year ended December 31, 2024, participants may contribute up to \$23,000 of pre-tax annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. Unless the employee is part of an excluded class of employees noted above, the employee is eligible to make voluntary contributions to the Plan as soon as administratively feasible. Participants may also contribute amounts representing distributions from other qualified retirement plans, 403(b) tax sheltered annuity plans, government 457(b) plans, and traditional individual retirement accounts.

Nonresident aliens, employees covered by a collective bargaining agreement, and students enrolled and regularly attending classes offered by the College are not eligible for College contributions. The College uses a service-graded formula for the Employer match. During the year ended December 31, 2024, the College matched employee contributions as follows:

*Catch-Up Contributions* – For the year ended December 31, 2024, if a participant is eligible to make deferrals and turns 50 before the end of the calendar year, the participant may defer an additional \$7,500 into the Plan as a pre-tax contribution subject to certain IRC limitations. Catch-up contributions are eligible for matching contributions made by the College.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions, related Employer-matching contributions, and an allocation of Plan earnings and charged with benefits paid to participants and an allocation of Plan losses, and administrative expenses, if not paid by the College. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting Requirements* – Participants are immediately fully vested in their voluntary contributions, including catch-up contributions, rollover contributions from other plans, and earnings thereon. A participant will become 100% vested in the portion of their individual account derived from College matching contributions after three years of vesting service.

### Note 1—Description of the Plan (continued)

*Investment Options* – Upon enrollment in the Plan, a participant must direct 100% of their allocation of contributions with TIAA and CREF. Within TIAA and CREF, participants may select between several investment options. Participants may transfer balances periodically based on the applicable funds as defined in the custodial service agreement.

*Benefits Paid to Participants* – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount, equal to the value of the participant's vested interest in his or her account, partial payments, installment payments, or an annuity. For termination of service for other reasons, distribution of the value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request. The Plan allows mandatory disbursements following a participant's severance from employment for accounts up to \$5,000. A participant may request a withdrawal from their elective deferral balance based on financial hardship. Certain income tax penalties may apply to withdrawals or distributions prior to the age of 59½.

*Contributions Receivable* – The amount of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of the year is reflected as a participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the College are reflected as Employer contributions receivable in the Plan's financial statement.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or greater for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at Wall Street Journal Prime Rate plus 1%. The effective interest rate for participant loans ranges from 6.50% to 9.50% as of December 31, 2024. Principal and interest are paid through an automatic draft of the participant's checking account by TIAA.

*Plan Loans* – Participants may borrow directly from the funds held by the Qualified Institutions a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45% of their vested account balance. According to the DC Plan document, participants could not borrow from the portion of their fund accounts attributable to school contributions. Loans are secured by the balance in the participant's account and bear interest rates ranging from 5.33% to 5.89 % as of December 31, 2024, with various maturities through January 2025. Principal and interest are paid through an automatic draft of the participant's checking account by the Qualified Institutions. Since Plan loans were borrowed directly from funds held by the Qualified Institutions, and not from participant accounts, they are not considered an asset of the Plan and are not included on the statements of net assets available for benefits. Plan loans outstanding amounted to \$3,377 and \$11,504 as of December 31, 2024 and 2023, respectively.

*Forfeitures* – Forfeited nonvested accounts are retained in the Plan and may be applied to the payment of Employer contributions to the Plan. As of December 31, 2024 and 2023, there were \$140,359 and \$49,576, respectively, of unallocated forfeiture balances.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Note 2—Summary of significant accounting policies (continued)

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value, except for the fully benefit-responsive investments, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in guaranteed investment accounts. Certain of the guaranteed investment accounts are deemed to be fully benefit-responsive contracts, while others are considered non-fully benefit-responsive. In accordance with U.S. GAAP, the fully benefit-responsive contracts are recorded at contract value, while the non-fully benefit-responsive contracts are recorded at fair value. The contract value represents contributions plus earnings, less participant withdrawals, and administrative expenses. Fair value is determined by the issuer of the contracts using the income approach and various inputs, such as board-determined interest rates and discounted cash flows.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation in fair value of investments and net appreciation in contract value of investments include the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Fair Value Measurements* – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP describes three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Money Market Funds* – These investments are a public investment vehicle valued using NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high-quality, liquid debt, and monetary assets. The Qualified Institutions establish the market and quote the price, on a daily basis, that is available to market participants, which is a market approach to valuation. The money market funds are classified within Level 2 of the valuation hierarchy.

### Note 2—Summary of significant accounting policies (continued)

*Pooled Separate Account (Real Estate Fund)* – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The fair value of the pooled separate account is stated at NAV as a practical expedient.

*Guaranteed Investment Contracts (Non-Fully Benefit-Responsive Contracts)* – These investments are guaranteed fixed income annuities backed by TIAA's claims paying ability whereby the annuities guarantee principal and a minimum interest rate, plus opportunity for additional amounts in excess of the guaranteed rate. The annuity contracts are not traded, and significant other observable inputs are not available. The contracts are reported at fair value and are classified within Level 3 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Risks and Uncertainties* – Investment securities in general, are subject to various risks, such as interest rate, credit, and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Benefits Paid to Participants* – Benefits paid to participants are recorded when paid.

*Administrative Expenses* – Except as discussed in Note 6, Plan administrative expenses are generally paid by the College.

### Note 3—Information certified by the Qualified Institutions (unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Qualified Institutions, have certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule:

Investments, at fair value, guaranteed investment contract, at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

Net appreciation in fair value of investments, net appreciation in contract value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 5—Investment contract with insurance company**

The Plan invests in guaranteed fixed annuity contracts with TIAA. Fully benefit-responsive annuity contracts include the Supplemental Retirement Annuity account (“SRA”) and the Group Supplemental Retirement Annuity account (“GSRA”). Non-fully benefit-responsive annuity contracts include the Retirement Annuity account (“RA”) and the Retirement Choice Annuity account (“RC”). TIAA maintains the contributions in the Teachers Insurance and Annuity Association General Account. TIAA groups the premium dollars it receives over defined time periods into vintages, typically composed of one or more contiguous calendar months, for the purpose of determining the crediting rate to participant’s accounts. The crediting rate for each vintage is determined, in part, by the net investment earnings rate of the Qualified Institutions’ assets supporting that vintage, minus a charge for administrative expenses and an amount set aside for contingency reserves. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at their stated value.

As described in Note 2, because a portion of the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. The fully benefit-responsive investment contracts are included in the financial statements at contract value as reported to the Plan by TIAA.

### **Note 5—Investment contract with insurance company (continued)**

The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate, generally 3.00%, that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3.00% for the SRA and RA accounts. TIAA's Board of Trustees may declare additional amounts on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12-month declaration year that begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years. The interest rate credited to participants for the fully benefit-responsive portion of the investment contracts for the year ended December 31, 2024 was 4.50% to 4.75% for the SRA and GSRA accounts. The interest rate credited to participants for the non-fully benefit-responsive portion of the investment contracts for the year ended December 31, 2024 was 5.25% to 5.50% for the RA account and 5.50% to 5.75% for the RC account.

Certain events limit the Plan's ability to transact at contract value with the Qualified Institutions. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **Note 6—Party-in-interest transactions**

Fees paid by the Plan for the investment management services of the Qualified Institutions, as well as notes receivable from participants and Plan loan fees amounted to \$204,263, which are included in net appreciation in fair value and contract value of investments within the statement of changes in net assets available for benefits. Additionally, third-party administrative expenses of \$71,624, of which \$13,866 was paid through servicing credit to the Qualified Institutions during the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

### **Note 7—Tax status**

The Internal Revenue Service ("IRS") has determined and informed the Plan prototype sponsor by a letter dated August 7, 2017, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC.") The College has chosen to rely on the determination letter issued to the Plan prototype sponsor. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Plan termination**

The College believes the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event such discontinuance results in termination of the Plan, participants become 100% vested in their account balances and the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. Distribution of participant account balances will occur as soon as administratively feasible upon termination of the Plan.

**Note 9—Subsequent events**

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through October 13, 2025, the date these financial statements were available to be issued.
