INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CarStar Collision Center 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain other internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets Held at End of Year and Schedule of Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) Summary of Significant Accounting Policies

Nature of Business of Plan Sponsor

CarStar Rapid City, Inc. (the Company and Plan Sponsor) owns and operates a full-service auto body repair shop. The Company provides services in western South Dakota.

Method of Accounting

The financial statements of CarStar Collision Center 401(k) Plan (the Plan) are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value on a recurring basis as determined by Fidelity Management Trust Company and Capital Bank and Trust Company (the Trustees) (Notes 4 and 6). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Net Change in Fair Market Value of Investments

The net appreciation in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year, and the unrealized gains and losses in securities held at the end of the year.

Risks and Uncertainties

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Contributions

Contributions from Plan participants and the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

(1) Summary of Significant Accounting Policies

Payment of Benefits

Benefits are recorded when paid.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent balance is recorded as a benefit payment based on the terms of the plan document.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued.

(2) Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which includes employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company, who have completed three months of service and have attained the age of eighteen are eligible to participate in the Plan. Upon meeting the Plan's eligibility requirements, employees may enter the Plan on the first day of the month. Employees of the participating companies who have completed eleven months of service are eligible for matching contributions.

Contributions

Participating employees contribute an amount each pay period as provided for in their participation agreement. Employees may contribute from 1 percent to 100 percent of their compensation, not to exceed certain limits established by the Internal Revenue Service. Matching contributions are 100 percent of the first 3 percent of compensation deferred to a maximum of \$800 annually. The Plan can also provide a discretionary contribution which is determined annually. No discretionary contributions were made during the years ended December 31, 2024 and 2023.

The Plan requires automatic enrollment for employees in which the Plan Sponsor automatically withholds 3 percent of the employee's compensation upon becoming eligible to participate unless otherwise elected by the participant. Contributions are automatically invested in the appropriate target date fund unless the participant elects other investment options. The Plan includes a provision to increase the participant's automatic enrollment annually by 1 percentage up to the lesser of a total increase of 3 percent or a maximum contribution of 10 percent of compensation.

(2) Description of the Plan

Contributions

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and are included in the participant's gross income. Future distributions of Roth elected contributions and earnings thereon will not be taxed if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participants' Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contribution, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options

Upon enrollment to the Plan, a participant may direct employee and employer contributions to any of the funds offered by the Plan. Participants may change their investment options daily.

Participant Notes Receivable

Loans may be made from the participants' accounts upon an electronic request submitted to the trustee. Participants may borrow up to a maximum amount equal to the lesser of 50 percent of their vested benefit or \$50,000, with a minimum of \$1,000. Loans bear interest commensurate with prevailing rates as determined by the Plan Administrator. Loans are repaid in equal amounts over the repayment term. Repayment terms are five years or less except for loans to acquire a principal residence, which are paid over a reasonable time period not to exceed ten years, as determined by the Trustees.

Payment of Benefits

Benefit payments are made as soon as administratively feasible following the date on which a distribution request is made or is otherwise payable. Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account.

Participants with benefits in excess of \$1,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits not greater than \$1,000 are paid in one lump-sum upon termination of employment, death, disability, or retirement. A participant with an account balance of greater than \$1,000, but less than \$5,000, may receive a rollover distribution into an individual retirement account set up by the Plan Administrator.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Company's contributions and related earnings becomes 20 percent vested after two years of credited service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after six years of service.

(2) Description of the Plan

Forfeitures

Forfeitures are used to reduce the administrative expenses of the Plan or employer contributions. Non-vested account balances are forfeited, unless participants return to employment and contribute the distribution received at termination within a specified time. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$2,468 and \$19,300, respectively. During the year ended December 31, 2024, the Plan paid administrative fees totaling \$220 and reduced employer contributions by \$-0- from forfeited non-vested accounts.

Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

(3) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

(4) Investments -- Information Certified by Trustees

Fidelity Management Trust Company and Capital Bank and Trust Company (the Trustees) hold the Plan's investments, execute investment transactions, and perform all related accounting functions. The Trustees determined the fair value of investments at December 31, 2024 (Capital Bank and Trust Company) and 2023 (Fidelity Management Trust Company).

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator has received certification from the Trustees as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended December 31, 2024 (Capital Bank and Trust Company) and 2023 (Fidelity Management Trust Company). The Trustees have certified information contained in the following:

Statements of Net Assets Available for Benefits (except for contribution receivable)
Statement of Changes in Net Assets Available for Benefits (except for contributions, benefits paid to participants, administrative expenses and transfer to Granite Automotive Group, LLC 401(k) Plan)
Supplemental Schedule of Assets Held at End of Year

The Plan primarily invests in mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed significantly since December 31, 2024.

(5) Income Tax Status

The Plan has adopted a non-standard form of prototype plan sponsored by Siegel Actuarial Consulting, Inc. (the Third-Party Administrator and TPA). The prototype plan has received an opinion letter from the Internal Revenue Services (IRS) as to the prototype plan's qualified status. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. Generally Accepted Accounting Principles (GAAP) requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the Department of Labor or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing, jurisdictions, however, there are currently no audits for any tax periods in progress.

(6) Recurring Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: inputs include
 1. quoted prices for similar assets or liabilities in active markets;
 2. quoted prices for identical or similar assets or liabilities in inactive markets;
 3. inputs other than quoted prices that are observable for the asset or liability;
 4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level Three: inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fidelity Brokerage Link Self-Directed Brokerage Fund: The underlying investments, which consist primarily of interest-bearing cash accounts and individual corporate common stocks, are valued at the closing price reported on the open market.

Money Market Mutual Funds: Valued at the quoted Net Asset Value of shares of \$1, held by the Plan at year-end.

(6) Recurring Fair Value Measurements

(7) Participant Withdrawals

As of December 31, 2024 and 2023, Plan assets include terminated participants with account balances totaling \$364,563 and \$862,216, respectively.

(8) Related Party Transactions

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. The Plan allows participants to take out loans against their account balances. Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(9) Delinquent Participant Contributions

In accordance with ERISA and Department of Labor rules, participant contributions are required to be remitted to the Plan as soon as administratively feasible. During the year ended December 31, 2024, certain participant contributions were not remitted to the Plan within the required timeframe. The total amount of delinquent contributions was \$19,149. These contributions have not been corrected as of the date of the report.

(10) Transfer to Granite Automotive Group, LLC 401(k) Plan

Effective May 2023, divisions of Granite Buick GMC, Inc., and Granite Imports, Inc. were sold to Granite Automotive Group, LLC. Some of the control and administration of the Plan was transferred to Granite Automotive Group, LLC, with no changes to the Plan’s provisions besides an amendment to permit Granite Automotive Group, LLC employees, to participate in the plan.

Effective October 1, 2023, the Plan changed its name to CarStar Collision Center 401(k) Plan. The Plan Sponsor’s name was changed to CarStar Rapid City, Inc.

Effective January 4, 2024, all participant balances of Granite Automotive Group, LLC employees were transferred to Granite Automotive Group, LLC 401(k) plan totaling \$5,073,834. The employees of CarStar Rapid City, Inc. remain in the Plan.
