Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Other Matters

The supplemental schedule is presented for purposes of additional analysis and is not a required part of the financial statements but is required by the Department of Labor's Rules

and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or, derived from the certified investment information, has been subjected to the auditing procedures applied in our audit and certain additional procedures including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS **AS OF DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN:

The following description of Banner Quality Management Inc. 401(K) Plan (Plan) is provided for general purposes only. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Banner Quality Management Inc. (Company) as defined in the Plan document. The Plan is subject to the requirements of the Employee Retirement Income Security Act (ERISA) of 1974. Administrative expenses, including auditing fees, are generally paid out of the Plan.

Effective January 1, 2023, the Plan was adopted by Banner Quality Management Inc. Plan investments are in the custody of Reliance Trust Company (Trustee).

Contributions

Each year, participants may defer a percentage of their annual compensation as defined in the Plan document and within limits set by the IRS (generally up to \$23,000 for 2024).

Also, participants may contribute amounts representing distributions from other qualified plans and the Company shall make matching contributions as further described in the Plan document.

Total contributions, both participant and employer, are subject to certain limits as described in the Plan document and Internal Revenue Code (IRC) section 415. Furthermore, contributions of certain highly compensated participants may also be limited based on the nondiscrimination tests described in IRC sections 401(k) and 401(m).

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited balances will be used to reduce Company contributions. As of December 31, 2024, remaining unused forfeitures totaled \$10.

Participant Accounts and Vesting

Each participant's account is credited with amounts withheld from compensation pursuant to salary deferral elections together with 1) allocations of Company contributions, and 2) Plan investment earnings.

Participants are immediately vested in all contributions arising from their respective salary deferral elections together with earnings thereon. Vesting in Company contributions plus earnings thereon is based on years of continuous service as described in the Plan document. Participants are 100 percent vested after five years.

Payment of Benefits

In general, distributions are not permitted before age 59 ½ or termination of employment, as described in the Plan document. Also, participants may defer distribution of their benefits beyond their normal retirement age.

The form of payment is lump sum, substantially equivalent or partial withdrawal.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared under accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

Investment Contracts / Valuation

The transactions between Trustee and the Plan qualify as exempt party-in-interest transactions. As agreed to by the Trustee and the Company, each participant shall be permitted to direct the investment of his/her individual account balance among those investment options listed in the Service Agreement (i.e., the Plan is intended to qualify as a participant-directed plan under section 404(c) of ERISA).

The Plan's investments are generally stated at fair value. Mutual funds are valued at the quoted net asset value of shares held by the Plan as of yearend (i.e., these funds are deemed to be actively traded); collective investment trust funds are valued based on the net asset values (NAV) of the underlying investments. For the stable value option, the investment is reported at contract value without consideration of a withdrawal (surrender) charge.

The use of NAV of the underlying assets for the collective investment trust funds is an allowable practical expedient for measuring fair value as long as it is not probable that the fund will sell the investment for an amount different than the reported NAV (i.e., such investments must be redeemable at the measurement date for the reported NAV). The Trustee reports that these investments can be redeemed on a daily basis, without being subject to any withdrawal limitation (i.e., such are redeemable as of the measurement date).

ASC 820, *Fair Value Measurement*, establishes a framework for measuring fair value and provides for a three-level hierarchy that distinguishes between market participant assumptions developed based on market data obtained from sources independent of the reporting entity (observable inputs) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs – Level 3). Furthermore, observable inputs have been further separated between unadjusted quoted prices (Level 1) versus inputs that are other than quoted prices (Level 2).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest based on annual interest rates ranging from 5.25 – 10.50 percent. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Under ASC 962, *Plan Accounting – Defined Contribution Plans*, participant loans are considered notes receivable and not part of investments. However, Form 5500 continues to consider these loans as part of investments.

Payment of Benefits

Benefits are generally reported when paid for purposes of preparing the financial statements. Amounts allocated to accounts for terminated participants (distributions which were not yet payable) totaled \$468,735 at December 31, 2024.

Subsequent Events

The Plan administrator has evaluated subsequent events for potential disclosure or recognition through October 13, 2025, the date these financial statements were available to be issued.

All withdrawal requests received in good order on a valuation date are processed at the unit price calculated at the end of that day.*

For 2024, the collective trust investments are principally represented by State Street S&P 500 Index IX. These funds are not mutual funds and, as such, are not registered with the U.S. Securities and Exchange Commission. These funds generally invest in mutual funds and other collective trusts.

Investment securities are exposed to various risks such as interest rate, market and credit risks (certain funds' investments in emerging markets can also be subject to social and political uncertainties resulting in extreme volatility). As such, it is at least reasonably possible that changes in values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

Fully Benefit-Responsive Investment

Consistent with ASC 962, the Plan reports fully benefit-responsive investments, such as the Invesco Stable Asset option (the Plan's only fully benefit-responsive investment), at contract value. Participants ordinarily withdraw or transfer their investment at contract value – which is considered a relevant measurement attribute.

Contract value represents the aggregation of contributions, plus crediting interest, less withdrawals. The crediting interest rate will never be less than the guaranteed minimum (which is no less than zero percent). Key factors that influence future crediting rates could include the level of market rates, the amount and timing of participant contributions, transfers and withdrawals; and the duration of the underlying investments.

Certain events may limit the ability of the Plan to transact at contract value including the Plan's failure to qualify under IRC section 401(a), the sale or spin-off of a subsidiary or division of the

sponsor, or any early group layoff or facility closing. The Plan administrator does not believe such events are probable as of December 31, 2024 or as of the date these financial statements were available to be issued.

5. TAX STATUS:

The Trust's most recent IRS opinion letter, dated October 6, 2020, states that the form of the Non-standardized Profit Sharing Plan with CODA is acceptable under section 401 of the IRC. The opinion letter also states that an employer adopting this plan may rely on this letter with respect to the qualifications of its plan under section 401(a) of the IRC. The Plan administrator believes that the Plan, both for the period ended December 31, 2024 and as currently designed and operated, is in compliance with all applicable IRC requirements.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain tax position as defined by ASC 740, *Income*

Taxes. While the Plan is subject to routine audits by taxing authorities, management is not aware of any audits currently in process.
