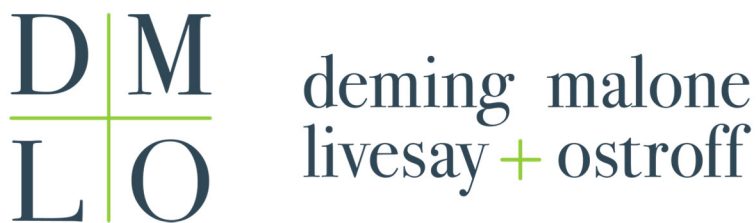

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed audits of the accompanying financial statements of EBCI Holdings LLC 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of EBCI Holdings LLC 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of EBCI Holdings LLC 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the EBCI Holdings LLC 401(k) Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of EBCI Holdings, LLC (Employer). The Plan was established on January 1, 2022 as a spin-off from the Caesars Entertainment, Inc. 401(k) Plan when Southern Indiana Casino (a wholly-owned subsidiary) was divested from Caesars Entertainment, Inc. and sold to EBCI Holdings, LLC. Full-time employees are eligible to participate in the Plan following 90 days of employment for both employee deferrals and employer matching contributions. Part-time employees are eligible to make employee deferrals following 90 days of employment, and are eligible to receive employer match contributions following one year of employment. Entry dates are immediate upon satisfaction of the service requirement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants may also elect to defer a portion of their after-tax compensation as a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all full-time employees hired after January 1, 2022 are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation unless changed by the participant.

The Employer makes a matching contribution for all participants equal to 50% of the first 6% of compensation deferred. Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant’s account is credited with the participant’s contributions and Employer matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of investment expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES TO FINANCIAL STATEMENTS

Vesting:

Participants are immediately vested in their employee contributions plus actual earnings thereon. Employees are vested in the Employer's matching contributions based on years of service according to the following schedule:

Payment of benefits:

On termination of service due to death, disability, retirement, termination of employment, or attaining normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or substantially equal installments over a specified period. The Plan specifically restricts the timing and method of benefit payment based upon the participant's age, length of service, account value and reason for termination.

Participants may also be permitted to receive a distribution from their account prior to termination of employment provided they experience certain financial hardships. Hardship withdrawals are allowed from all sources.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest as determined quarterly by the plan administrator. The loan interest rate is set at 1% above the prime rate. Interest rates currently range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions or ACH deduction from the participants' bank account based up the loan repayment schedule established at inception.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts were \$61,804 and \$82,569 respectively. Forfeited accounts are used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$138,278 and \$31,062 were utilized to reduce employer contributions, respectively.

NOTES TO FINANCIAL STATEMENTS

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of EBCI Holdings LLC 401(k) Retirement Savings Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTES TO FINANCIAL STATEMENTS

Contributions:

Contributions from Plan participants and the matching contribution from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Substantially all administrative expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was derived from information certified as complete and accurate by Lincoln National Life Insurance Company, a qualified institution.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All assets have been valued using a market approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds – valued at the daily closing price as reported by the fund.

Pooled separate accounts – valued at the net asset value of units held by the Plan at year-end. The net asset value is used as a practical expedient to estimate fair value.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments Measured Using Net Asset Value per Share Practical Expedient:

The pooled separate accounts have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' net asset value (NAV). The NAV is updated daily.

Note 5. Guaranteed Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company (Lincoln) with a contract value of \$3,942,693 and \$4,725,234 at December 31, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a monthly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Plan Administrator does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

NOTES TO FINANCIAL STATEMENTS

Lincoln may terminate the contract for any of the following reasons: if any charges billed to the contract owner have not been paid within 30 days, the plan ceases to meet the requirements of the Internal Revenue Code for purchasers of this contract, failure to maintain an account balance of at least \$15,000 at the end of the third contract year, if there is no deposit activity for a 24-consecutive-month period and the contract balance is less than \$50,000, failure to provide requested documentation, misrepresentation of material information, Lincoln discontinues offering the contract, or the plan terminates the recordkeeping agreement with Lincoln.

Note 6. Related Party and Party-in-Interest Transactions

Lincoln Financial Trust Group Company (Lincoln) is the trustee of the Plan and, therefore, transactions with Lincoln qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$117,868 and \$107,702 for the years ended December 31, 2024 and 2023, respectively.

Deming, Malone, Livesay, & Ostroff (DMLO) is the auditor of the Plan and, therefore, transactions with DMLO qualify as party-in-interest transactions. Fees paid to DMLO by the Plan for the year ended December 31, 2024 were \$23,000.

PYA Professional Corporation (Pyapc) was the auditor of the of the Plan for 2022 and, therefore, transactions with Pyapc qualify as party-in-interest transactions. Fees paid to Pyapc by the Plan for the year ended December 31, 2024 were \$13,243.

USI Advisors (USI) is an outside advisor of the Plan and, therefore, transactions with USI qualify as party-in-interest transactions. Fees paid to USI by the Plan for the year ended December 31, 2024 were \$16,490.

Morningstar is an investment advisor of the Plan and, therefore, transactions with Morningstar qualify as party-in-interest transactions. Fees paid to Morningstar by the Plan for the year ended December 31, 2024 were \$705.

Certain administrative functions are performed by officers or employees of the Employer. No officer or employee receives compensation from the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the plan termination, participants are entitled to 100% of the value of their accounts.

NOTES TO FINANCIAL STATEMENTS

Note 8. Income Tax Status

The Plan is a prototype plan offered by USI Consulting Group. The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various securities held by Lincoln Financial Group Trust Company. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. Prohibited Transactions

During the plan years ended December 31, 2024, 2023, and 2022, the Employer failed to remit \$10,300, \$3,798, and \$2,718, respectively, of employee contributions within the period prescribed by Department of Labor regulations. The Employer will make a contribution to the affected participants accounts to compensate those participants' for lost earnings due to the delays.
