## INDEPENDENT AUDITOR'S REPORT

To the Trustees

### Opinion

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

---

### NOTE 1 – DESCRIPTION OF PLAN

The following description of Fogelman Properties Health Benefit Plan (the “Plan”) provides only general information. Participants should refer to the plan document and associated separate plan documents for a more complete description of the Plan’s provisions, copies of which may be obtained from the plan administrator.

#### General

The Plan is sponsored by Fogelman Properties, LLC and certain affiliated companies (collectively, the “Company”). The Plan was amended and restated as of January 1, 2019. The Plan provides health care benefits for the benefit of all active employees who have elected to participate, work at least twenty-four (24) hours per week, and have fulfilled the waiting period, as defined. Effective January 1, 2019, an Irrevocable Trust was established to hold the assets of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Benefits

The Plan provides health benefits (accident, hospital, surgical, doctor prescribed drugs, and medical) covering electing eligible employees (and their beneficiaries and covered dependents) who have fulfilled the waiting period, as defined. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Upon retirement, if the employee was covered under the plan on the date of retirement and had fifteen years of consecutive service, the employee and eligible dependents may retain coverage for five years or until the employee is eligible for full Medicare coverage, whichever comes first. The retired employee will be responsible for 100% of the premium.

#### Self-insured benefits

All Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under an administrative service only (ASO) arrangement. The claims processor pays claims directly to or for participants and is then reimbursed by either the Plan’s trust or the general assets of the Company. Despite the Plan’s utilization of a third-party claim’s processor, ultimate responsibility for payments to providers and participants is retained by the Plan. Benefits are paid solely in the form and amount pursuant to the terms of the program.

#### Contributions

The Company makes monthly contributions to cover the benefit obligations of the Plan based upon the number of participants and the contribution rates for coverages, as determined by the plan administrator in connection with service providers. The participating employees are charged for a portion of the monthly contributions based upon applicable monthly premiums for their respective benefit elections, as determined by the plan administrator. Employee contributions are obtained through payroll deductions. The Company makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan’s net assets over benefit obligations is funded on a pay-as-you-go basis.

### Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

### Administrative Expenses

The Plan pays administrative service fees to the third-party claim's administrator for claims processing. The Plan also pays network access fees so that members may access health care services outside the geographic service area, and the related claim for those services can be processed and paid in conformity with network access rules of the third-party claims administrator. These fees along with consulting and professional fees are reported on the statements of changes in net assets available for benefits.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The financial statements of the Plan are prepared in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 965, *Health and Welfare Benefits Plans*. Under FASB ASC 965, the Plan does not report benefit obligations as liabilities in the statements of net assets available for benefits. Instead, information about benefit obligations and the changes in such benefit obligations are presented in separate statements. The financial statements of the Plan are prepared using the accrual method of accounting.

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Plan obligations for health claims incurred but not reported are computed based upon actual claims paid after the end of the plan year. Subsequent year claims payments which represent claims incurred prior to year-end are reported in the accompanying statements of plan's benefit obligations.

In accordance with general practice with self-insurance, the Company maintains a stop-loss insurance policy for the Plan which limits the Plan's liability for any specific claim and aggregate claims. The policy covers claims exceeding \$100,000 per individual with a maximum aggregate benefit of \$1,000,000. Excess loss insurance does not discharge the Company from its primary liability to the covered participants. Consequently, failure of the insurer to honor its obligation could result in additional claims to the Company. Benefits paid by the Plan and reimbursed under stop-loss coverage totaled \$813,627 in 2024 and \$142,514 in 2023. Reinsurance reimbursements are included as stop loss refund receivables of \$65,291 and \$17,202 as of December 31, 2024 and 2023, respectively.

Because of the large volume of prescription drugs purchased through the various health programs provided by the third-party claim's administrator, drug manufacturers make available rebates on certain drugs. The third-party claims administrator returns 100% of the rebates it receives to its self-funded customers based upon the group's pharmacy utilization. Rebates are recorded when received. During the years ended December 31, 2024 and 2023, pharmacy rebates totaled \$71,631 and \$53,950 respectively.

Premiums paid by either the Company or the Trust are recorded as insurance premiums in the accompanying statements of changes in net assets available for benefits.

Claims payments are recorded when paid by the third-party claim's administrator.

### Date of Management's Review

Plan management has evaluated the Plan's December 31, 2024 financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

### **NOTE 3 – RELATED PARTY AND PARY-IN-INTEREST TRANSACTIONS**

Plan expenses that are paid directly by the Company qualify as party-in-interest transactions. The Plan is provided certain services by third parties and the fees for such services qualify as party-in-interest transactions. Fees paid for claims administration services totaled \$499,846 in 2024 and \$491,654 in 2023. Fees paid for professional services and other consulting services totaled \$6,500 in 2024 and \$0 in 2023.

### **NOTE 4 – RISKS AND UNCERTAINTIES**

Financial instruments that potentially subject the Plan to concentrations of risk consist of cash. Those accounts are insured by the Federal Deposit Insurance Corporation up to an aggregate of \$250,000 per institution. At times, deposits may exceed these insured limits. The Plan maintains its cash with high quality financial institutions which the Plan believes limits these risks. The Plan has not experienced any losses in such accounts and management believes the Plan is not exposed to significant risk on cash.

### **NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or to be used for purposes other than for the exclusive benefit of the Plan's participants. The provisions of the Plan will continue in effect for the purpose of payment of plan benefit expense claims incurred on or before the date of termination, but not paid on or before the date of termination.

## NOTE 6 – TAX STATUS

The Plan’s management believes that the Plan and the related trust are currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.
