Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Family Resources, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Family Resources, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) Plan Description and Summary of Significant Accounting Policies

(a) Description of Plan

The following description of the Family Resources, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) profit sharing pension plan established October 1, 2021 covering all full-time employees of Family Resources, Inc., (the “Organization”) who are age twenty-one or older and have completed one month of service. The Plan amendment dated October 1, 2024 described below did not significantly change any Plan provisions, nor did it impact amounts included in the financial statements. Participation in the Plan is voluntary and employees can enroll in the Plan the month after the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Life Insurance Company (U.S.A) (“John Hancock”) serves as the recordkeeper and custodian of the Plan and Qualified Plan Consultants, LLC serves as the trustee of the Plan in 2024 and Mutual of America Financial Group served as the recordkeeper of the Plan and Mid Atlantic Trust Company served as the custodian and trustee of the plan in 2023. The Plan administrator oversees governance of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Changes in the Plan

In October 2024, the custodian and recordkeeping services for the Plan was changed from Mutual of America to John Hancock and the third-party administration services were changed from American Trust Retirement to Qualified Plan Consultants, LLC. The Plan was amended on October 1, 2024 to convert the Plan document and adoption agreement from American Trust Retirement to Qualified Plan Consultants, LLC. All investment funds held by Mutual of America were liquidated and reinvested in funds offered by John Hancock as determined by each participant. All participants hired before the amendment were deemed 100% vested in their employer match contribution.

Contributions

Participants may contribute a percentage of eligible compensation (as defined in the Plan document) in the form of pre-tax or after-tax salary reduction. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (referred to as rollover contributions). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation, with no automatic increase. Contributions related to auto-enrollments are automatically invested in a designated investment fund until changed by the participant. Contributions are subject to certain IRS statutory annual limitations.

The Plan provides for Organization matching and profit sharing contributions which are at the discretion of the Organization. The Organization matches 50% of employee contributions up to 10% of each participant’s eligible compensation. The Organization did not make a discretionary profit sharing contribution in 2024 and 2023.

Employee contributions, matching employer contributions and employer discretionary contributions are invested in one or more investment fund options offered by the Plan as directed by the individual participant.

(a) Description of Plan, continued

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contributions, and (b) Plan earnings (losses) and charged with the participant's withdrawals and an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited balances of terminated participant's nonvested accounts are used to pay for the Plan's general administrative expenses and/or to reduce employer contributions. Total forfeitures used to reduce employer contributions and/or reduce administrative expenses amounted to \$60,256 in 2024 and \$27,072 in 2023. Forfeitures included in net assets available for benefits amounted to \$3,352 and \$2,981 as of December 31, 2024 and 2023, respectively.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service.

Payment of Benefits and Participant Loans

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or installments over a period elected by the participant or their beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan provides that participants may borrow (minimum of \$1,000) up to 50% of the participant's total vested account balance, not to exceed \$50,000. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 1% (effective rates ranging from 4.25% to 9.50%). Participants are only allowed to have two outstanding loans at a time. Principal and interest are paid ratably through payroll deductions over a maximum period of five years for all loans, other than home loans, which must be repaid over a maximum period of fifteen years.

(b) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

The Plan evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are held by John Hancock at December 31, 2024 and Mid Atlantic Trust Company at December 31, 2023 (custodians), who allocate Plan assets to the individual accounts of each participant as directed by the participant.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Contribution Recognition

The Plan recognizes employee and related employer matching contributions based on the period the employee contribution is withheld by the Organization from the employee's compensation.

Administration Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan's sponsor and therefore, are not included in the accompanying statement of changes in net assets available for benefits. Plan administration expenses related to participant loans, member requested services and investment fees are deducted directly from the participant's account balance.

Payment of Benefits and Participant Notes Receivable

Benefit payments to participants are recorded when paid.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when they are incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The excess participant contributions were distributed by the Plan to applicable participants subsequent to year-end.

(3) Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices in active markets of similar assets for assets in non-active markets and Level 3 inputs which consist of other valuation techniques that have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Plan investments requiring the use of Level 3 inputs, transfers between Levels or changes in the methods used to measure fair value in 2024 and 2023. The fair value of the Plan's investments have been determined by John Hancock for the year ended December 31, 2024 and Mid Atlantic Trust Company for the year ended December 31, 2023 and are reported in the accompanying statement of net assets available for benefits as follows:

Level 1 Fair Value Measurements – Mutual Funds

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The mutual funds must publish their daily net asset value and transact at that price; and therefore, they are considered actively traded.

Level 2 Fair Value Measurements – Common Investment Trust

The common investment trust is a stable value fund which invests in various fixed income investment contracts. The underlying assets of the investment contracts include U.S. Government securities, corporate bonds and mortgage backed securities. The fair value of all these investments are used in determining the net asset value of the collective investment trust, which is not publicly quoted.

(4) Related Party and Party-in-Interest Transactions

The Plan investments include shares of mutual funds managed by John Hancock in 2024 and Mutual of America Financial Group in 2023. John Hancock is the recordkeeper as defined by the Plan in 2024 and Mutual of American Financial Group was the recordkeeper in 2023, and therefore these transactions qualify as party-in-interest transactions. Fees paid to for recordkeeping services amounted to \$17,256 and \$10,459 for the years ended December 31, 2024 and 2023, respectively.

(5) Federal Income Taxes

The Plan uses a prototype plan document sponsored by Qualified Plan Consultants, LLC in 2024 and Mutual of America Life Insurance Company in 2023. Qualified Plan Consultants, LLC received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020 and Mutual of America Life Insurance Company received an opinion letter dated November 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan evaluates the tax benefits of a tax position using the "more likely than not" threshold. As of December 31, 2024, management is not aware of any uncertain tax positions and related tax benefits which would be material to the Plan's financial statements. The Plan files annual information returns which for 2020 and subsequent years are subject to examination by taxing authorities.

(6) Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) Subsequent Event – Distributions

On December 31, 2024, two participants requested \$106,793 of distributions from their investment accounts, which were processed and distributed in January 2025. As of December 31, 2024, the distribution amounts for these participants are included in the Plan's investment balance.

(9) Recent Developments

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2025 and forward. The Plan Sponsor is working with Qualified Plan Consultants, LLC to determine that the Plan document is updated to comply with the provisions of SECURE 2.0 Act.


