## INDEPENDENT AUDITORS' REPORT

**Note 1: Description of Plan**

The following description of the Hanlees Dealer Group 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan's Adoption Agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of the participating Companies except collective bargaining employees and nonresident aliens who do not receive United States source income, who have completed 1,000 hours and six months of service, and are age eighteen or older. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The participating companies, collectively ("the Company") are Hanlees Hilltop, Inc. (dba Hanlees Hilltop Toyota), Hanlees Davis, Inc. (dba Hanlees Davis Nissan), Leehan, Inc. (dba Hanlees Hilltop Nissan), Dohan, Inc. (dba Hanlees Davis Chevrolet), DKD of Davis, Inc. (dba Hanlees Toyota of Davis), Hanlees Napa, Inc. (dba Hanlees Napa Subaru Volkswagen), Hanlees Seven, Inc. (dba Hanlees Hilltop Hyundai), DKD of Napa, Inc. (dba Hanlees CDJR Napa), DKD of Hilltop, Inc. (dba Hanlees Hilltop Buick), Leehan of Davis, Inc. (dba Hanlees CDJR Kia), Hanlees Fairfield, Inc. (dba Fairfield Toyota) and Leehan of Fairfield, Inc. (dba Fairfield Nissan).

Administration. Under the terms of the Plan, certain corporate officer's of the sponsor are designated as Plan Trustee. The Plan has contracted The Vanguard Group, Inc. ("Vanguard"), to act as contract administrator, and Ascensus Trust Company ("Ascensus") to act as trustee for the plan. Vanguard has subcontracted with Ascensus to provide record keeping and compliance services.

Contributions. Each year, participants may contribute 0% - 100% of their compensation, as defined in the Plan, subject to IRS annual limits. Employees who are age 50 or older may make additional "catch up" contributions. The Company may make discretionary matching contributions. For the 2024 plan year, the Company contributed \$500 per quarter for each active participant, totaling \$322,000 in matching contributions to the plan. The annual matching contribution was made on January 31, 2025 to participants employed at December 31, 2024.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. An employee must work 1,000 hours during the plan year to be credited with a year of service. A participant is 100 percent vested after six years of service.

Forfeitures. The total non-vested portion of terminated employees account balances are used by the plan sponsor to offset plan expenses or as additional employer matching contributions. There were \$26,921 of forfeitures generated in the current year, and no forfeitures were used to offset employer matching contributions. As of December 31, 2024 there is a balance of \$145,361 remaining in unused forfeitures available to be used to pay plan expenses, or be used to offset employer matching contributions.

Investment Options. Upon enrollment in the Plan, a participant may direct employee contributions in any of a wide variety of professionally managed mutual funds offered by Vanguard. Participants may change their investment options on a daily basis.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump sum distribution or in installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. All investments available in the plan with allow for daily redemptions with no redemption notice period required.

**Note 1: Description of Plan (continued)**

Amendments - There were no amendments to the plan during the year ending December 31, 2024.

Notes Receivable from Participant. Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan balances may be paid over a reasonable period of time not to exceed five years. The loans are secured by the balances in the participants' accounts and bear interest at a rate (as specified in the Wall Street Journal) plus 2%.

**Note 2: Summary of Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments consist of mutual funds. The mutual funds are stated at fair value as determined by Ascensus, based on quoted market prices. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Risks and Uncertainties - The Plan provides for various investment options which are exposed to a variety of risks, including interest rate, market fluctuations, valuation, and credit risks. Due to the level of risk associated with certain investments, it is possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Plan management has evaluated subsequent events through October 10, 2025 the date the financial statements were available to be issued.

**Note 3: Certified Information**

Ascensus Trust Company, the trustee of the Plan, have certified as to the completeness and accuracy of all investments and participant notes receivable reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the investment activities and interest on participant notes reflected on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and all investment information reflected in the supplemental Schedule of Assets (Held at End of Year), in accordance with 29 CFR 2520.103-8(c) of the Department of Labor's Rules and Regulation for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. **Note 4: Fair Value Measurements**

Financial Accounting Standards Board ASC 820-10 (formerly FASB Statement No. 157, Fair Value Measurements), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value ('NAV') of shares held by the plan at year end as reported by Ascensus Trust Company, the trustee of the Plan, based on quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**Note 6: Tax Status and Regulatory Compliance**

The Plan uses the Ascensus, LLC prototype plan document Defined Contribution Basic Plan Document 01, sponsored by Ascensus, LLC who received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Basic Plan Document was amended on June 15, 2021 to adopt the provisions of the Bipartisan Budget Act of 2018 regarding hardship withdrawals. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administration has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 7: Administrative and Investment Fees**

The Plan paid direct participant transaction fees of \$6,375 for the year ending December 31, 2024. Total fund level fees for the investments held at December 31, 2024 range from .04% to .41%, dependent upon the investment selected. The plan sponsor paid Ascensus record keeping fees of \$29,752, and audit fees of \$13,200.

**Note 8: Excess Contributions Payable and Corrective Distributions**

The Plan was required to make corrective distributions of \$86,803 and \$25,179 to certain participants, to return to them excess deferral contributions to satisfy the relevant nondiscrimination provisions of the Plan for the 2024 and 2023 plan years, respectively. This amount is reflected as Excess Employee Contributions Payable in the statement of net assets available for benefits as of December 31, 2024 and 2023.

**Note 9: Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. All of the plan investments are mutual funds offered by Vanguard, who is also the plan's record keeper. Vanguard is the investment advisor for these investments, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Vanguard for investment management services of these mutual funds is included as a reduction of the return on each fund. Notes receivable from participants also reflect party-in-interest transactions.

**Note 10: Reconciliation of Financial Statements to Schedule H of Form 5500**

Accrual for Excess Contributions:

As discussed in note 8, the Plan is required to refund excess contributions for the plan year ending December 31, 2024. For purposes of these financial statements, this amount was recorded as a payable as of December 31, 2024. The form 5500 is prepared on a cash basis, and these refunds will be shown as corrective distributions on the Schedule H for the 2024 tax year.

Due to the cash basis versus accrual basis differences detailed above, Net Assets Available for Benefits are \$86,803 lower in these financials than reported on the Schedule H of form 5500, and the Net increase reported on the Statement of Changes in Net Assets Available for Benefits is \$61,623 lower in these financial statements than reported on the Schedule H of form 5500.

**Note 11: Prohibited Transactions - Late Participant Contributions**

During the year ending December 31, 2024, the Plan sponsor inadvertently failed to deposit contributions of participant deferrals and loan repayments, totaling \$8,085, within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions.
