### NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023 AND THE YEAR ENDED DECEMBER 31, 2024

#### 1. DESCRIPTION OF THE PLAN

The following description of the Columbia Sussex 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan Document for more complete information.

**General** - The Plan is a defined contribution plan covering substantially all employees of Crestview Management, LLC (the “Company”), except certain employees covered by collective bargaining agreements for which retirement benefits have been negotiated, who have completed six months of service, are at least eighteen (18) years of age and elect to participate in the Plan. The Board of Directors of the Company control and manage the operation and administration of the Plan. Fidelity Management Trust Company (“Fidelity”) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Affiliated and Unrelated Employers** - The Plan Document has also been adopted by Columbia Sussex Corporation allowing employees of the Company to participate within the Plan.

**Contributions** - Participants may contribute up to 25% of their annual wages in the form of an “Elective Deferral,” and certain catch up contributions for those over 50 years of age, both subject to additional limits for contributions made on the participants’ behalf under any other qualified cash or deferred arrangements. The Company makes matching contributions to all non-highly compensated participants within the Plan, receiving a Company matching contribution of 75% of the first 6% of base compensation that a participant contributes to the Plan.

At the discretion of the Company’s Board of Directors, additional amounts could have been contributed as “qualified nonelective employer contributions,” only for certain non-highly compensated participants. The Company did not make a discretionary contribution for 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (known as “rollovers”).

Participants may elect to make all or a portion of the contributions to the plan on an after-tax basis (Roth Deferral Contributions). Roth Deferral Contributions and related future earnings thereon can be withdrawn tax-free subject to certain limitations.

**Participant Accounts** - Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s matching and discretionary contributions, if any, and allocations of Plan earnings, and charged with withdrawals and an allocation of Plan losses and an allocation of certain administrative expenses. Certain expenses, such as loan withdrawal or maintenance fees, are charged directly to the participant’s account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments** - A participant can specify the manner in which contributions made by or for the participant to the Plan shall be invested in the available funds under the Plan and may elect to change the funds to which future contributions are allocated and transfer amounts held in the participant's Plan account from one fund to another.

**Vesting** - Participants are fully vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of credited service.

Employer contributions and earnings will be vested in accordance with the following schedule:

**Notes Receivable from Participants** - Participants may borrow from their fund accounts up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. The loans are secured by the balance in the participant's account and have interest rates commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator. Participants are charged a loan origination fee and a quarterly maintenance fee during the term of the loan. The loan fees are deducted from the participant's account. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** - Upon termination of service due to death, but before receiving the value of their plan account balance, the participant's beneficiary shall receive a lump-sum distribution in cash or in kind, in the form of various annuity contracts, or any combination thereof. In-service withdrawals are allowed upon attainment of age 59 ½ or upon incurring a financial hardship if certain requirements are met.

Upon termination of service other than due to death, for participants with a Plan account balance of more than \$5,000, the account balance may not be distributed prior to the participant's normal retirement date unless the participant consents to the distribution. Employees choosing to defer distribution continue to participate in investment gains and losses, but are no longer eligible for matching or discretionary contributions by the Company, if any. Employees also would be responsible for all fees necessary to maintain the account following separation from service.

If the participant's vested Plan Account balance is \$5,000 or less, the Plan Administrator will direct the Trustee to distribute the funds to the participant as a lump sum distribution, without the participant's consent. Any distribution greater than \$1,000 before the participant's normal retirement age will be rolled over to an Individual Retirement Account or Annuity ("IRA") for their benefit.

**Forfeitures** - Any nonvested Company contributions forfeited by participants under the Plan are applied to reduce subsequent contributions of the Company to the Plan and to offset Plan administrative expenses. During the plan year ended December 31, 2024, employer matching contributions of \$30,632 and administrative expenses of \$23,080 were offset by forfeited nonvested accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$557,200 and \$284,008 respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, and on the accrual basis.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value. Shares of mutual and money market funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

**Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding adjustment to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, loan withdrawal or maintenance fees are charged directly to the participant's account and are included in administrative expenses.

Management fees and operating expenses charged to the Plan for investments in the mutual and money market funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

**Subsequent Events** - For the year ended December 31, 2024, subsequent events were evaluated through October 3, 2025 the date the financial statements were available to be issued.

### 3. INVESTMENTS

ASC 820, *Fair Value Measurements and Disclosures*, established a single authoritative definition of fair value, set a framework for measuring fair value, and requires additional disclosures about fair value measurements. In accordance with ASC 820, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The Plan’s investments that are measured at fair value on a recurring basis, such as money market funds and mutual funds are generally classified within Level 1 of the fair value hierarchy. The fair value of these investments is valued based on quoted market prices in active markets. There have been no changes in the methodology used at December 31, 2024 and 2023.

### 4. ADMINISTRATION OF PLAN ASSETS AND EXEMPT PARTIES-IN-INTEREST

Plan assets are held by Fidelity Management Trust Company (“Fidelity”), the trustee of the Plan. Certain Plan investments are shares of mutual funds managed by Fidelity. As such, these transactions qualify as party-in-interest transactions. The Company and participant contributions are held and managed by the trustee, which invests cash received, interest and dividend income, and makes distributions to participants. Fidelity charges the Plan administrative fees for managing the funds. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## **5. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts. The benefits will be distributed to participants by the Trustee, less administrative costs to the Trustee for such distribution.

## **6. FEDERAL INCOME TAX STATUS**

The Company adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **7. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivables from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, Note 3, and the supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

## **8. RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments, including mutual and money market funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the financial statements.
