1. Description of Plan

The following brief description of the H & K Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was originally effective November 1, 1985 and most recently amended and restated effective January 1, 2022. The Plan is a defined contribution plan covering all employees of the H & K Group (the “Company”) and its participating related companies, who have completed three months of eligibility service. Nonresident aliens, part time employees, and employees who are covered by a collective bargaining agreement are ineligible to participate in the Plan. Eligibility requirements have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (“SECURE Act 2.0”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Eligible participants may elect to contribute a portion of their compensation, as defined, subject to certain Internal Revenue Code (“IRC”) limitations. The Plan provides for an automatic enrollment of salary deferral contributions of 2% from payroll of new eligible employees, unless otherwise elected by the participant.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. These catch-up contributions are limited to \$7,500 for 2024 and 2023, and are not eligible for the Company match contribution.

The Plan provides for discretionary employer matching contributions varying from 25 to 50 percent of the first 6% of eligible compensation that a participant contributed to the Plan, subject to certain limitations as detailed in the Plan document.

The Company, in its sole discretion, may make profit sharing contributions on behalf of each participant who was employed on the last day of the Plan year, in an amount to be determined by the Company. For purposes of receiving profit sharing contributions, an employee becomes eligible after the completion of one year of service, defined as 1,000 hours. The employee must also be employed at the end of the Plan year. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and employer matching contributions, if any, as well as allocations of the Company’s profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments

All investments are participant-directed. A participant can direct the investment of employee and employer contributions into various investment options including mutual funds (registered investment companies), self-directed brokerage accounts, and a pooled separate account. The Company designates an age-appropriate target fund as the default investment for participants who do not make an affirmative election of an investment fund.

Vesting

A participant, at all times, has a fully vested (100%) interest in their contribution accounts, rollover accounts, and actual earnings thereon. Vesting in the employer matching contributions and the Company’s profit sharing

contributions is based on years of service with a five-year graded schedule. A participant is fully vested upon the completion of five years of service or upon attaining normal retirement age, death or disability.

Forfeited Accounts

Forfeitures resulting from the non-vested portions of accounts of participants who terminate employment prior to being fully vested are used to reduce employer contributions and/or to pay any administrative expense. Total unallocated forfeitures were \$307,360 and \$199,196 at December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$0 and \$177,013 were used to offset employer contributions, respectively. No forfeitures were utilized to pay administrative expenses for the years ended December 31, 2024 and 2023.

Notes Receivable from Participants

Active Plan participants may request loans for a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the participant's vested account balance. Loan terms range from one to five years, or up to fifteen years for the purchase of a primary residence. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account balance and bear interest at rates as directed by the Plan. At December 31, 2024, the interest rates ranged from 4.25% to 9.50%. Loan application and processing fees are charged directly to the participant's account balance. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

In the event of a participant's death, retirement, disability or termination of employment for other reasons, the participant or his beneficiary may elect to receive the entire account balance in a lump sum or leave their account balance in the Plan. Account balances which do not exceed \$5,000 will automatically be paid in a lump sum as soon as administratively feasible. Hardship and in-service distributions are also permitted from participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America, requires Plan management to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The benefits steering committee of the Plan sponsor determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Profit sharing contributions from the Company, if any, are recorded in the year in which the related participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants during 2025 and 2024, respectively.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment management fees, fees related to the administration of notes receivable and other participant specific fees are charged directly to the participant's account and are included in administrative expenses. Certain other professional expenses of the Plan and its participants are partially offset through income generated from revenue sharing agreements (which is reported in the statements of changes in net assets available for benefits as other investment income, see Note 7) or from forfeited accounts. Other investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events

Management evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, a qualified institution and trustee of the Plan, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including interest and dividend income, net appreciation in fair value of investments, other income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The information for all mutual funds, self-directed brokerage accounts, pooled separate accounts and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds and self-directed brokerage accounts: Mutual funds (registered investment companies) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Self-directed brokerage accounts generally are limited to certain mutual funds, including money market funds, and publicly traded common stock, preferred stock, and exchange-traded funds. Common stock, preferred stock, and exchange-traded funds are valued at the closing prices reported on the active market on which the individual securities are traded.

Pooled separate account: The pooled separate account is valued at the net asset value or equivalent based on units of the pooled separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its investment in the MassMutual Stable Diversified Separate Account, a pooled separate account. The MassMutual Stable Diversified Separate Account is composed primarily of fixed income securities. Participants' ownership of the pooled separate account is represented in units. The investment objective is to provide a stated rate of return, generated from performance of a diversified portfolio, that insulates the account from daily fluctuations in the bond market. This investment option provides an interest rate that is determined based on the anticipated market returns in the separate account. The MassMutual general account guarantees to pay a stated rate of return to the pooled separate account. MassMutual may impose restrictions on frequent trading and withdrawals might be processed at fair value or payments may be delayed if the event that produced the withdrawal was employer or sponsor initiated (e.g. termination of contract, layoffs, etc.). Participant transactions are processed on a daily basis.

5. Tax Status

Effective January 1, 2022, the Plan was amended and restated by adopting a non-standardized profit sharing/401(k) plan sponsored by the Vanguard Group. The IRS issued an opinion letter dated June 30, 2020, stating that the non-standardized profit sharing/401(k) plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for

any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Related Party and Party-in-Interest Transactions

The Plan invests in mutual funds which are managed by affiliates of Vanguard Fiduciary Trust Company ("VFTC"). The Plan also pays to VFTC certain administrative, trustee, recordkeeping, and other expenses. VFTC is the trustee as defined by the Plan and, therefore, transactions in these securities qualify as party-in-interest transactions. Such transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

VFTC or its affiliates generate income to the Plan through revenue sharing agreements. More specifically, VFTC or its affiliates may receive revenue from mutual fund and pooled separate account service providers for services VFTC or its affiliates provide to the funds and pooled separate account. This revenue may be used to offset certain amounts owed to VFTC or its affiliates for administrative services to the Plan. If the revenue received by VFTC or its affiliates from such mutual fund or pooled separate account service providers exceeds the amount owed as agreed to by VFTC and the Plan for administrative services, VFTC or its affiliates is to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the years ended December 31, 2024 and 2023, the related amounts deposited into the Plan were approximately \$96,303 and \$114,809, respectively. As of December 31, 2024 and 2023, the Plan has \$130,115 and \$152,123, respectively, of such amounts in unallocated accounts. During 2024 and 2023, the Plan used \$125,085 and \$123,996 of the amounts deposited to pay administrative expenses of the Plan. The Plan or Plan Sponsor may make a payment to VFTC or its affiliates for administrative expenses not covered by revenue sharing.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.
