INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of V. Alexander & Co., Inc. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of V. Alexander & Co., Inc. Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

Note 1 – Description of plan

The following description of the V. Alexander & Co., Inc. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering the employees of V. Alexander & Co., Inc. (the “Company”) who are twenty-one years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended to be a safe harbor plan and a Principal safe harbor prototype plan document was adopted.

Contributions

Participants may elect to contribute up to 100% of their annual pre-tax compensation, subject to annual limits as prescribed by the Internal Revenue Code. Participants may also elect to contribute on an after-tax basis as a Roth 401(k) deduction, subject to the annual limits as prescribed by the Internal Revenue Code. The Company contributes a match up to 100% of the first 5% of compensation that a participant contributes to the Plan as a safe harbor contribution. The plan also allows certain eligible rollover contributions.

Participant accounts

Each participant’s account is credited with an allocation of the Company’s contribution and the Plan’s earnings as stated in the Plan Document. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments

Participants may direct contributions in several investment options. The Plan offers various pooled separate investment accounts, a collective investment trust account, and mutual funds as investment options. Participants may change their investment options and transfer previously contributed amounts between fund options at any time.

Vesting

All participants are immediately 100% vested in both participant and Company match contributions under the safe harbor guidelines.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments not exceeding ten years. For termination of service due to other reasons, a participant may receive the vested account balance as a lump-sum payment. Benefit payments to participants are recorded when paid.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum of 50% of their vested benefits up to \$50,000 reduced by any outstanding loan balance, if any during the one-year period ending on the day before the new loan is made, if less. Only one loan may be outstanding at a time. The loans are secured by the balance in the participant’s account and bear interest at the prime rate determined at the time the loan is made. Loan repayments and related interest are deducted from participant’s paychecks over installment periods up to five years.

Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Note 2 – Summary of significant accounting policies*Basis of accounting*

The accompanying financial statements of the Plan are prepared under generally accepted accounting principles in the United States of America.

Investment valuation

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator considers the participant loan to be in default, the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

Plan expenses

The Plan pays various transaction fees whereas the Company pays the basic administrative expenses of the Plan, less forfeitures, as provided in the Plan document.

Payment of benefits

Benefit payments to participants are recorded when paid.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Date of management's review

Management has evaluated subsequent events through October 15, 2025, which was the date the financial statements were available to be issued, for possible recognition of disclosure in the financial statements. Management has determined that there are no material events or transactions that would require recognition or disclosure in the Plan's financial statements.

Note 3 – Information prepared and certified by the custodians

The following is a summary of the information included in the Plan's financial statements and supplemental schedule for 2024 which was prepared by the trustee of the Plan assets, Principle Life Insurance Company, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

- A. Investments at the beginning and end of the year.
- B. Changes in net assets resulting from investment activities.
- C. Information included in the supplemental schedule of assets (held at end of year), except for notes receivable from participants.

Note 4 – Fair value measurements

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement and Disclosures*, provides a common definition of fair value and establishes a framework for measuring fair value. ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC Topic 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value, and describes three levels of inputs that may be used to measure fair value.

- Level 1 - Quoted prices for identical assets in active markets that the entity has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, and other inputs that are observable or can be correlated by observable market data.
- Level 3 - Significant unobservable inputs that reflect a plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: The fair value of pooled separate accounts is determined by the trustee based on the fair value of the underlying investments, which primarily consist of publicly traded equities, fixed income, and other marketable securities. Although the PSA units themselves are not publicly quoted, the NAV is calculated daily and reflects quoted market prices for the underlying securities. Because the underlying securities are actively traded and the NAV is readily determinable, these pooled separate accounts are classified as Level 1.

Collective investment trust: The fund's value is based on its net asset value ("NAV"), which is determined in accordance with GAAP for investment companies and reflects the fair value of the underlying investments, primarily in publicly traded securities. Although the NAV is not publicly quoted, it is available to participants on a daily basis and serves as the basis for all purchase and redemption transactions. Because the NAV is readily determinable and represents the fair value of the underlying assets, the trustee has classified this investment as Level 1 to provide consistency with the valuation of comparable mutual funds.

Mutual Funds: Valued daily at the closing price reported on the active market on which the funds are traded.

Each account is then included within the fair value hierarchy based on the lowest level of any asset, or group of assets, that is significant to the overall fair value measurement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax status

The Plan operates under the Principal Financial Group Prototype Basic Savings Plan. This prototype document has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. There were no uncertain tax positions at December 31, 2024 and 2023. The Plan is subject to routine audits by various taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 6 – Plan termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Transactions with parties-in-interest

Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Company manage certain Plan investments of pooled separate accounts, a collective investment trust account, and mutual funds. Principal Life Insurance Company and Principal Trust Company were the custodians for 2024 as defined by the Plan and, therefore, these transactions qualify as exempt parties-in-interest transactions. Fees paid by the Plan for the investment services amounted to \$146,701 and \$132,136 for the years ended December 31, 2024 and 2023, respectively.

V. Alexander & Co., Inc. pays certain administrative expenses on behalf of the Plan and provides certain services at no cost to the Plan.

Note 9 – Separated participants

At December 31, 2024 and 2023, the Plan held balances for participants who have terminated totaling \$5,623,045 and \$5,534,493, respectively.
