INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Responsibilities of Management for the Financial Statements (continued)

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Auditor's Responsibilities for the Audit of the Financial Statements (continued)

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA


The supplemental schedule of Schedule H, Line 4i — Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Pacific Legal Foundation (“the Foundation”) 403(b) Plan (“the Plan”) provides only general information. Participants should refer to the Plan documents and any amendments thereto for a more complete description of the Plan’s provisions.

General

The Plan is a voluntary, defined contribution plan subject to the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Eligibility for elective deferrals is universal—all employees may make salary deferrals (subject to applicable IRS limits). Employees who normally work fewer than 20 hours per week are not eligible for employer matching or nonelective contributions; eligibility for such employer contributions applies only to employees who normally work 20 hours or more per week, as defined by the Plan.

Contributions

Under the Plan, eligible participants may elect to contribute up to 100% of their compensation for the year, not to exceed the Internal Revenue Service (IRS) limitation of \$23,000 for the Plan year ended December 31, 2024. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Foundation may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the participant elective deferrals. The Foundation may make discretionary contributions as well, not to exceed the maximum amount that may be contributed under the law. In order to receive the matching contributions, the participant must work at least 501 hours during the plan year.

1. Plan Description (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, as well as allocations of the Foundation's nonmatching and matching contributions, if any, and Plan earnings and losses, less any charges, if applicable. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various mutual funds and annuity contracts offered by Nationwide Group Retirement Series (Nationwide) in accordance with Plan documents.

Vesting

Participants' contributions, including Roth 403(b) deferrals, catch-up contributions, and rollover contributions, are fully vested at all times and are not subject to forfeiture for any reason.

Employer matching and nonelective contributions vest according to the following schedule, with a year of service defined as a one-year period ending December 31 in which the participant has 1,000 or more hours of service:

Notes Receivable from Participants

Participants may borrow from the Plan against their account balance. Loans are treated as a directed investment of the borrower's account. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance subject to annuity contract and plan provisions. Loan terms range from one to five years, or a longer term for the purchase of the participant's primary residence. Loans bear interest at market rates. Principal and interest are paid ratably by the participant at least quarterly.

1. Plan Description (continued)

Payment of Benefits

Upon retirement, death, disability, or termination of employment (after attaining age 65), a participant or, in case of death, the beneficiary, may elect to receive a lump sum, partial payments, or in various installment annuities based on the participant's marital status and the terms allowed under each investment fund in which the participant's account is invested. Participants may also request a distribution from their elective deferrals upon reaching age 59½, incurring a disability, or incurring a financial hardship, as defined in the Plan document.

Forfeitures

As of December 31, 2024 and 2023, there were \$53,849 and \$21,958, respectively in forfeited nonvested accounts. These accounts may be used to reduce future employer contributions or to pay administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair market value.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Investments in registered investment companies are carried at fair value based on quoted market prices. The Plan's guaranteed fixed income annuities are considered fully benefit-responsive and are reported at contract value. The fair value, estimated using a discounted cash flow model, is disclosed in Note 3 and classified within Level 2.

Purchases and sales of securities are recognized on a trade date-basis. Interest income is recognized on the accrual basis. Dividends are reported on the ex-dividend date. The net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year, as well as those held at year end.

2. Summary of Significant Accounting Policies (continued)

Payment of Benefits

Benefits and other distributions are recorded when paid.

Administrative Costs

Administrative expenses of the Plan are generally paid by the Plan sponsor. However, the Plan may require the payment of a pro-rata share of administrative expenses by individual participants under certain circumstances.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from estimated amounts.

Subsequent Events

In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The Plan follows Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, for its financial assets. This standard establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value measurement standards require an entity to maximize the use of observable inputs (such as quoted prices in active markets) and minimize the use of unobservable inputs (such as appraisals or other valuation techniques) to determine fair value. The categorization of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to the entity's perceived risk of that instrument. The inputs used in measuring fair value are categorized into three levels:

Level 1: Inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to this valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following section describes the valuation methodologies the Plan uses to measure its assets at fair value.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within Level 1 of the valuation hierarchy.

Guaranteed Investment Contracts: The Plan holds a group annuity contract, the Best of America Fixed Contract, issued by Nationwide Life Insurance Company. The contract provides a guaranteed minimum interest rate of 0.35% and is backed by the general account of the issuer.

Because the contract is fully benefit-responsive, it is reported at contract value, which represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value is the relevant measure for participant-directed transactions and is therefore the amount presented in the accompanying statements of net assets available for benefits. At December 31, 2024 and 2023, the contract value approximated fair value.

For disclosure under FASB ASC 820, the fair value of the contract is estimated using a discounted cash flow model that considers the contract's interest crediting rate, duration, and the financial strength/credit rating of the issuer. The fair value measurement relies primarily on observable market inputs (such as current interest rate yield curves) and therefore is classified within Level 2 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Guaranteed Investment Contracts with Insurance Companies

At December 31, 2024 and 2023, the Plan held an investment in the Best of America Fixed Contract, a group annuity contract issued by Nationwide Life Insurance Company. The contract provides a guaranteed minimum interest rate and is backed by the general account of Nationwide Life Insurance Company.

4. Guaranteed Investment Contracts with Insurance Companies (continued)

Certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. The contracts may be terminated by the Plan sponsor by providing notice of termination. Employer directed withdrawals, including termination, may be subject to a surrender charge, as outlined in the agreement. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

5. Related Party and Party-in-Interest Transactions

The Plan's custodian and issuer of the guaranteed investment contract, Nationwide Life Insurance Company, is a party-in-interest under ERISA. Accordingly, transactions involving Nationwide qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

6. Plan Termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Administrative Error

During 2024, the Plan Sponsor identified an administrative error in which certain participant elective deferral contributions were not withheld from compensation in accordance with participant elections and certain employer contributions were not properly calculated and contributed. The Plan Sponsor has taken corrective action, including contributing amounts equal to the missed deferrals and related investment earnings to the affected participant accounts. Management has concluded that the correction does not have a material impact on the Plan's financial statements.

9. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-5(c) of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Certain information related to investments disclosed in the accompanying financial statements and supplementary schedule held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from the information supplied to the Plan Administrator and certified as complete and accurate by Nationwide, custodian of certain Plan assets.

10. Income Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the IRS. The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2017. The Plan has not individually sought its own determination letter. The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

The Plan's management has evaluated the Plan's tax positions and concluded that there are no significant uncertain tax positions that qualify for either recognition or disclosure in the accompanying financial statements.
