INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Nelson Automotive Group 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nelson Automotive Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ending December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of the Nelson Automotive Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan Administrator oversees governance of the Plan and with assistance of advisors determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

General

The Plan is a defined contribution plan covering all full-time employees of the Nelson Automotive Group (the “Company”) who have at least one year of service and have attained 21 years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participant Contributions: Plan participants can elect to contribute up to 100% of their eligible compensation not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code. Participants may designate their contributions as a pre-tax deferral or on an after-tax basis (Roth contribution). Contributions are based upon total eligible compensation, which includes all compensation that is paid for or made available during the Plan year, excluding any compensation received (a) while being a member of an ineligible class of employees and (b) prior to the date of becoming a participant. Participant’s contributions are made through automatic payroll deductions every pay period. Pre-tax deferral contributions and related earnings are not taxable to the participant until they are withdrawn from the Plan. Roth contributions and related earnings are not taxed upon distribution from the Plan.

Rollovers: Participants who were members of a former employer’s qualified plan may elect to make a rollover contribution from that plan to the Plan.

Employer Contributions: The Company may also make annual discretionary matching and/or profit-sharing contributions in an amount to be determined at Plan year end by the Company’s Board of Directors. These discretionary contributions will be allocated following the end of the Plan year to all participants eligible to share therein based on each qualifying participant’s eligible compensation for the Plan year to the total eligible compensation of all qualifying participants for the Plan year. To be eligible for employer contributions, with limited exceptions, an employee must have at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year. There were no such contributions made for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s contribution, if any, and (b) Plan earnings (losses) and any directly allocable administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES TO FINANCIAL STATEMENTS – (Continued)

1. DESCRIPTION OF PLAN – (Continued):

Vesting

Participants are immediately vested in their participant contributions, rollovers, and actual earnings thereon. Vesting in the employer's discretionary matching and profit-sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is credited with one year of service when credited with 1,000 hours of service during a Plan year. A participant is 100% vested in employer discretionary contributions after six years of credited service.

Investment Options

Participants may direct their contributions to various registered investment companies.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms cannot exceed 5 years unless the loan is for the purchase of a primary residence. The loans are secured by the participant's vested account balance and bear interest at current market rates. Principal and interest is paid ratably through payroll deductions. Participants may only have one outstanding loan at any time.

Payment of Benefits

The Plan is designed to provide participants with benefits at the time of retirement. However, if employment with the Company is terminated, the participant's vested account balance becomes distributable to them. Upon proper notification of the Plan Administrator, the vested account balance will be distributed to the participant in the form of a lump-sum cash payment. The participant may also request a rollover distribution, as soon as practicable after separation from service. Individual vested account balances of \$1,000 or less can be involuntarily cashed out to the participant as a lump sum payment, subject to tax withholding requirements. For vested account balances above \$1,000, the participant may request a distribution or remain in the plan.

The normal retirement age for the Plan is 65. Participants may continue employment and participation in the Plan past the normal retirement age. In-service distributions are allowed only to participants who have reached age 59 ½, which may include the distribution of employer discretionary matching and/or profit-sharing contributions. Hardship withdrawals of elective participant deferrals are also allowed by the Plan.

If a participant dies while a member of the Plan or before any or all of their account balance has been distributed to them, their beneficiary will be entitled to receive the participants' vested interest in his or her account.

Forfeited Accounts

As of December 31, 2024 and 2023 forfeited non-vested accounts totaling \$43,326 and \$40,575 were available to reduce future employer matching and/or profit sharing contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following accounting policies, which conform to accounting principles generally accepted in the United States of America (“GAAP”), have been used consistently in the preparation of the Plan’s financial statements.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to determine fair value of investments. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Substantially all administrative expenses of maintaining the Plan are paid by the Company. Custodian fees are allocated to participant accounts. Participant loan origination fees, annual loan maintenance fees, and benefit distribution fees are paid by the participant acquiring the loan or receiving the distribution. Any remaining expenses are paid by the Company.

NOTES TO FINANCIAL STATEMENTS – (Continued)

3. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Notes receivable from participants held by the Plan also are party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. Some of these officers or employees are also Plan participants. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

Ascensus Trust Company (the “Trustee”) served as trustee during 2024 and 2023 and managed the Plan investments for both years. These investment transactions qualify as party-in-interest. Fees paid to the Trustee for investment management services and administrative costs amounted to \$1,020 for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS:

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the period presented.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies – Shares of registered investment companies (mutual funds) are valued at quoted market prices on the last business day of the Plan year, which represents the fair market value of shares held by the Plan (Level 1).

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. All unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

6. TAX STATUS:

The Plan adopted a prototype plan sponsored by the Trustee. The Trustee received a determination letter dated as of June 30, 2020 from the Internal Revenue Service (“IRS”) stating that it is an acceptable plan under Section 401(a) of the Internal Revenue Code. The Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. TRUSTEE CERTIFICATION:

As of December 31, 2024 and 2023 and for the year ended December 31, 2024, all assets are held and invested by the Trustee. The Trustee also receives and holds all income from the investments. In accordance with DOL Section 2520.103-8 for reporting and disclosure under ERISA, verification of the transactions and investment values is not required and is not within the scope of our audit.
