Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed audits of the financial statements of **Natoli Engineering, Inc. Employees 401(k) Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

NOTE 1 DESCRIPTION OF PLAN

The **Natoli Engineering Employees 401(k) Profit Sharing Plan** (the Plan) was adopted effective January 1, 1985, and has been amended and restated throughout the years to comply with tax legislation. The Plan was last restated effective January 1, 2009, and amended March 1, 2023. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of **Natoli Engineering Company, Inc.** (the Company) who meet certain eligibility requirements. An employee is eligible to participate in the Plan upon reaching age 18 and the completion of 60 days of service, as defined in the Plan document. Employees may participate in the Plan on the first day of the following month upon meeting the eligibility requirements. The Plan excludes employees who are key employees under IRS rules, non-resident aliens, leased employees, independent contractors, and employees covered under a collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for the oversight of the Plan.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, elect annually to make matching and/or profit-sharing contributions to the Plan. Participants are eligible for matching contributions once they have completed one year of service, are employed on the last day of the Plan year and have a minimum of 1,000 hours of service during the Plan year. The Company's matching contribution is 50% of employee deferrals up to 7.00% of eligible compensation for the year ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balance or participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan offers a guaranteed investment contract or pooled separate accounts as investment options.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes to Financial Statements (Continued)

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions when the participant reaches age 59 1/2. Hardship distributions are allowed subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize the benefit payment be rolled into an individual retirement account in the participant's name.

Participant Hardship Withdrawals

According to the Plan, each participant who has not attained age 59-1/2 may make a hardship withdrawal if he or she demonstrates that the withdrawal is necessitated by the participant's immediate and heavy financial need and the participant lacks the available resources.

Loans to Participants

Participants may borrow up to ½ (not to exceed \$50,000) of the vested portion of their account, if approved by the Plan administrator. Loans bear a reasonable interest rate that is commensurate with the interest rates charged by local commercial banks for similar loans.

Forfeited Accounts

Participants who terminate their employment and are less than 100% vested in their employer's contributions forfeit their non-vested portion. The forfeitures may be used to reduce administrative expenses or used to reduce future Employer contributions. For the years ended December 31, 2024 and 2023, forfeitures added from distribution of non-vested accounts totaled \$14,220 and \$11,931, respectively. Forfeitures used to pay Plan expenses totaled \$10,160 and \$10,474 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the Plan had cumulative forfeitures of \$22,579 and \$18,519, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fixed interest account which is reported at contract value and the pooled separate accounts which are reported at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investments Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administration

The officers of the Company serve as Plan Trustees. Certain Plan expenses are absorbed by the Company at the Company's discretion and excluded from these financial statements.

Subsequent Events

Management of the Plan has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued, for possible additional recognition or disclosure.

NOTE 3 INVESTMENTS

Investments

During 2024, the Plan's investments appreciated in value by \$645,946.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Notes to Financial Statements (Continued)

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy under the standards are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a summary of the inputs used, as of December 31, 2024 and 2023, respectively, involving the fund's assets carried at fair value.

- Registered Investment Companies— valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the insurer and record-keeper, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions could result in a different fair value measurement at the reporting date. The Plan's investments are reported at net asset value and are not leveled on the fair value hierarchy for the years ended December 31, 2024 and 2023.

(1) Investment Strategy

The multi-strategy pooled separate account and registered investment companies consist of sub-accounts investing in mutual funds. The mutual funds in the sub-accounts range from blend, bond, growth, money market, retirement, target date, value, and world stock options.

Each mutual fund sub-account has its' own investment strategy. Therefore, there is not one overall strategy for the pooled separate account and registered investment companies other than the Plan's investment objective of providing Plan participants with a sufficient variety of investments options to enable participants to achieve their individual investment goals for retirement. Participants can direct their money into the sub-accounts of their choice.

Participants can transact with the pooled separate account and registered investment companies sub-accounts on a daily basis by changing investment elections and transferring money between sub-accounts. At a Plan level, partial surrenders must be paid proportionately from all investment options and is limited to once per 90 calendar days.

Notes to Financial Statements (Continued)

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the participants' accounts will become 100% vested. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 6 TAX STATUS

Financial accounting standards for uncertain tax positions prohibit financial statement recognition of the impact of a tax position if the position is not "more likely than not" to be sustained on audit, based on the technical merits of the position. The Plan's Annual Return/Report of Employee Benefit Plan remains subject to examination by taxing authorities for three years after they have been filed. As of October 14, 2025, no returns have been selected for examination.

The Plan adopted a prototype plan. The prototype plan was approved by the Internal Revenue Service in its latest opinion letter dated March 31, 2014. The Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the IRC).

NOTE 7 PARTY-IN-INTEREST

Certain investments of the Plan were in entities affiliated with Fidelity Workplace Services LLC, the record-keepers of the Plan and, therefore, related transactions qualify as party-in-interest transactions.

NOTE 8 SUMMARY OF FINANCIAL DATA CERTIFIED BY CUSTODIAN

As permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to have Fidelity Management Trust Co., the custodians of the Plan, certify as to the accuracy and completeness of the information. Fidelity Management Trust Co. certified to the accuracy and completeness of the information at December 31, 2024 and 2023 included in the accompanying statements and instructed the Plan's independent accountants not to perform any auditing procedures with respect to such information.

Accordingly, the following information certified by Fidelity was not subjected to any auditing procedures except for comparing such information with related information contained in the accompanying statements.

- A. Investments held by subservice organizations on behalf of Fidelity at fair value as of December 31, 2024 and 2023 included in the accompanying statements of net assets available for benefits.
- B. Investment income included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023.
- C. Investments held by subservice organizations on behalf of Fidelity as of December 31, 2024 and 2023, included in the accompanying schedule of assets held for investment at end of year.
