Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of FSSY Home Care - 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 (in liquidation), and the related statement of changes in net assets available for benefits for the year then ended (in liquidation), and the statement of net assets available for benefits as of December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the board of directors of the Plan Sponsor approved a plan of liquidation on September 12, 2024, and the Plan Sponsor terminated the plan effective October 31, 2024. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of FSSY Home Care - 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on July 1, 2011 and restated on September 14, 2014 pursuant to a Collective Bargaining Agreement between Family Service Society of Yonkers (the "Organization" or the "Plan Sponsor") and District Council 1707, CSAEU, AFSCME, AFL-CIO, Local 389 for the benefit of the Organization's union members. All union members become eligible on the first day of employment with the Organization. An eligible employee may enter the Plan on the first month coinciding with or following the date on which the employee meets the eligibility requirements. The Plan's trustees are responsible for oversight of the Plan and determining the appropriateness of the Plan's investments and for monitoring investment performance. The Organization is also the plan administrator. The recordkeeper of the Plan is Principal Life Insurance Company. The Plan is self-trusted, however, Principal Life Insurance Company is the directed trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

On June 15, 2022, the plan restated the existing plan document pursuant to the newly adopted Collective Bargaining Agreement between the Organization and District Council 37, AFSCME, AFL-CIO, Local 389 (the "Union") and made the following modifications to the plan's employer additional contributions: (1) to include \$0.20 for each hour of service performed during the payroll period beginning January 1, 2022 of an active participant, (2) to include \$1.08 for each hour of service performed during the payroll period beginning January 1, 2022 of newly hired personnel during any applicable probationary period with the Union (not to exceed 360 hours), and who was an active participant, and (3) to include \$0.33 for each hour of service performed during the payroll period beginning January 1, 2022 of personal assistants in the Consumer Directed Personal Assistance Program ("CDPAP"), and who was an active participant. On the same date, the plan adopted an amendment to comply with the requirements of certain provisions of the Bipartisan Budget Act of 2018 and final regulations that amend the rules relating to hardship distributions.

On November 1, 2022, the plan adopted amendments to change the plan name from FSSY Union 401(k) Plan to FSSY Home Care - 401(k) Plan and change employer additional contributions from \$0.20 to \$1.20 for each hour of service performed on or after October 1, 2022 of an active participant.

1. DESCRIPTION OF PLAN - CONTINUED

Plan Termination

On April 28, 2023, FSSY Home Care's plan of closure was filed with the New York State Department of Health and was approved on August 23, 2023. The closure of the Plan Sponsor's Home Care Department and termination of all employees were finalized in April 2024. On September 12, 2024, the board of directors of the Plan Sponsor approved the termination of the Plan. The Plan Sponsor terminated the Plan effective October 31, 2024. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan and ceased new participant notes receivable from the Plan. Participant balances were distributed to participant individual retirement accounts ("IRA") or the participant's current employer's plan. All balances were distributed as of December 12, 2024.

Participant Contributions

Each year, participants may contribute up to 100% of eligible annual compensation, as defined in the Plan, provided that such contributions do not exceed the limitations under the Internal Revenue Code ("IRC") for 2024 of \$23,000, plus a maximum of \$7,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan year. Contributions may be made as a pre-tax deferral or after-tax (Roth) deferral. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

On June 15, 2022, the plan restated the existing plan document and made the following modifications to the plan's employer additional contributions: (1) \$0.20 each hour of service performed during the payroll period beginning January 1, 2022 of an active participant, (2) \$1.08 for each hour of service performed during the payroll period beginning January 1, 2022 of newly hired personnel during any applicable probationary period with the Union (not to exceed 360 hours), and (3) \$0.33 for each hour of service performed during the payroll period beginning January 1, 2022 of personal assistants in the CDPAP. Starting on October 1, 2022, the employer additional contributions changed from \$0.20 to \$1.20 for each hour of service performed of an active participant.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Plan's earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN - CONTINUED

Vesting

Participants are immediately vested in their accounts upon entry date.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance reduced by any outstanding loan balance, whichever is lesser. The loans are secured by the balance in the participant account and bear interest at the commercial lending institution rates, determined at the time of the loan. The interest rate is determined as of the date of origination and is fixed for the loan term. Loans currently outstanding bear interest at rates ranging from 9% to 10.25%. Principal and interest is paid ratably through monthly payroll deductions over a period not to exceed five years, unless the funds are used to acquire a principal residence, in which case the maximum repayment period is determined as of the date of the origination and is at the discretion of the plan administrator. Any outstanding loans must be fully repaid when employment terminates.

Payment of Benefits

On termination of service, disability or death of a participant, the participant or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a defined period.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's statement of net assets available for benefits as of December 31, 2023 is prepared on the accrual basis of accounting.

As a result of the decision to terminate the Plan effective October 31, 2024, and in accordance with U.S. generally accepted accounting principles ("U.S. GAAP"), the Plan's statement of net assets available for benefits as of December 31, 2024 and statement of changes in net assets available for benefits for the year ended December 31, 2024 are presented using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no material changes to the financial statements as a result of the change under the liquidation basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Sponsor or plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. These estimates are based on information available at the time the estimates are made. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Organization and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

3. CERTIFIED INFORMATION (UNAUDITED)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the trustee of the Plan, has certified to the completeness and accuracy of all the investments reflected on the accompanying statement of net assets available for benefits (in liquidation) as of December 31, 2024 and statement of net assets available for benefits as of December 31, 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2024.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan Sponsor determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value.

Common collective trusts: Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS - CONTINUED

The Plan uses NAV as a practical expedient to estimate the fair value of the Plan's investments in common collective trusts amounting to \$447,041 at December 31, 2023. In accordance with FASB ASC 820, these investments that are measured at NAV per share have not been classified in the fair value hierarchy.

Due to the termination of the Plan, there are no investments at December 31, 2024.

^(a) The common collective trust funds are valued at their December 31, 2023 NAV per share as provided by the trustee. The funds' investment objective is stability of principal and high current income.

Gains and losses (realized and unrealized) included in net decrease in net assets available for benefits for the year ended December 31, 2024 is reported in net appreciation in fair value of investments.

5. TAX STATUS

The Plan has adopted a Principal Life Insurance Company Non-standardized Pre-Approved Profit Sharing Plan with CODA (the "Principal Plan"). On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the Principal Plan sponsored by Principal Life Insurance Company and adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust is exempt from taxation.

The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Upon termination, the Plan did not submit an application to the IRS for a determination letter confirming its qualified status as of the termination date. As such, no IRS determination letter was received. The plan administrator believes that such submission was not required under current IRS procedures and guidance.

5. TAX STATUS - CONTINUED

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

6. PARTY IN INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are managed by Principal Life Insurance Company, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Accordingly, these transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees paid by the Plan for administrative expenses, loan expenses and member requested services amounted to \$8,867 for the year ended December 31, 2024.

Certain employees of the Plan Sponsor, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
