#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the New Balance Athletics Employee Savings and Security Plan (the "Plan") provides only general information. Participants should refer to the Plan document and trust agreements for a more complete description of the Plan's provisions.

The Plan is a participant-directed defined contribution plan sponsored by New Balance Athletics, Inc. (the "Company" or "Employer" or "Plan Sponsor") and subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

##### **Eligibility**

Employees who are employed by the Company or one of its subsidiaries on a full-time basis (20 or more hours per week), have attained 20 years of age and have completed 30 days of service are eligible to participate in the Plan. All eligible employees are automatically enrolled in the Plan 30 days after date of hire.

##### **Contributions**

Participants may elect to defer 2% to 50% of their pretax eligible compensation, as defined in the Plan document, subject to annual limitations under the Internal Revenue Code ("IRC"). Participants may elect to have all or any portion of their salary deferral contributions treated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans.

The Company matches 100% of the first 5% of participants' pay contributed to the Plan. In addition, the Company may elect to make a discretionary profit-sharing contribution to the Plan, which did not occur in Plan year 2024. Company discretionary contributions are allocated based on each respective eligible participant's years of service as determined as of the last day of the Plan year.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions, the Company's matching contributions, an allocation of the Company's discretionary contributions (if any), Plan earnings, losses and service credits and charged with an allocation of administrative expenses. Allocations are based on participant's elected allocation percentages, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants direct the investment of their account balance into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. Plan earnings are credited to a participant's account according to the type of funding vehicle in which balances are invested.

##### **Vesting**

Participants are immediately vested in employee contributions, Employer matching contributions, and rollover contributions from other qualified plans, as adjusted for actual earnings or losses thereon. For discretionary Employer profit-sharing contributions, a participant vests at the rate of 20% per year such that a participant is 100% vested after five years of credited service. Employer contributions are fully vested upon death or disability of the participant.

Participants will be credited with a year of service for each Plan year in which the participant has completed at least 1,000 hours of service.

#### ***Forfeitures***

Forfeited amounts, if any, and earnings thereon are available to reduce future Employer contributions and to pay plan expenses. As of December 31, 2024, and 2023, the Plan had unallocated forfeitures of \$1,081 and \$261, respectively. During the year ended December 31, 2024, no forfeitures were used to pay employer contributions or plan expenses.

#### ***Payment of Benefits***

On termination of employment due to death, disability or retirement, the vested portion of a participant's account may be distributed to the participant or beneficiary by transfer to another qualified plan or IRA account or through a lump sum. There are additional provisions for participants who work beyond normal retirement age or who terminate employment prior to reaching normal retirement age. If a participant's account balance is less than \$7,000 but greater than \$1,000 upon termination, a distribution of the participant's account may be made automatically into an IRA. If a participant's account balance is less than \$1,000 upon termination, a distribution of the participant's account may be made automatically in a single-lump-sum cash distribution.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59½. Hardship withdrawals from a participant's deferral contribution accounts are permitted when certain criteria are met. In-service withdrawals of all or a portion of a participant's rollover account may be made at any time.

#### ***Notes Receivable from Participants***

Participants may borrow from their vested fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can only have one loan outstanding at any given time and may elect a repayment term of up to 60 months, with longer terms available when the loan is used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Participant loans receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### ***Administrative Expenses***

Certain administrative expenses related to custody and recordkeeping of the Plan are paid by the Company and others are charged to participants. Loan and other transaction fees are charged to participants. In addition, certain administrative functions are performed by the officers or employees of the Company for which the officer or employee receives no compensation from the Plan nor is the Plan charged by the Company for these services.

#### ***Mutual Fund Fees***

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earning activity and thus are not separately identifiable as a Plan expense.

***Service Credits***

The Plan receives service credits through John Hancock Trust Company from various funds. These credits are recorded by the Plan as investment income. During 2024, the Plan received \$457,065 of service credits.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value and contract value as determined by the Plan's custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan in default, the participant loan balance is reduced and a benefit payment is recorded.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company ("JHTC"), the custodian of the Plan, has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds which are actively traded are valued at quoted market prices on nationally recognized securities exchanges.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Changes in Fair Value Levels***

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no transfers among Levels 1, 2 and 3.

**NOTE 5 - INVESTMENT AT CONTRACT VALUE**

The Plan has a fully benefit-responsive investment contract with New York Life Insurance Company ("NYL") which maintains the contributions in a pooled separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The objective of the contract is to provide a low risk, stable investment offering competitive yields, allowing investors to accumulate current income while preserving principal. The issuer is contractually obligated to repay the principal along with a variable interest rate that is guaranteed by the Plan but may not be less than 0%.

The investment contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

#### **NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions. Certain administrative expenses of the Plan are paid by the Company. The Plan also has notes receivable from participants and receives service credits from the Custodian. Such transactions are permitted under provisions of the Plan and are exempt from the prohibited transaction rules under ERISA.

#### **NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

#### **NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the funds shall be held for distribution by the custodian who shall distribute to the participants the full amount outstanding to their credit.

#### **NOTE 9 - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has since been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the taxing jurisdictions. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. Management is not aware of any other subsequent event which would require recognition or disclosure in the financial statements.
