### Note 1 - Plan Description

The following description of Hikma Pharmaceuticals USA Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that was established on January 1, 2001. The Plan covers substantially all employees of Hikma Pharmaceuticals USA Inc. (the "Company"). The Plan does not cover certain union employees, nonresident aliens, employees of an affiliate that is not a participating employer, leased employees, temporary employees, or interns.

Full-time employees who have completed three months of service are eligible to participate in the Plan on the first day of the month coinciding with or next following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Company is the sponsor of the Plan. The Hikma Pharmaceuticals USA Inc. benefit plans committee is the plan administrator and has responsibility for the administration of the Plan. On August 1, 2024, the Plan changed trustees from Bank of America, N.A. to Fidelity Management Trust Company (Fidelity). Also effective August 1, 2024, Fidelity replaced Merrill Lynch Pierce, Fenner, & Smith Inc. to function as the Plan's recordkeeper and third-party administrator. Various administrative costs, charges, and expenses are paid by the Plan in accordance with the plan agreement.

#### **Contributions**

The Plan provides for employee 401(k) deferral contributions up to a maximum of 95 percent of the participant's annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may designate all or a portion of their deferral contributions as Roth contributions, which are after-tax contributions that are also subject to certain IRC limitations. In addition to pretax and Roth contributions, participants may also make after-tax contributions up to 50 percent of the participant's annual compensation subject to certain IRC limitations.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Employees hired on or after January 1, 2018 are automatically enrolled in the Plan at a 3 percent pretax contribution rate unless they elect otherwise. Effective August 1, 2024, the Plan was amended to increase the automatic enrollment contribution rate to 4 percent.

The Plan provides for employer matching contributions equal to 100 percent of the first 6 percent of a participant's elective deferral contributions. Contributions receivable of \$326,288 and \$595,448 as of December 31, 2024 and 2023, respectively, represent a true-up of employer matching contributions.

The Company may also make an annual discretionary profit-sharing contribution. An employee must have completed 1,000 hours of service within a 12-month period to be eligible for the discretionary profit-sharing contribution. The participant must also be employed on the last day of the plan year to receive an allocation of such contribution. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions and related lost earnings to the Plan during 2024.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participant and rollover contributions are fully vested at all times. Vesting in employer contributions plus actual earnings thereon is based on years of service. Participants become 50 percent vested after two years of service and 100 percent vested after three years of service. In addition, participants become fully vested in all accounts upon retirement at age 65 or in the event of permanent disability or death.

Employer contributions previously received under the provisions of the former West-Ward Pharmaceuticals Corp. Columbus 401(k) Retirement Plan vest according to the following schedule:

Benefit Payments

Upon termination of employment, retirement, death, or disability, the participant (or, in the case of death, the participant's spouse or beneficiary) may receive 100 percent of the value of the participant's vested account balance in a single lump-sum payment or in various installment annuities. Account balances of less than \$5,000 are automatically distributed upon termination. Effective August 1, 2024, the Plan was amended to increase the minimum account balance for automatic cash out to \$7,000. Active participants may also begin taking penalty-free distributions from the Plan upon reaching the age of 59½.

Participants in the former West-Ward Pharmaceuticals Corp. Columbus 401(k) Retirement Plan prior to February 15, 2021 can take partial and annuity withdrawals limited to the account balance that represents their accrued benefit under the former plan as of February 14, 2011.

Participants may request that all or a portion of their vested accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balance totaled \$1,359,975 and \$390,231, respectively.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with prevailing market rates determined by the plan administrator. The notes generally have a term of five years or less. Loans for the purchase of a principal residence can be paid over a reasonable period of time that may exceed five years. Principal and interest are paid ratably through payroll deductions.

#### ***Party-in-interest Transactions***

Merrill Lynch Pierce, Fenner & Smith Inc. was the recordkeeper and third-party administrator of the Plan, and Bank of America, N.A. was the trustee of the Plan through August 1, 2024. Effective August 1, 2024, Fidelity became the trustee, recordkeeper, and third-party administrator of the Plan; therefore, transactions with these entities qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Effective August 1, 2024, the Plan changed its trustee from Bank of America, N.A. to Fidelity Management Trust Company (collectively, the "Trustees"). The Trustees of the Plan held the Plan's investments and participant notes receivable and executed all related transactions during the periods under audit. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements, and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### *Interest-bearing Cash*

The fair value of these investments is based on their outstanding balances.

**Note 4 - Fair Value Measurements (Continued)**

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

***Common/Collective Trusts***

The common/collective trusts are valued at net asset value (NAV) per share or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.
