### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 8G Solutions 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

**1. DESCRIPTION OF THE PLAN**

The following description of the 8G Solutions 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document and Adoption Agreement (the Plan Documents) for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of JPI Glass, LLC (the Company), as defined by the Plan Documents. Ineligible employees include certain part-time employees, leased employees, seasonal/temporary employees, union employees, non-resident aliens, and residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

The Plan is funded through pre-tax and Roth employee elective contributions and Company contributions. A participant may elect to contribute up to 100% of eligible annual compensation, subject to certain limitations imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Plan requires the Company to make safe harbor matching contributions and allows discretionary matching and profit-sharing contributions in amounts determined by the Company. The Company's safe harbor matching contributions are equal to 100% of participants' contributions that do not exceed 6% of eligible compensation, as defined by the Plan Documents. During the year ended December 31, 2024, the safe harbor matching contributions were the only Company contributions.

The Plan was amended effective January 1, 2025, to modify the provision for the Company safe harbor matching contributions to be equal to 100% of participants' contributions that do not exceed 3% of eligible compensation, and 50% of participants' contributions that do not exceed the next 2% of eligible compensation, as defined by the Plan Documents.

Total annual contributions made to the Plan on behalf of any participant are subject to limitations imposed by law.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Company contributions, and an allocation of Plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Documents.

Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions, plus actual earnings thereon. Participants whose entry dates are prior to September 23, 2024, are vested immediately in their Company contributions plus actual earnings thereon. Participants whose entry dates are after September 23, 2024, are subject to a 3-year cliff vesting schedule in all Company contributions other than safe harbor matching contributions.

Notes Receivable from Participants

Participants may borrow against their account balance. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of \$50,000 or 50% of their vested account balance. The maximum number of loans that a participant may have outstanding at any time is one. A participant loan must be payable within a period not exceeding five years, unless the loan is for the purchase of the participant's principal residence, in which case the term may be extended. The loans are secured by the balance in the participant's account and bear fixed interest at the prime rate plus 1%.

Payment of Benefits

Upon normal retirement age, death, or disability, a participant's benefits are payable in an amount equal to the participant's vested account balance. The Plan also allows for rollover withdrawals, hardship withdrawals, in-service withdrawals upon attaining age 59 ½, and other permissible withdrawal options, as defined in the Plan Documents.

Forfeitures

Forfeitures may be used to offset Plan expenses then to reduce Company contributions. During the year ended December 31, 2024, forfeitures of \$2,996 were recognized and \$-0- were used to reduce administrative expenses or reduce Company contributions. At December 31, 2024, and 2023, unapplied forfeitures totaled \$3,487 and \$-0-, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are presented on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by advisors and the trustee/custodian. See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 for discussion of contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold, as well as those held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrators consider the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Documents.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Recent Accounting Pronouncements

During the year ended December 31, 2024, and through October 15, 2024, there were several new accounting pronouncements issued by the Financial Accounting Standards Board (FASB). Each of these pronouncements, as applicable, has been or will be adopted by the Plan. Plan management does not believe the adoption of any of these accounting pronouncements has had or will have a material impact on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through October 15, 2024, which is the date the financial statements were issued.

**3. SUMMARY OF INFORMATION CERTIFIED AND PROVIDED BY TRUSTEES**

The following is a summary of the Plan’s asset information as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedules, that was prepared by, or derived from information provided by, American United Life Insurance Company (AUL) and Empower Trust Company, LLC and Empower Annuity Insurance Company of America (Empower) (collectively, the Trustees) and furnished to the Plan Administrators. The Plan Administrators have obtained certifications from the Trustees that information provided to the Plan Administrators by the Trustees related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrators instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information in Note 4 and the supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year), related to the assets as presented in the table below at December 31:

The Trustees also certified the completeness and accuracy of \$426,703 of net appreciation in fair value of investments, \$33,440 in interest and dividends, and \$11,129 of interest from notes receivable from participants related to the aforementioned Plan assets for the year ended December 31, 2024.

**4. FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1      Valuations based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2      Valuations based on quoted prices in markets that are not active, or financial instruments for which all significant inputs are observable; either directly or indirectly; and
- Level 3      Valuations based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable; thus, reflecting assumptions about the market participants.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024, and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust* – Valued based on the NAV of units of the common/collective trust held by the Plan at year-end. The NAV, as provided by the Trustees, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments composing the trust less its liabilities based upon audited financial statements. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024, and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to their fair value measurement.

**5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company, and certain others. As such, transactions conducted with the custodian, recordkeeper, financial advisor, third-party administrator, auditor, and the Company qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan paid \$1,379 to Empower for recordkeeping services provided to the Plan and \$2,000 was paid to Stratos Wealth Partners for investment advisory services provided to the Plan. The Company pays directly any other fees related to the operation of the Plan.

**6. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a group annuity contract with Empower Annuity Insurance Company of America which invests contributions in the Empower Investments Fixed Account. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent upon the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions, if applicable.

**8. TAX STATUS**

The Plan is a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with Cash or Deferred Arrangement. The IRS has determined and informed the Plan by a letter dated November 14, 2022, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, and the Plan Administrators believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. As such, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

**10. DELINQUENT CONTRIBUTIONS**

As required by ERISA Section 2510.3-102, the Company is required to segregate employee contributions to the Plan from its general assets as soon as practicable following the date in which amounts are withheld from wages. During 2024, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$105,802 within the period prescribed by DOL regulations. The delayed contributions are considered prohibited, or nonexempt, transactions.

**11. ERISA FIDELITY BOND COVERAGE**

The Plan is required to maintain an adequate level of fidelity bond coverage for Plan management who handle Plan funds. The Plan failed to maintain adequate fidelity bond coverage as required by Section 412 of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, for the plan year ended December 31, 2024.

As of January 1, 2025, the Plan met or exceeded the required amount of ERISA fidelity bond coverage based on the value of plan assets as of December 31, 2024.
