## INDEPENDENT AUDITOR'S REPORT

### Opinion

We have audited the financial statements of Lea + Elliott, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Notes to Financial Statements**

**Note 1. Plan Description**

The following description of the Lea + Elliott, Inc.'s (the Company) Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Company established the Plan effective as of January 1, 1994. The Plan was amended and most recently restated effective January 1, 2008, and thereafter was amended by First, Second, Third, Fourth and Fifth Amendments. The Plan is designed to comply with Section 4975 (e) (7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of ERISA. The Plan is administered by a committee made up of Plan management.

**Eligibility**

Employees of the Company who are age 18 or older, have completed 6 months of service and obtained 500 hours by the last day of the Plan year are eligible for an ESOP contribution and can enter the Plan on 1<sup>st</sup> day of the month after eligibility requirements are met.

**Contributions**

For each Plan year, the Company may make contributions to the Plan in such amounts as may be determined by the Board of Directors, to be allocated to eligible participants. Each participant who has been credited with at least 500 hours of service with the Company during the Plan year and who is employed on the last day of such Plan year, shall be entitled to share in the allocation of the Company contributions. A participant shall also share in the allocation of Company contributions for a Plan year if they terminate employment during the Plan year on or after attaining normal retirement age, or due to disability or death, regardless of the hours of service credited to the participant in the Plan year. The Company contribution for the year ended December 31, 2024 was \$450,000. The investment of all contributions is non-participant directed.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of the employer contribution, Plan earnings and forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest 20% per year of service after 2 years and are 100% vested after 6 years of service.

## Notes to Financial Statements

### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions for other separations from service shall begin no later than one year after the end of the fifth Plan year following the Plan year in which benefits become distributable on account of the Participant's termination of employment.

At the discretion of the employer, a participant shall receive distribution of their vested accounts in either 1) a single lump sum of Company stock or cash or 2) substantially equal periodic payments of cash or Company stock over a period not longer than the greater of 5 years or, in the case of an account balance greater than \$500,000, 5 years plus an additional one year for each \$100,000 or fraction thereof by which such balance exceeds \$500,000.

### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may withdraw from the Plan in cash, an amount based on the value up to 25 percent of his or her account. In the sixth year, the participant shall have the right to diversify up to 50 percent of the account balance. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

### Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant.

### Administrative Expenses

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or the Company. The Company has historically paid the operating expenses of the Plan.

### Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

## Notes to Financial Statements

### Forfeited Accounts

Plan forfeitures are allocated to each participant's account based upon the ratio of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants for the year ended December 31, 2024 totaled \$13,005 in cash and 24.72 shares (value of \$3,297) of Company stock. There were no forfeited nonvested account balances as of December 31, 2024 and 2023.

## Note 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The shares of Company common stock are valued at fair value. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on an accrual basis.

### Cash and Interest-Bearing Cash

At December 31, 2024 and 2023, the Plan's interest-bearing cash consisted of a United Bank Insured Cash Sweep account and Truist Money Market account, respectively. As of December 31, 2024 and 2023, interest-bearing cash totaled \$438,611 and 640,241, respectively and is included in investments at fair value on the statement of net assets available for benefits. Generally, accounts are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, cash may exceed federally insured limits; however, all such cash in these accounts is always insured by the FDIC.

At December 31, 2024 and 2023, the Plan's non-interest-bearing cash consisted of a United Bank Business Checking account and a Truist Checking Account, respectively. Generally, accounts are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, cash may exceed federally insured limits; however, all such cash in these accounts is always insured by the FDIC.

## Notes to Financial Statements

### Payment of Benefits

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no benefit claims filed by terminated employees that had not been paid.

### Note 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Valued at cost which approximates fair value.

*Investment in sponsor company common stock:* The fair value of the Company's common stock held by the Plan was determined with the assistance of the independent, third party appraiser.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of different levels.

## Notes to Financial Statements

The Company common stock held by the Plan is reported at fair value based upon an appraisal. This appraisal was based upon a combination of the income and market valuation techniques consistent with prior years as illustrated in the following table. Significant changes to these inputs could result in a significantly higher or lower fair value measurement for the Company common stock.

The valuation process involves management's selection of an independent appraiser on an annual basis, with the ability to cancel at any time. Plan management accumulates the data for the appraiser from the financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with ESOP trustee, reviews in detail, discusses and approves.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### Note 6. Tax Status

The IRS has determined and informed the Plan Sponsor, by a letter dated October 17, 2013, that the Plan is qualified, and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. Plan management believes the Plan and trust are operating in a manner that did not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/ or other such techniques. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

### **Note 8. Related Party and Party-in-Interest Transactions**

The Plan invests in Company common stock. This is a related party transaction. As described in Note 1, the Company pays all Plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

### **Note 9. Subsequent Events**

In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, the date the financial statements were available to be issued.
