### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of East Penn Manufacturing Co. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and May 31, 2024, the related statement of changes in net assets available for benefits for the seven-month period ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### **Note 1 - Description of Plan**

The following description of the East Penn Manufacturing Co. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

#### **General**

The Plan is a defined contribution retirement plan covering substantially all employees of East Penn Manufacturing Co. and subsidiaries (the Company) who meet the service requirements of the Plan. Established in 1965, the Plan provides retirement, death, and disability benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

#### **Contributions**

Each year, participants may contribute any whole percentage (not to exceed 99%) of pre-tax annual compensation as defined in the Plan, up to the maximum allowed by law. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the 401(k) portion of the Plan, unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a mandatory 401(k) matching contribution of 25% of the first 6% of the participants' eligible compensation contributed to the Plan. The Company also makes an annual safe harbor employer contribution equal to 3% of a participant's base salary (as defined). A participant does not have to contribute to the Plan to be eligible for the safe harbor employer contribution. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's matching contribution, as well as allocations of (a) the Company's safe harbor employer contribution, (b) plan earnings, (c) forfeitures of terminated participants' nonvested accounts, and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Effective June 1, 2022, participants are 100% vested in the Company's contributions. Prior to June 1, 2022, the Company's contributions vested at a rate of 20% per year after two years of service, reaching full vesting after six years.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid within five years, unless the loan is for the purpose of buying a principal residence, in which case, the loan may be for up to 15 years. The loans are secured by the balance in the participant's account and bear interest in the current prime lending rate of Principal Financial Group, plus 2% or such other rate as prescribed by the trustees based on periodic re-evaluations of the adequacy of such rate. A participant may have no more than two loans outstanding at one time, and no more than two loans may be applied for in any calendar year. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to retirement, participants will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Normal retirement is at the age of 65. Early retirement is age 55 with completion of 10 or more years of service.

In-service withdrawals are available to participants who have attained age 59 ½. Participants may take a hardship withdrawal from their 401(k) contribution account, if certain criteria is met. Minimum amount is \$1,000.

##### **Death and Disability Benefits**

When an active employee dies prior to actual retirement, or a vested or retired member dies prior to the complete distribution of any benefits, his or her beneficiary shall be entitled to full accumulated benefits in his or her account. In the event an active member becomes permanently disabled, he or she shall thereupon be classified as retired and paid in accordance with normal retirement provisions.

##### **Forfeited Accounts**

At December 31, 2024 and May 31, 2024, forfeited nonvested accounts totaled \$114,179 and \$133,871, respectively. These accounts can be either allocated to participants or used to reduce future Company contributions.

For the seven-month period ended December 31, 2024, \$128,703 was used to reduce Company contributions.

#### **Note 2 - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are shown separately on the Plan's financial statements.

### **Note 3 - Information Certified and Provided by Principal Trust Company**

Certain information in the accompanying financial statements and ERISA-required schedule, related to investments and notes receivable from participants held at December 31, 2024 and May 31, 2024, and net appreciation in fair value of investments, interests and dividends, and interest income on notes receivable from participants for the seven-month period ended December 31, 2024, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Principal Trust Company, the trustee of the Plan.

#### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and May 31, 2024.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interests in the collective trust funds and unitized assets are valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. The collective trust funds are direct filing entities. There are no unfunded commitments or redemption notice periods. Redemption frequency is immediate.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Tax Status

The IRS has determined and informed the Company by a letter, dated January 11, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is exempt from federal and state income taxes under current regulations.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company's contributions.

#### **Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of a collective trust fund managed by Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan for the investment management, asset custody, and recordkeeping services amounted to \$93,370 for the seven-month period ended December 31, 2024.

#### **Note 9 - Subsequent Events**

Plan management has evaluated subsequent events through October 15, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
