Opinion

1. Description of the Plan

The following description of the ManTech Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General: The Plan was established on January 1, 2013 and provides health and other benefits to full-time and part-time regular Service Contract Act ("SCA") employees of ManTech International Corporation (the Corporation) who work an average of 30 or more hours per week and their covered dependents. The assets of the Plan are held in a trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees become eligible the first day of the month following the completion of 30 days of employment.

Benefits: The Plan provides health benefits (medical, vision, dental, and prescription drug), life insurance, short-term and long-term disability benefits, and accidental death and dismemberment benefits.

Insured benefits: The Plan offers one vision program that participants can choose. The Plan fully insures basic life insurance benefits, accidental death and dismemberment benefits, short-term disability benefits, and long-term disability benefits. In addition, a Health Maintenance Organization (HMO) option is available to participants. Premiums are paid from the assets of the trust.

Self-insured benefits: All other medical benefits, dental benefits, and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Corporation utilizes a pharmacy benefit manager (PBM) with respect to the prescription drug benefits provided under the Plan.

Stop loss coverage: The Plan has entered into a stop loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

Notes to Financial Statements

Contributions: Participants contribute specified amounts to the Plan based on applicable monthly premium equivalents established for their respective benefit elections. The Corporation pays the full cost of basic life insurance, accidental death and dismemberment insurance, short-term disability insurance, and long-term disability insurance.

The Corporation makes contributions on behalf of employees in amounts required to satisfy the fringe benefit contribution obligations under the SCA. The Corporation also makes contributions to the Plan as needed to fund premiums and claims in excess of participant contributions.

Participant accounts: A separate Premium Reserve Account is maintained for each participant. The account is credited monthly with the employee and employer contributions for the month and reduced by the premiums paid and administrative expenses incurred on behalf of each participant. Any net contribution in excess of a three month premium reserve is paid to the Corporation's qualified retirement plan on the participant's behalf.

2. Significant accounting policies

Basis of accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

The Plan's benefit obligations as of December 31, 2024 and 2023 and changes in benefit obligations for the year ended December 31, 2024 have been presented on the same statements as the Plan's net assets available for benefits and changes in net assets available for benefits.

Cash and cash equivalents: Cash and cash equivalents consist of highly liquid debt instruments with initial maturities of ninety days or less. The Plan maintains a cash balance at one commercial bank which can exceed the Federal Deposit Insurance Corporation (FDIC) insured deposit limit of \$250,000 per financial institution. At December 31, 2024 and 2023, the Plan's cash balance held at a commercial bank did not exceed the FDIC limit. The Plan has not experienced any losses through the date when the financial statements were available to be issued.

Contributions receivable: Contributions receivable represent amounts due from the participants for premium equivalents or from the Corporation for SCA obligations or other amounts necessary to cover the expenses of the Plan.

Contribution advance: Contribution advance represents amounts paid by the Corporation in excess of amounts due for premiums, premium equivalents and SCA contributions.

Payment of benefits: Claim payments are recorded when paid by the third-party claims processors. Amounts due to the claims processors that have yet to be reimbursed by the Plan are recorded as due to claims administrators in the accompanying Statements of Benefit Obligations and Net Assets Available for Benefits. Amounts paid to claims processors in advance of the processor's payment to providers is recorded as advance to claims administrator in the accompanying Statements of Benefit Obligations and Net Assets Available for Benefits. Premium payments are recorded as expense in the period of insurance coverage.

Stop loss: Premiums for stop loss insurance are included in premium payments in the accompanying Statement of Changes in Benefit Obligations and Net Assets Available for Benefits.

Rebates: Under the agreement with the PBM, the Corporation may receive rebates related to the Plan's utilization pattern of specific drugs. While these rebates are contractually due to the Corporation, the Corporation elects to pass the rebates to the Plan. The Plan recognizes the rebates when received by the Corporation. Pharmacy rebates totaled \$198,910 for 2024, and have been netted with claims paid in the accompanying Statement of Changes in Benefit Obligations and Net Assets Available for Benefits.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: Management has evaluated subsequent events for disclosure in these financial statements through October 13, 2025, which is the date the financial statements were available to be issued.

- 3. Claims incurred but not reported** Plan obligations for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.
- 4. Administrative expenses** The Plan pays administrative expenses that consist primarily of fees paid to third-party claims administrators, as well as other professional service fees to administrative service providers. These payments qualify as exempt party-in-interest transactions.

5. Tax status

The trust received a favorable exemption letter from the Internal Revenue Service on February 10, 2015, under the provisions of Section 501(c) (9) of the Internal Revenue Code (IRC) indicating that the trust is exempt from income taxes.

The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and, therefore believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan termination

Although it has not expressed any intention to do so, the Corporation has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.
