NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the ZT Motors 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General: The Plan is a defined contribution plan covering substantially all full time employees of ZT Motors of Fort Walton, LP, Ron Carter Autoland, LLC and Steve Rayman Chevrolet (collectively referred to as the Company) as defined in the Plan document. On May 14, 2024, the Plan was amended to allow ZT Automotive of Florence One, LLC, ZT Automotive of Florence Three, LLC, ZT Automotive of Florence Four, LLC, and ZT Automotive of Florence Six, LLC employees to be immediately eligible to participate in the Plan. The eligible employees' prior service will count for vesting and eligibility.

Employees become eligible to participate in the Plan upon attaining age 21 and completing 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The effective date of the Plan was January 1, 2015 and was amended and restated on January 1, 2021.

Contributions: Participants are permitted to contribute up to 100% of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. The total deferrals in any taxable year may not exceed a dollar limit that is set by law. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

In addition, the Company may make matching contributions to the Plan on behalf of all participants who have completed at least 1 year of employment, with at least 1,000 hours of eligible service, as defined in the Plan document in an amount to be determined by the Company each year.

Participant Accounts: Each participant's account is credited with the participant's voluntary contribution, the Company's matching contribution, Plan earnings, and charged with an allocation of administrative expenses, if applicable, which are allocated proportionately among all participants based on their investment in each fund.

Retirement, Death or Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Investment Options: Participants may change their investment options at any time and may direct contributions among various investment options.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service in accordance with the following:

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or receive annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Notes Receivable from Participants: A participant may borrow from the Plan an aggregate amount not to exceed the lesser of: (a) \$50,000 less the highest outstanding balance of loans in the past 12 months or (b) 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the plan administrator. All loans are covered by demand notes and are repayable through payroll deductions.

Forfeitures: Forfeitures are first used to cover the administrative expenses of the Plan. Any remaining forfeitures are added to any Company discretionary contributions; however, any remaining forfeitures attributable to matching contributions are used to reduce the Company's matching contributions. During 2024, the Company utilized approximately \$114,000 to offset Company matching contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (VOYA).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. Transfers between hierarchy measurement levels are recognized by the Plan as of the end of the reporting period.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Pooled Separate Accounts: The fair values of participation units held in pooled separate account sub-accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account sub-account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Investment Contract: The Plan holds an investment contract that is not fully benefit-responsive due to certain restrictions on participant-directed investment exchanges and fair value adjustments for lump-sum contract withdrawals pursuant to the terms of the contract, and accordingly is measured at fair value. The fair value of the Plan's investment contract has been determined to approximate contract value as the terms of the contract prohibits transfer or assignment of rights under the contract and provides for all distributions at contract value, frequent resetting of contractual interest rates based upon market conditions and no defined maturities (Level 2 inputs). In addition, management has determined that no adjustment from contract value is required for credit quality considerations. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Notes receivable from participants are party-in-interest transactions of the Plan. The Plan's payment of service provider fees, record-keeping fees and investment management fees qualify as party-in-interest transactions. Transactions during the year ended December 31, 2024 with parties-in-interest included fees paid to VOYA. Additionally, the Plan holds units of pooled separate account with sub-accounts managed by VOYA and an unallocated investment contract with VOYA. Therefore, these transactions and the Plan's payment of administrative expenses to VOYA qualify as party-in-interest transactions. United Benefit Pensions Inc. was the Plan's recordkeeper and Stifel Nicolaus & Company provided advisory services to the Plan for the year ending December 31, 2024, therefore, these qualify as parties-in-interest. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

NOTE 6 - TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE 6 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

Subsequent to December 31, 2024, the Plan Sponsor identified participant contributions that were not remitted to the ZT Motors 401(k) Plan within the time frame required by Department of Labor regulations. The Plan Sponsor intends to correct this matter outside of the Department of Labor's Voluntary Fiduciary Correction Program (VFCP). As of December 31, 2024, the total uncorrected delinquent contributions and lost earnings totaled \$202,735 and \$1,940, respectively. Plan management corrected the missed contributions plus earnings in October 2025.
