Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of InterImage, Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about InterImage, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules of assets (held at end of year) and delinquent participant contributions (supplemental schedules) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or

is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the InterImage, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants and interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. General - The Plan became effective January 1, 1998, and is a defined contribution plan covering substantially all employees of InterImage, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In 2021, the Company acquired 100% interest in Amches, Inc. In February 2022, the Company merged the Amches, Inc. retirement plan, including all plan assets and liabilities, into the InterImage, Inc. 401(k) Profit Sharing Plan, with all participants becoming participants in the Plan.
- b. Contributions - Participants may make voluntary contributions to the Plan. The amount that may be contributed is limited by the Internal Revenue Code applicable to the type of plan. Upon becoming eligible, employees are automatically enrolled with a salary deferral of 3%, unless they affirmatively elect not to participate, and that amount increases by 1% each subsequent plan year, up to 10%, unless the participant elects an alternative salary deferral.

The Company matches a percentage of the participant's contributions based on employment division. The standard matching calculation is 100% of each participant's contribution up to 1% of the participant's wages and then 25% of the next 4% of the participant's wages. For the business intelligence unit, the matching calculation is 100% of each participant's contribution up to 7% of the participant's wages. The Company may also make a discretionary contribution. During the year ended December 31, 2024, the Company did not make a discretionary contribution. Investments of contributions are participant-directed.

Forfeitures from the accounts of participants who have terminated employment are used to offset employer contributions. During the year ended December 31, 2024, matching contributions were reduced by \$33,579, from nonvested accounts. The amount of unused forfeitures available to offset future contributions totaled \$3,929 and \$5 at December 31, 2024 and 2023, respectively.

- c. Participant Accounts - Each participant's account is credited with the participant's contribution, the Companies match of that contribution, and an allocation of (a) the Companies discretionary contributions, if any, and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

- d. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting on the remainder of their account is based on years of service with a minimum of 1,000 hours of service a year. Participants, however, are fully vested upon employment post-retirement age, death, disability, or plan termination as defined in the Plan document. Vesting provisions vary based on the funding sources as outlined below:

- d. Investment Options - Upon enrollment in the Plan, a participant may direct the investment of contributions in any of the available investment options. Participants may change their investment options on a daily basis. At December 31, 2024 and 2023, and these investment options include mutual funds, common/collective trusts, and a self-directed brokerage account.
- e. Payment of Benefits - Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of their vested account balance, or installments over the participant's life expectancy or joint life expectancy of the participant and designated beneficiary, if the vested account balance is greater than \$5,000.
- f. Participant Notes Receivable - Participants may elect to borrow from their participant accounts the lesser of 50% of the vested account balance or \$50,000, reduced by any outstanding loan balance, with a minimum loan of \$1,000. Loan terms generally range from one to five years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through biweekly payroll deductions.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any unpaid interest. Interest income is recorded on the accrual basis. Proceeds of loans provided to participants are net of processing fees charged by the plan administrator. Such fees are the responsibility of individual participants and not the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value, including the common/collective trusts, which hold indirect investments in fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investment related expenses (fund expenses) are included in net appreciation (depreciation) of fair value of investments.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available for issue. The accompanying financial statements recognize the effects of subsequent events that provided evidence about conditions that existed on the statement of net assets available for benefits date, including the estimates inherent in the process of preparing financial statements. The accompanying financial statements do not recognize the effect of subsequent events that did not exist at the statement of net assets available for benefits date, but disclosures of such events, if any, are included in the accompanying notes.

3. Fair Value Measurements

Financial reporting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable, typically with little, if any, market activity.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in *mutual funds* are valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Investments in *common/collective trusts* are valued at NAV per unit, as determined by the trustee at year end. The NAV is used as the practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported as of the end of the reporting period. For the year ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2 or 3.

4. Investment in Common/Collective Trusts

The Plan holds investments in Fisher Investments All World Equity Fund and Fisher Investments U.S. Fixed Income Fund. Both funds were formed under Fisher Asset Management, LLC. The funds invest in various types of investments such as common and preferred stocks, futures contracts, government issues, and collective trust funds. Issuers seek to preserve the principal investment and earnings but cannot guarantee they will be able to do so. The funds are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There are no reserves against contract values for credit risk of the contract issuers or otherwise. There are no unfunded commitments. 5. Investments

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, any remaining non-vested account balances will become vested as of the date of the plan termination.

7. Tax Status

The IRS has informed the Plan sponsor by a letter dated November 14, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not obtained a separate determination letter from the IRS. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by federal or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Plan Expenses

Any fees related to the administration of the Plan or associated with the investment of Plan assets may be paid by the Plan or by the Company. The Company has elected to allow the Plan to use forfeitures to pay administrative expenses such as recordkeeping, custodian and audit fees. However, if there are insufficient forfeitures to cover such fees, the Company will absorb the differential and such amounts will not be reflected on the Plan's financial statements.

9. Related Party Transactions

Certain Plan investments are shares of mutual funds managed by various fund companies. Fees incurred by the plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The plan made direct payments of \$84,968 in December 31, 2024, to the third party administrator, which was not covered by revenue sharing.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is likely that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
