## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Parasol Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of August 26, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to August 26, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Parasol Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 26, 2024 and December 31, 2023, and for the period from January 1, 2024 to August 26, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Parasol Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Parasol Group 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## Notes to the Financial Statements

---

### 1. DESCRIPTION OF PLAN

The following description of Parasol Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **Affiliated Employers**

The Plan is sponsored by multiple employers with Parasol Group LLC being the lead sponsor. Employers participating in the Plan include:

- Parasol Group LLC (parent of controlled group)
- Vox Nutrition, Inc.
- Next Energy Alliance LLC
- Quality Supplemental Manufacturing Inc.
- Kaya Naturals, LLC
- Herbal Extracts
- Ship Central
- On Demand Fulfillment LLC

These are referred to as an inclusive group in the financial statements as Parasol Group.

#### **General**

The Plan is a defined contribution plan covering eligible employees of the entities who have completed 240 hours of service in a 3-month period, provided that they are an eligible employee at the end of that period. If the employee does not complete 240 hours of service in a 3-month period, measured from their hire date, they may still become eligible to participate in the Plan if they complete 240 Hours of Service in a 3-month period during the next successive 3-month period, up until they have worked a full year. They will become eligible to participate in the Plan if they complete one year of eligibility service, provided that they are an eligible employee at the end of that period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute up to 100 percent of pre-tax or post-tax (Roth) annual compensation, as defined in the Plan. Participants who have attained age 55 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans who has met the service requirements. The total deferrals in any calendar year may not exceed a maximum amount that is set by law. Parasol Group matches employees' contributions up to 4% of total compensation (Safe Harbor matching requirements). Additional amounts may be contributed at the option of Parasol Group's Directors. Contributions are subject to certain limitations.

#### **Participant Accounts**

Participant accounts are maintained by American Funds Retirement Planning Center, a division of Capital Bank and Trust Company. Each participant's account is credited with the participant's contribution and allocations of (a) the Parasol Group's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses and Plan losses. Each participant directs how his or her account balance will be invested among the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the entity's matching and discretionary contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service (100% vesting upon contribution for Safe Harbor contributions).

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic payments at times and amounts requested by the participant or beneficiary. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 1/2. At August 26, 2024, Plan assets due to persons who have terminated was \$-0- (\$728,792 at December 31, 2023) of which none will be forfeited. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**Forfeited Accounts**

At August 26, 2024, there were no employer funds that would be forfeited due to all funds being contributed under the Safe Harbor provisions. In the event the Plan has employer funds that are not subject to these provisions, forfeitures will be used to pay reasonable plan expenses first. The remaining forfeited accounts are used to reduce the employer match and then employer nonelective contributions.

**Expenses of the Plan**

The administrative expenses of the Plan are allocated to participant accounts as a decrease in investment earnings.

**Participants Loans**

Participants may borrow from their accounts. Participant loans must be a minimum of \$1,000, and cannot exceed \$50,000 or 50 percent of the participants' vested balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate. Principal and interest is paid ratably through monthly payroll deductions. Past due accounts are deemed delinquent and are reported as distributions to the employee.

**2. ACCOUNTING POLICIES****Date of Management's Review**

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

**Method of Accounting**

The accompanying financial statements are stated on the accrual basis, and accordingly, include all material assets and liabilities of the Plan. Financial statement presentation generally follows the recommendations of the AICPA Industry Guide, "Audits of Employee Benefit Plans."

**Cash and Cash Equivalents**

Cash and cash equivalents consist of money market fund investing in a variety of short-term, high-quality debt securities. The potential for low risk and safety are important features of this fund. Investments include obligations of highly rated banks, including certificates of deposit, U.S. Treasury notes and bills, agency issues, and top-rated commercial paper.

**Income Taxes**

No amounts have been paid or accrued on the financial statements for income taxes. As of August 26, 2024, the Company's tax years for 2021, 2022, 2023, and 2024 are subject to examination by the tax authorities.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities, at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Investments in mutual funds are stated at fair value based upon quoted market prices.

Net appreciation (depreciation) of investments includes realized and unrealized gains or losses on investments and is recognized in income currently. Amounts invested may earn interest and dividends, which in turn are reinvested. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid.

**3. PLAN TERMINATION AND CONVERSION TO A POOLED EMPLOYER PLAN**

Parasol Group has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

During May 2024, the lead Plan sponsor on behalf of all participating employers elected to become a participating employer in a certain pooled plan provider pursuant to a joinder agreement, effective September 1, 2024. The participating employer's existing plan merged into the new plan, effective September 1, 2024 and the new adoption agreement was formed. Certain provisions of the Plan were modified, including participation vesting, plan eligibility requirements, and plan entrance dates. Participants should refer to the updated Plan agreement for a more complete description of the Plan's provisions. Effective August 26, 2024, all plan assets were transferred to the new recordkeeper and trustee and individual accounts were formed for each participant based on their individual plan assets as were valued on August 26, 2024.

**4. INFORMATION PREPARED AND CERTIFIED BY INSTITUTION**

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by Capital Bank and Trust Company, the Trustee, which included total investments as of August 26, 2024 and December 31, 2023, the total investment income for the period from January 1, 2024 to August 26, 2024 as noted in the following table:

## **5. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **6. TAX STATUS**

The Plan uses a prototype plan document sponsored by CCH incorporated DBA ftwilliam.com. The prototype plan document received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the Internal Revenue Service. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan Administrator has analyzed the tax positions of the Plan and has concluded that as of August 26, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits in tax jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax periods in progress.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Capital Bank and Trust Company, who is the trustee of the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$13,034 for the period from January 1, 2024 to August 26, 2024 (\$13,337 in 2023).

## **8. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 26, 2024.

*Mutual funds, fixed income funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
