NOTE 1 - DESCRIPTION OF PLAN

The following description of the Georgia Banking Company Section 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Georgia Banking Company Section 401(k) Profit Sharing Plan is a defined contribution plan covering substantially all employees of Georgia Banking Company (the "Company" or "Employer") except those who are non-resident aliens as defined by the Plan. The Plan provides eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan upon beginning employment with the Company. Employees may elect to participate in the Plan on the first day of the month following the date that the eligibility requirements were met.

Contributions

Each year, participants may contribute up to the maximum amount of the participant's qualified compensation, as defined by the Plan, subject to an annual dollar limit which is set by law. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants are also permitted to make Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and an insurance investment account as options for participants.

Effective January 15, 2022, all new employees are automatically enrolled into the Plan with 5% of compensation deferred. As of the beginning of each subsequent Plan year, the automatic deferral amount will increase by 1% of compensation up to a maximum of 10% of compensation. Prior to January 15, 2022, employees were automatically enrolled in the Plan with 6% of compensation deferred. Employees have the option to elect out of the automatic enrollment by notifying the Company.

The Plan is a safe harbor plan where the employer makes a safe harbor matching contribution equal to 100% of an eligible employee's salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. Safe harbor contributions are calculated each pay period.

Additionally, the Company may make discretionary matching contributions equal to a discretionary percentage, to be determined by the Company, of the participant's elective deferrals. The Company may also make an annual discretionary profit sharing contribution. Catch-up contributions will be taken into account in applying any matching contribution under the Plan.

Plan Amendments

Effective January 15, 2024, the Plan was amended to change the participation entry date for all contribution types to the first day of the month coinciding with or next following the date the requirements are met.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, any Company discretionary contributions, and allocation of Plan earnings (losses) reduced by administrative expenses which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in deferral contributions plus actual earnings thereon and safe harbor matching contributions. Vesting in the Company's contributions, qualified non-elective contribution (QNEC), and Company discretionary matching contributions is based on Plan years of service. A participant is 100% vested upon normal retirement, employment termination due to death or termination as a result of becoming disabled. A participant is 100% vested after four graded years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to 50% of their vested account balance or \$50,000. Participants are permitted to have two loans outstanding. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, which is fixed on the date of the loan. Generally the term of a participant's loan may not exceed five years. Principal and interest is paid ratably through semi-monthly automated clearing house or electronic funds transfer deductions.

Payment of Benefits

Benefits equal to the value of the funds allocated to a participant's vested balance in the account will be paid upon the participant's death, disability, retirement, or termination of employment in either a lump sum amount or in annual installments. The non-vested portion will be forfeited, unless the employee returns to service with the employer before incurring five consecutive breaks in service, in which case the account balance will be restored unadjusted for any gains or losses. In-service distributions may be made to a participant who has not separated from the Company and has reached the normal retirement age.

Forfeitures

The Plan allows for a specific schedule of vesting in discretionary contributions. Amounts of discretionary contributions that are not considered vested by a participant can be forfeited due to the termination of the participant. The Plan's sponsor has elected to apply forfeitures to administrative expenses and against discretionary contributions. There were no forfeited nonvested accounts as of December 31, 2024 and 2023. Forfeitures used to reduce Company contributions totaled \$0 for the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for those for which fair value is measured using the net asset value (NAV) per share practical expedient or any fully benefit-responsive investment contract, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make scheduled payments and the Plan Administrator deems the participant to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820, Fair Value Measurements, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan measures the fair value of certain investments that do not have a readily determinable fair value using the NAV per share (or its equivalent) as a practical expedient. The NAV of these investments is based on the fair value of the underlying assets, as reported by the custodian of the plan. The use of this practical expedient is based on the Plan's ability to transact at NAV on the measurement date.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

As of December 31, 2024, pooled separate accounts were valued by using the net asset value (NAV) of the funds held by the Plan at year-end as a practical expedient. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. As of December 31, 2023, these investments were traded and valued daily using their NAV at level 2.

In 2022, Minnesota Life Insurance Company ("Minnesota Life") and Standard Insurance Company ("The Standard") entered into a Reinsurance Agreement and other related agreements that transferred administrative, payment, and investment responsibilities with respect to certain insurance contracts from Minnesota Life to The Standard, on a coinsurance basis in the case of general account liabilities and on a modified coinsurance basis in the case of separate account liabilities. Pursuant to the agreements, The Standard is responsible for all administrative services, including the preparation and certification of the plan's annual reporting on behalf of Minnesota Life. Because Minnesota Life remains the issuer and retains liability for the insurance contracts that are reinsured and administered by The Standard, the Plan maintains a benefit-responsive investment contract with Minnesota Life.

Minnesota Life maintains the contributions in a general account which supports insurance and annuity obligations. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average yield and crediting interest rate was approximately 2.01% for the year ended December 31, 2024. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the Plan’s ability to transact at contract value with Minnesota Life. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (d) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. The Plan Administrator does not believe any events that would limit the Plan’s ability to transact at contract value with the Plan participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 - TAX STATUS

The Plan Sponsor has adopted a pre-approved non-standardized profit-sharing plan with a cash or deferral arrangement (“pre-approved plan”) that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the IRC, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

NOTE 5 - TAX STATUS (CONTINUED)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTIES IN INTEREST TRANSACTIONS AND RELATED PARTY EXPENSES

Certain Plan investments are pooled separate accounts and a guaranteed investment contract managed by The Standard Insurance Company and Minnesota Life Insurance Company for the years ended December 31, 2024 and 2023. The Standard Insurance Company is the custodian as defined by the Plan for the period January 19th, 2024 through December 31, 2024. Minnesota Life Insurance Company is the custodian as defined by the Plan for the year ended December 31, 2023 through January 18th, 2024. Minnesota Life Insurance Company is the issuer for insurance contracts in the Plan for years ended December 31, 2024 and 2023 and therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rule under ERISA. Notes receivable from participants are also defined by ERISA as party-in-interest transactions.

NOTE 7 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company for the period January 19th through December 31, 2024 and Minnesota Life Insurance Company (the Custodians of the Plan) for the period January 1, 2024 through January 18th, 2024 and for the year ended December 31, 2023. This information has not been audited by the Plan's independent auditors.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 11– OPERATIONAL ERRORS AND PROHIBITED TRANSACTIONS

For the plan years ended December 31, 2024 and 2023, there were operational errors with the Plan where there was an improper use of the definition of compensation. Certain other compensation was being excluded from Plan compensation when it should have been included based on the Plan Document in effect for 2023 and 2024. This resulted in missed contributions and lost earnings for both years for participants. A corrective Qualified Nonelective Contribution (QNEC) calculation of \$15,042 for the missed contributions and lost earnings was funded on September 30, 2025 to correct the amounts. Plan management also amended the Plan subsequent to year end to exclude this compensation going forward. See Note 12 for further detail.

During the 2024 plan year, there were also three payroll dates where participant contributions were not remitted timely in accordance with Department of Labor guidelines. These are reported on the Supplemental Schedule H, line 4a – Schedule of Delinquent Participant Contributions. Management is working with the TPA to calculate the lost earnings and fund the corrective amount.

NOTE 12 - SUBSEQUENT EVENTS

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

The Securing a Strong Retirement Act of 2022 (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2025 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.

Subsequent to year-end, the Plan Document was amended, effective January 1, 2025, to exclude certain other compensation from the definition of compensation for deferral purposes. This compensation was previously included and then erroneously excluded in 2023 and 2024.

Subsequent to year-end on March 1, 2025, the Plan Sponsor acquired new employees as a part of an acquisition arrangement. The Plan Document was amended to include those employees hired in conjunction with the acquisition for eligibility, vesting, and contribution allocation purposes.

Subsequent to year end on September 30, 2025, a QNEC contribution of \$15,042 was funded to the Plan for correct for the errors noted in Note 11.

No other events have occurred that would require adjustment to or disclosure in the financial statements which were available to be issued on October 10, 2025.
