Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Schuster Enterprises, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

NOTE 1: Description of the Plan

The following brief description of the Schuster Enterprises, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General - The Plan is a prototype defined contribution plan sponsored by Schuster Enterprises, Inc. (the “Plan Sponsor”) for its employees and is subject to and in conformity with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was originally adopted on October 1, 1979 and has been amended and restated from time to time since that date with the most recent restatement effective January 1, 2022 where the Plan was updated to recognize all prior Plan amendments.

The Administrative Committee, designated by the Plan Sponsor, has responsibility for the administration of the Plan. Empower Trust Company (“Empower”), acts as the Plan's recordkeeper and custodian/ trustee. Empower, as a qualified institution, has responsibility for the management, operation and administration of the Trust Fund. A fee is charged for trustee, custodial and recordkeeping services.

Eligibility - Employees can enter the Plan immediately following or coinciding with the attainment of age 18 and the completion of 1,000 hours of service during the 12-month period following the date of hire. Beginning January 1, 2024 under the provisions of the Setting Every American Up for Retirement Enhancement (SECURE) Act, part time employees who completed at least 500 hours of service in each of the three previous calendar years were eligible to participate in the Plan.

Contributions - Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan, subject to limitations set by the Internal Revenue Code (“IRC”). Participants may elect to make after tax Roth contributions in lieu of all or a portion of their eligible pre-tax contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan Sponsor made a safe harbor matching contribution equal to 100% of the participants’ elective deferrals up to 3% of compensation plus 50% of the participants’ elective deferrals between 3% and 5% of compensation. The Plan Sponsor may also make a discretionary contribution subject to certain limitations. There were no discretionary contributions for 2024 or 2023.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Plan Sponsor's safe harbor contributions, and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions and the Plan Sponsor's safe harbor matching contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary contribution plus actual earnings thereon is based on years of continuous service, summarized as follows:

Unallocated accounts - Unallocated accounts consist of an ERISA revenue sharing account and forfeitures. The ERISA revenue sharing account represents payments to the Plan by investments in accordance with applicable service agreements. Forfeitures represent the non-vested portion of a participant's account balance that is forfeited upon termination. These accounts are used to reduce the Plan Sponsor's contributions and pay Plan expenses according to the Plan specifications. These holding accounts had balances of approximately \$9,000 and \$11,000 as of December 31, 2024 and 2023, respectively. Amounts used to pay Plan administrative expenses totaled approximately \$25,000 and \$24,000 for the years ended December 31, 2024 and 2023, respectively.

Investment Options - A participant may direct contributions in one percent increments in any of the investment options offered by the Plan, as chosen by the Administrative Committee. Participants may change their investment options daily.

In addition, participants have the option of self-directing contributions to a wider range of investment options outside of the investment options established by the Plan Sponsor, including mutual funds, publicly traded stocks and bonds, and limited partnerships for an annual fee. Transactions are accounted for through personal brokerage investment accounts.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 - 5 years or up to 20 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate equal to the prime rate plus 1.00% (8.50% and 9.50% at December 31, 2024 and 2023, respectively). Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.

Payment of Benefits - Upon a participant's termination of employment, disability, retirement, death, or reaching age 65, such participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested balance in his or her account, rollover a portion of the distribution directly into an eligible retirement plan, or receive monthly or annual installments over a specified period of time as defined in the Plan. Vested account balances less than \$5,000 are subject to automatic distribution in accordance with the Plan document. Participants may also receive distributions of benefits from their account if certain requirements are met in order to take a hardship distribution. The Plan also allows for in-service withdrawals of a participant's vested interest upon reaching the age of 59 ½.

Plan Termination - Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts and the trustee shall dispose of the Plan assets by distribution to participants and their beneficiaries.

NOTE 2: Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of Investments - The Plan's investments are stated at fair value, except for fully benefit-responsive contracts which are stated at contract value, as described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date. See Note 3 for discussion of fair value measurements.

Net appreciation or depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Tax Status - The Plan received a favorable determination letter dated April 29, 2014 from the Internal Revenue Service (“IRS”) which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America (“GAAP”) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods; however, there are currently no audits for any tax periods in progress.

Benefit Payments - Benefits are recorded when paid.

Plan Expenses - Significant costs of administering the Plan are absorbed by the Plan Sponsor and are not reflected in these financial statements. These costs include legal, administrative, accounting and trustee fees. Certain investment management fees and administrative expenses are incurred and paid by the Plan. Other investment related expenses are included in net appreciation of fair value of investments.

Reclassifications - Certain items in the 2023 financial statements have been reclassified in order to be in conformity with the 2024 statement presentation.

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events - The Plan's Administrative Committee has evaluated all subsequent events that may qualify for disclosure through October 13, 2025, which is the date the financial statements were available to be issued. There were no transactions that are required to be disclosed under professional guidance.

NOTE 3: Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Valued at net asset value of shares held by the Plan at year end.

Common and preferred stocks & exchange-traded funds: Valued at quoted market prices at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: Fully Benefit-Responsive Investment Contracts

The Plan holds an investment in the Empower Guaranteed Income Fund (“GIF”). The GIF is a guaranteed separate account provided under a group annuity contract and is deemed to be fully benefit-responsive. As such, contract value is the relevant measurement attribute for benefits attributable to the GIF because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The GIF is the sole investment presented at contract value on the face of the Statements of Net Assets Available for Benefits.

Contract value represents contributions made to the fund, plus earnings at guaranteed crediting rates less participant withdrawals and administrative fees, and is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Generally there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the Plan Sponsor to settle at an amount different than contract value paid either within 90 days or over time.

Empower bears the risk that the return on the underlying investments will be sufficient to support the guaranteed rate during each guarantee period.
