### **Opinion**

We have audited the accompanying financial statements of Horizon Communications, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### Note 1 – Description of Plan

The following description of the Horizon Communications, Inc. (the Sponsor) Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of the Sponsor who have attained the age of twenty-one, have completed one year of service and worked a minimum of 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan holds common shares of the Sponsor in a trust established under the Plan.

#### Contributions

The Plan is a defined contribution plan under which a separate individual account is established for each participant. The Sponsor may make contributions to the Plan in an amount determined at its sole discretion. Generally, contributions are made in the form of cash or stock. If the Sponsor makes a contribution in the form of cash, the Trustee generally will use the cash to purchase the Sponsor's stock or other assets as determined by the Trustee. Contributions are subject to certain limitations. The Plan does not allow participant contributions. Each year, the Sponsor may make contributions of cash or other property at the option of the Sponsor's board of directors.

#### Participant Accounts

Each participant's account is credited with allocations of (a) the Sponsor's contributions and, (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

A participant vests in the Sponsor's contribution portion of the participant's account plus earnings thereon based on years of continuous service. The participants vest in accordance with the following schedule:

Less than two years	0%
At least two years	20%
At least three years	40%
At least four years	60%
At least five years	80%
At least six years	100%

Credited years are Plan years commencing with the year of hire and ending with retirement year excluding years with less than 1,000 hours.

## **Notes to Financial Statements**

### **Forfeited Accounts**

Forfeited balances are allocated to participants in the same manner as sponsor contributions. Forfeitures totaling \$0 and \$17,375 were allocated to participant accounts during the years ended December 31, 2024 and 2023, respectively.

### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Payments are based on the participant's account balance as of the December 31, fiscal year end. For termination of service due to other reasons, a participant's stock portion account balance is converted over to cash investments, where it remains until the payment occurs.

### **Administrative Expenses**

Significant administrative expenses of the Plan related to the third-party administrator are paid by the Trust.

### **Put Option**

The employer stock that is held by the Plan is not readily tradable on an established market. Under federal income tax regulations, the employer stock includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Sponsor's common stock into investments which are more diversified.

Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post - 1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. Participants eligible to diversify make their election after year-end based on the number of shares of the Sponsor's stock held in their account at year end.

## **Note 2 – Summary of Significant Accounting Policies**

### **Plan Adoption**

The Plan was adopted on September 16, 2006 and amended on January 1, 2011 and January 1, 2016. On December 19, 2019 the Plan began operating, in relevant part, as a leveraged employee stock ownership plan as a result of entering into a loan agreement with the Sponsor in order to repurchase shares of stock as discussed in Note 7.

## **Notes to Financial Statements**

### **Accounting Principles**

The Plan's accounting policies conform to accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Concentrations of Credit Risk**

The Plan maintains its cash balances at a financial institution. At times such investments may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash.

### **Investment Valuation**

Investments are reported at fair value. Fair value is defined as the amount that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The following hierarchy prioritizes the inputs to valuation methodologies used to measure fair value:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

The fair value of the Sponsor's common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal is based upon an income valuation technique consistent with prior years. The appraiser took into account historical and projected cash flows and net income, return on assets, return on equity, market comparable and estimated fair value of the Sponsor's assets and liabilities.

### **Benefit Payments**

Benefit payments are recognized when paid.

### **Subsequent Events**

The Plan Administrator has evaluated subsequent events through October 15, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

### Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### Note 5 – Income Tax Status

The Internal Revenue Service has determined and informed the Sponsor by a letter dated January 26, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

### Note 6 – Risks and Uncertainties

The Plan invests in the Sponsor's common stock. This investment is exposed to various risks. Due to the level of risk associated with this investment, it is at least reasonably possible that changes in the value of the Sponsor's common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 7 – Related Party Loan Payable

In December 2019, the Plan entered into a \$2,256,644 term loan agreement with the Sponsor. The proceeds of the loan were used to purchase 112,215 shares of the Sponsor’s common stock. Unallocated shares are collateral for the loan. The agreement provides for the loan to be repaid in annual payments of \$521,228 of principal and interest at 5.0% over 5 years. The loan was paid in full as of December 31, 2024.

### Note 8 – Party-in-Interest Transactions

The Plan's main investment is in the Sponsor's common stock administered by Blue Ridge ESOP Associates, the third party administrator of the Plan. The fees associated with these services as well as fees for valuation and other administrative services qualify as party-in-interest transactions. Fees paid amounted to \$63,503 for the year ended December 31, 2024. The above party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.
