Note 1. Description of the Plan

The following description of Crestline Hotels & Resorts, LLC Retirement and Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Crestline Hotels & Resorts, LLC (Company) for the benefit of its employees. Employees who are at least 18 years of age and not covered by a collective bargaining agreement are eligible to participate in the Plan after one month of service. Participants are also eligible to qualify for matching contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company serves as plan trustee.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 85% of eligible compensation. Employee rollover contributions are also permitted by the Plan. Participants who have attained age 50 before the end of a plan year are eligible to make catch-up contributions. Through July 31, 2023, the Company made discretionary matching contributions equal to 75% of participants' deferrals to the Plan, including employee catch-up contributions, up to a maximum of 4% of compensation. Effective August 1, 2023, the Plan was restated, and the Company makes non-discretionary matching contributions equal to 75% of participants' deferrals to the Plan, including employee catch-up contributions, up to a maximum of 4% of compensation. The Company may make discretionary nonelective contributions for participants who are employed on the last day of the plan year.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing the contributions to their account into any of the separate investment accounts and may change the allocation daily or they may individually direct their investments as they choose within a self-directed account.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contributions plus earnings thereon is based on a five-year graded vesting schedule. A participant automatically becomes 100% vested, regardless of the years of service, upon the attainment of normal retirement age, death, total disability, or termination of the Plan.

Payment of Benefits

If a participant ceases to be an employee of the Company and his account balance is less than \$1,000, the entire vested account balance will be payable to the participant or his beneficiaries in a single lump-sum payment. Balances greater than \$1,000 but less than \$7,000 as of January 1, 2024 and \$5,000 prior to January 1, 2024, are to be rolled over to an individual retirement account as designated by the Plan, absent an election by the participant. Participant balances in excess of \$7,000 as of January 1, 2024 and \$5,000 prior to January 1, 2024, can remain in the Plan until such time the participant elects to receive a distribution. A participant may elect to receive a lump-sum amount or installment payments equal to the vested value of their account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

In March 2020, the Company implemented *Coronavirus Aid, Relief, and Economic Security Act* (CARES Act) provisions for coronavirus-related distributions (CRD). Through December 30, 2020, qualified participants were permitted to take a CRD of up to \$100,000 from the Plan. Participants who took a CRD had the option to have the distribution taxed over a three-year period, with the ability to recontribute up to the full amount of the distribution within three years and not be subject to federal income tax as a result.

Forfeited Accounts

Forfeited nonvested accounts totaled \$366,404 and \$427,847 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. In 2024 and 2023, the Company used \$202,884 and \$0, respectively, of forfeited accounts to reduce employer contributions. In 2024 and 2023, the Company used \$145,289 and \$75,191 of forfeited accounts to pay plan expenses, respectively.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Participants are allowed to have no more than one loan outstanding at any time. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 reduced by the greater of the outstanding balance on any loan from the Plan to the participant on the date the loan is made or the highest outstanding balance on loans from the Plan to the participant during the one-year period ending on the day before the date the loan is approved (not taking into account any payments made during such one-year period); or one-half of the value of the participant's vested account balance (as of the valuation date immediately preceding the date on which such loan is approved).

All loans are secured by the pledge of the participant's vested account balance, not to exceed the balance of the loans and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. The loans bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the plan administrator.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Common stocks and U.S. government securities are valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A loan is considered to be in default if a participant fails to make all or any part of a required loan repayment by the end of the calendar quarter which follows the calendar quarter in which the repayment was due. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants before March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

The Plan has a fee agreement with Fidelity Trust Management Company from which it receives revenue sharing funds which are recorded in the non-allocated ERISA spending account. The purpose of this account is to pay necessary and reasonable plan-related expenses in accordance with the Department of Labor's guidance. During 2024 and 2023, there were no additions to the ERISA spending account. There were no ERISA spending account funds utilized during 2024 and 2023 to pay administrative expenses. The ERISA spending account balance at December 31, 2024 and 2023, was \$19,462 and \$21,366, respectively.

- Investment income (loss) and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are mutual funds managed by Fidelity Management Trust Company, which is the trustee and custodian to the Plan, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$274,394 and \$184,241 to Fidelity Management Trust Company during 2024 and 2023, respectively.

Certain legal and accounting fees and other administrative expenses relating to the maintenance of employee eligibility records are paid by the Company.

Note 5. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy, which include mutual funds, money market funds, and common stocks and government bonds within the self-directed brokerage accounts, which are valued at quoted market price per share at year-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Investment Contract with Insurance Company

The Plan invests in the New York Life Anchor Account, a stable value investment option, through a group annuity contract issued by New York Life Insurance Company (New York Life). Contributions are directed to a New York Life pooled separate account that invests primarily in a diversified portfolio of high-quality, fixed income securities. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan, therefore it is considered a fully benefit-responsive investment contract with New York Life.

The guaranteed investment contract is fully-benefit responsive, therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract value of the New York Life Anchor Account at December 31, 2024 and 2023, is \$0 and \$2,870,366, respectively. The contract was terminated on November 1, 2024.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 9. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by FMR, LLC. This nonstandardized plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

During 2024, the Company determined that a partial plan termination occurred during the year ended December 31, 2020, due to significant changes to the workforce resulting from COVID-19. As of August 1, 2024, the partial plan termination process was complete.

Note 11. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Vesting Schedule

Effective January 1, 2025, the Company amended the Plan to change vesting in the Company's contributions plus earnings thereon to be based on a three-year graded vesting schedule rather than the current structure of five years.
