Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

The following description of L&S Plumbing Partnership, Ltd. Employees 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of L&S Plumbing Partnership, Ltd. (Company). All nonexcluded employees of the Company are eligible to participate in the Plan upon hire and may enroll immediately. Excluded employees include union employees and non-resident aliens. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Contributions

Participants may contribute a percentage of pre-tax or post-tax annual compensation, as defined in the Plan Document and up to the amount allowable under current income tax regulations. Prior to January 1, 2024, each new eligible participant automatically had 1% of defined compensation deferred into the Plan unless the employee elected otherwise. Effective January 1, 2024, this increased to 3% for participants with no existing affirmative election. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Discretionary matching contributions may be made on behalf of all eligible participants. The participant must have completed 1,000 service hours during the plan year and be actively employed on the last day of the plan year. The Company may make a discretionary profit-sharing contribution to the Plan. Participants who are employed on the last day of the plan year and have completed 1,000 service hours during the year are eligible to receive a share of the discretionary profit-sharing contribution. There were no additional discretionary profit-sharing contributions made during 2024 or 2023.

For the year ended December 31, 2023, the Company elected to make matching contributions to the Plan in an amount equal to 50% of employee salary deferral contributions up to 6% of eligible compensation.

For the year ended December 31, 2024, the Company has elected to contribute a safe harbor employer match. The safe harbor employer match is defined as an amount equal to 100% of the employee salary deferral contributions up to 1% of eligible compensation, plus 50% of the employee salary deferral contributions that exceed 1% but do not exceed 6% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan provides that each participant direct the investment of his or her account in any combination into a number of investment funds. The Plan currently offers a variety of pooled separate accounts which contain registered investment companies, a guaranteed investment contract, and money market fund as investment options for participants.

Vesting

Participants are immediately vested in employee salary and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary employer-match contribution and discretionary profit-sharing contribution is based on years of continuous service. Prior to January 1, 2024, a participant became 20% vested after two years of service and an additional 20% of each year of continuous service thereafter. A participant is 100% vested in these contributions after six years of credited service. Effective January 1, 2024, a participant will become 100% vested in the Company's discretionary employer-match contribution and discretionary profit-sharing contribution after two years of credited service.

As defined in the Plan Document, a participant becomes 100% vested in either of the Company's employer contributions through attaining their normal retirement date, permanent disability, or death.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested balance or \$50,000 minus their highest outstanding loan amount during the prior 12 months, whichever is less. The loans are collateralized by the balance in the participant's account and bear interest at prime plus 1% for loans initiated prior to September 25, 2017, and prime plus 2% for loans initiated thereafter. Interest rates on loans outstanding ranged from 4.50% to 10.50% at December 31, 2024. Principal and interest are paid by payroll deductions, and the loans must be paid in full within five years or within a reasonable time if the loan is for the purposes of a primary residence.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

The Plan's provisions also provide for hardship and in-service withdrawals if certain criteria are met.

Forfeited Accounts

If a participant is not fully vested on their termination date, the nonvested portion of their account is forfeited. Forfeitures are used to reduce future Company contributions or to pay plan expenses. As of December 31, 2024 and 2023, forfeited account balances totaled \$20,236 and \$13,026, respectively. No forfeitures were used to pay plan expenses in 2024 and 2023. Forfeitures in the amounts of \$23,782 and \$17,154 were used to reduce discretionary employer-matching contributions in 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions are recorded when received and expenses are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the guaranteed investment contract which is fully benefit-responsive and are reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Pooled separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in administering the Plan are paid by the Company and not reimbursed by the Plan. Administrative expenses paid by the Plan are recognized as paid. Certain investment fees are netted in the net appreciation in fair value of investments.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are valued at NAV of units held by the Plan at year-end as a practical expedient. The NAV of these accounts is based on the market value of its underlying investment divided by the number of units outstanding.

The money market fund is valued at cost which approximates fair value (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and specified interest rate guaranteed to the Plan. The investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events, *e.g.*, divestitures or spin-offs of a subsidiary that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons. Certain plan investments are shares of pooled separate accounts and a guaranteed investment contract issued by Voya, the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. The Company provides certain administrative services at no cost to the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contribution portions of their accounts.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved plan sponsored by Nova 401(k) Associates, Inc. This has been filed with the appropriate agency and the plan sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the non-standardized pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Company's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted employee contributions to the Plan, contributions of \$187 and \$90,860 were not remitted within the required time period for the years ended December 31, 2023 and 2022, respectively. Plan management has made the necessary corrections for the 2023 late deposits through the remittance of lost earnings in 2024. The Company is in the process of correcting the 2022 late deposits.
