### **Opinion**

We have audited the financial statements of International Association of Sheet Metal, Air, Rail, and Transportation Workers (SMART) Local Union No. 36 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

**Note 1. Description of the Plan**

International Association of Sheet Metal, Air, Rail, and Transportation Workers (SMART) Local Union No. 36 401(k) Plan (the Plan) was established during 1996 as a result of collective bargaining agreements between Sheet Metal, Air, Rail and Transportation Workers (SMART) Local Union No. 36 (the Local) and the St. Louis chapter of Sheet Metal and Air Conditioning Contractors Association (SMACNA). The Plan is primarily funded by employer contributions and participant deferrals. The Plan is a multiemployer defined contribution retirement plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits are not insured by the Pension Benefit Guaranty Corporation.

Under current provisions of the Plan, individuals become eligible to participate in the Plan on the first day that employer contributions are received on their behalf. Employer contributions were paid at a rate that ranged from \$.50 to \$.60 per hour during the years ended December 31, 2024 and 2023. Additionally, participants may elect to defer contributions from their hourly compensation, as defined by the Plan, in increments of \$0.10, subject to limits set forth under the Internal Revenue Code. Participants may also roll over amounts representing distributions from other qualified retirement plans.

Contributions to the Plan are invested as directed by the participant in various investment options. In the absence of participant direction, contributions are invested in a default investment fund. Participants must evaluate their own investment goals and objectives and choose the funds best suited to achieve those goals and objectives. Poor investment performance by the investments selected by the participants may cause their balances to be lower than the amounts contributed on their behalf.

Each participant's account is fully vested at all times and is maintained so as to separately reflect the amounts attributable to employer contributions and participant contributions as well as an allocation of earnings or losses, and administrative expenses. Allocations are based on participant earnings or losses or account balances as defined by the Plan. Participant accounts are charged a quarterly fee, which was equal to \$21.25 for the years ended December 31, 2024 and 2023. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

The Plan allows participants to take a withdrawal from their account upon retirement, disability, death or termination of service. Participants may also receive a distribution under the hardship withdrawal provisions of the Plan.

## **Note 1. Description of the Plan (continued)**

While the participants are fully vested in their entire account balance at all times, their balance may be subject to forfeiture under the following circumstances: a) a participant is eligible to apply for a benefit; b) for a period of three years thereafter has not filed an application for benefits or otherwise communicated in writing with the Plan; and c) the participant fails to communicate in writing with the Plan a current mailing address one year after communication attempts by the Plan. Participants may file an application for benefits to restore forfeited amounts. Forfeitures incurred totaled \$4,738 and \$0 for the years ended December 31, 2024 and 2023, respectively.

At December 31, 2024 and 2023, net assets available for benefits include unallocated amounts totaling \$328,319 and \$366,839 respectively, which are available to pay administrative expenses of the Plan.

Participants should refer to the summary plan description for more information.

## **Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements have been prepared on the cash basis of accounting, modified to record assets or liabilities that arise from cash transactions and events which provide a benefit or result in an obligation that covers a period greater than the period in which the cash transactions or events occurred. The modifications result in the recording of certain liabilities on the statements of net assets available for benefits. Except for unrealized gains or losses on investments, all transactions are recognized as either revenue or expenses when received or paid in cash. The modified cash basis of accounting is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP).

**Investments** - The investments of the Plan are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. For all other investments, the fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price).

Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

**Plan Administration** - The Plan is maintained under an agreement with Empower Retirement, LLC (Empower), who has custody of the assets of the Plan and makes payments to participants at the direction of the Trustees.

## **Note 2. Summary of Significant Accounting Policies (continued)**

**Property and Equipment** - Property and equipment consist of office furniture and equipment and are carried at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation is computed by the straight-line method over estimated useful lives of five years.

At both December 31, 2024 and 2023, property and equipment of \$5,082 were fully depreciated.

**Revenue Recognition** - Revenue is primarily derived from employer contributions. Under GAAP, revenue derived from employer contributions would be recognized when covered work is performed. Employers are required to remit contributions on a monthly basis, based on the number of hours worked in covered employment and the contribution rate currently in effect, as set forth in the applicable collective bargaining agreements. Contributions for the month of December are generally received the following month. On an ongoing basis, there are no significant changes in the opening and closing balances of contributions receivable. The Plan carries out its purpose described in Note 1 within a jurisdiction primarily located in the Greater St. Louis area.

The Plan is signatory to reciprocity agreements with various affiliated multiemployer retirement plans for its participants who perform work outside the geographic jurisdiction of the local union. Participants who are normally employed within the territory of one local union (home local) may be temporarily employed within the territory of another local union (reciprocating local). When a participant works in the territory of a reciprocating local, the latter is to make contributions to the former's fringe benefit plans on the participant's behalf. Monies received by the Plan on behalf of persons from outside participating local unions are forwarded to their home local fringe benefit plans. The Plan uses the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements, as for all other employer contribution revenue. Amounts paid to other plans under the terms of reciprocity agreements are not reflected in the statements of changes in net assets available for benefits, as the amounts received are not revenue earned by the Plan, and the corresponding payments are not an expense of the Plan. The Plan recognizes a liability upon receiving reciprocal contributions on behalf of non-participants working within the jurisdiction of the local union, and recognizes a decrease in that liability upon remitting those contributions to the appropriate plan. Employer contributions included reciprocal contributions of \$9,477 and \$2,722 for the years ended December 31, 2024 and 2023, respectively, from various other retirement plans under the terms of reciprocity agreements. The Plan remitted a total of \$28,664 and \$47,118 in reciprocal contributions to various other retirement plans under the terms of reciprocity agreements for the years ended December 31, 2024 and 2023, respectively.

**Payment of Benefits** - Benefits paid to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

## **Note 2. Summary of Significant Accounting Policies (continued)**

**Leases** - The Plan recognizes lease expense when rent payments are made, in accordance with the modified cash basis of accounting. Under GAAP, the Plan would need to determine if an arrangement is a lease at inception and record a right-of-use asset and lease liability. The Plan has determined that it has not directly entered into a lease but only reimburses a related party for shared facilities. The Plan has included in the accompanying financial statements informative disclosures about the Plan's arrangement with the related party relative to this arrangement.

**Expenses** - Certain investment related expenses are included in net appreciation in fair value of investments. The Plan pays directly any other expenses related to the Plan's operations.

**Estimates** - The preparation of financial statements require management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Reclassifications** - Certain prior year amounts have been reclassified to conform with the current year presentation.

**Subsequent Events** - Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

## **Note 3. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants and their beneficiaries. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at the time and the priority of those benefits.

## **Note 4. Tax Status**

The Plan's latest determination letter is dated July 6, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the determination letter. The Trustees and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

#### Note 4. Tax Status (continued)

The Plan is required to evaluate its tax positions and disclose the amount of a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 5. Fair Value Measurements

The Plan prepares its financial statements in accordance with the modified cash basis of accounting. Because one of the modifications to the cash basis the Plan has made is to carry certain investments at fair value, the *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification, which established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, has been implemented by the Plan. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The following describes the three levels of the fair value hierarchy:

##### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Measurements Using Net Asset Value as a Practical Expedient

The pooled separate accounts are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The pooled separate accounts are direct filing entities (DFEs) and file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis without notice.

**Note 6. Benefit-Responsive Investment Contract**

The Plan has a traditional fully benefit-responsive group annuity contract with Empower, who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest crediting rates are determined based on many factors. Rates are not developed by a formula method since the contracts do not have pre-defined cash flows, maturity dates, or a singular interest crediting rate from inception through discontinuance. The crediting rate is reviewed on a quarterly basis for resetting. The applicable crediting interest rate was 2.15% at December 31, 2024 and 2.00% at December 31, 2023. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **Note 6. Benefit-Responsive Investment Contract (continued)**

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan administrator believes the occurrence of such events, that would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

## **Note 7. Related Organizations**

The Plan is related to several tax-exempt organizations, which include a pension plan, a health and welfare plan, an apprentice fund and the Local.

### Shared Administrative Costs

The Plan shares facilities, equipment and staff with the related benefit plans and the Local. Salaries, payroll taxes, benefits and other expenses are initially paid by the related pension plan. Expenses allocated to the Plan totaled \$240,603 and \$229,992 for the years ended December 31, 2024 and 2023, respectively. Amounts due to the pension plan totaled \$32,056 and \$34,783 as of December 31, 2024 and 2023, respectively. The Plan shares office space with the related pension plan. The Plan is allocated a portion of rent based on estimates of space utilized. The Plan's portion of rent expense for the years ended December 31, 2024 and 2023 was \$11,257 and \$10,915 respectively.

### Clearing Account

Contributions for the Plan and related organizations are received and deposited in a general depository account which is held by the related welfare plan. On a regular basis, contributions due to the Plan are transferred from the clearing account into the Plan's account. Amounts due from the clearing account totaling \$2,002 and \$1,743 as of December 31, 2024 and 2023, respectively, are not included in the accompanying modified cash basis financial statements.

## **Note 8. Participant Deferrals**

Employers withhold participants' contributions from their payroll. During the years ended December 31, 2024 and 2023, several instances occurred where certain employers remitted contributions to the Plan after the 15<sup>th</sup> business day of the following month. The late payments did not meet the timeliness requirements as prescribed by U.S. Department of Labor (DOL) regulations and therefore constitute a prohibited transaction with a party-in-interest. During the years ended December 31, 2024 and 2023, contributing employers failed to timely remit participant contributions totaling \$256,144 and \$299,135 respectively.

The Plan has a collection program that pursues legal action against delinquent employers. As part of its collection program, the Plan may collect contributions, liquidated damages, interest and attorney fees from delinquent employers. Upon receipt of late contributions from a delinquent employer, the amount of contributions, plus an estimate of lost earnings, is credited to the participant's account to compensate the participant for lost earnings resulting from the delay in contributions.

## **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, the Plan held a significant portion of its assets in a guaranteed investment contract with a contract value of \$43,286,922 and \$40,995,869 respectively, which represented approximately 20% of the Plan's net assets available for benefits. It is reasonably possible that changes in the value of this investment could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the participant directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial investments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.

## **Note 10. Party-in-Interest Transactions**

The Plan's investments are held by Empower, who provides certain recordkeeping services to the Plan. Therefore, these transactions qualify as party-in-interest transactions under ERISA.



