### *(1) Description of the Plan*

The following description of the Roofers Union Local 30 Combined Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a multiemployer defined contribution plan formed under collective bargaining agreements covering both commercial and residential roofing between the Roofing Contractors' Association of Philadelphia and Vicinity (the "Employers"), the Delaware Valley Roofing Contractors' Association and Local No. 30 (the "Union"), affiliated with the AFL-CIO. The Plan covers substantially all the employees under the terms of the collective bargaining agreement between the Employers and the Union. The Plan is administered by a Board of Trustees, comprised of Union officials and management of the employers contractors association. The Trustees have overall responsibility for the operation and administration of the Plan, including the appropriateness of the Plan's investment elections and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - The Plan provides for the creation of an individual account, on behalf of each employee participant, to which all employers' contributions are credited. Employers' contributions to the Plan are based upon the number of hours worked by the participants. Investment income and fund expenses shall be allocated to each account on the basis of the ratio of the participants' individual balance to the total balance of all participants included in the valuation.

**Benefits** - The Plan provides retirement, death and certain other benefits. The terms of all benefits provided are explained in the Summary Plan Description. Under the terms of the collective bargaining agreement between the Employers and the Union, the Employers are required to make monthly contributions to the Plan based upon the number of hours worked by employees.

Benefits are payable in a lump sum upon attainment of retirement, death, or disability. In addition, a hardship distribution can be taken to pay for either: (1) full-time post-secondary education expenses of a participant, spouse or dependent; (2) to purchase, construct or forestall a mortgage foreclosure on a primary residence; (3) unreimbursed medical expenses of a participant or dependent; (4) uninsured casualty loss to a participant's primary residence; (5) uninsured funeral expenses of a participant's spouse, child, parent or spouse's parent; (6) participants who have attained age 50 and have 20 or more years of credited service may elect to withdraw all or a portion of their account if the participant faces financial hardship of sufficient severity, and the participant is confronted by present or impending financial ruin. A separation distribution can be taken if a vested participant has not worked for at least two consecutive years in the commercial and residential roofing industry in the geographic jurisdiction of the Plan. A partial withdrawal benefit can be taken if an active participant has two or more years of credited service. A participant with an account balance of \$100,000 or more can take a partial withdrawal up to 20% of their balance. A participant with less than \$100,000 can take a partial withdrawal up to a maximum of 10% of their account balance with a minimum of \$2,000.

**Participants Accounts** - Each participant's account is credited with the contributions made on his or her behalf and an allocation of the Plan's investment earnings, administrative expenses and forfeitures of terminated participants' non-vested accounts. Allocations are based on relative participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant's account is also charged a yearly fee of \$25. Any participant whose account balance is \$25 or less will have their full balance deducted to pay the fee.

**Vesting** - Participants become 100 percent vested after two years of credited service including service under the Roofers Union Local 30 Combined Pension Plan.

**Funding Policy** - Under the terms of the collective bargaining agreement, the Employers are required to make contributions to the Plan on a monthly basis for each hour worked by participants.

**(2) Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Adoption of Recent Accounting Pronouncements** - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that is subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

**Use of Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Certain investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive contracts held by the Plan are recorded at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employers' Contributions Receivable** - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on an agreed upon hourly rate and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection including subsequent period collections. As of December 31, 2024 and 2023, the Plan did not record any credit losses for employers' contributions receivable.

The Board of Trustees has established a program to review participating employer records in order to determine compliance with contribution provisions of the collective bargaining agreement. As a result of this program, previously unreported contributions are identified related to current and prior fiscal years. However, due to the collection efforts required by the Plan, including litigation, the ultimate realization of any additional contribution receivable cannot be reasonably estimated until the collection process is completed. Accordingly, the Plan primarily recognizes these previously unreported contributions in the fiscal year in which the settlement proceeds are received.

**(2) Summary of Significant Accounting Policies (Continued)**

**Payment of Benefits** - Benefits payments to participants are recorded upon distribution.

**Administrative Expenses** - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with related ERISA plans. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Plan in relation to the other plan. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events** - The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**(3) Fair Value Measurements**

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Interest Bearing Cash: Valued using amortized cost, which approximates fair value.

Common Stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Partnership/Joint Venture Interest: Valued based on the Plan's ownership percentage and the value of the partnerships' investments per the last reported sales price on the last business day of the plan year or the last quoted bid price.

**Transfers Between Levels** - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(a) In accordance with FASB Accounting Standards Codification Subtopic 820-10 Fair Value Measurement - Overall, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

(a) Boyd Watterson GSA Fund, L.P. and Subsidiary (the "Fund"), a Delaware limited partnership, was formed on August 16, 2013 to acquire, develop, own, and operate a diversified portfolio of real estate investments in commercial property. The Fund was formed to operate as a perpetual life, open-end, commingled collective investment fund and intends to invest primarily in real estate primarily leased to the U.S. federal government either through the General Services Administration ("GSA") or other federal government agencies.

**(4) Group Annuity Contracts**

The Plan has two traditional fully benefit-responsive guaranteed investment contracts with Principal Global Investors Trust Company ("Principal") and AXA Equitable Life Insurance Company ("AXA") Principal and AXA both maintain the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4% (Principal) and 2% (AXA). The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal and AXA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

***(4) Group Annuity Contracts (Continued)***

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

***(5) Related Party Transactions***

Administrative expenses incurred and revenues received jointly by the Roofers Union Local 30 benefit plans (the "Plans") that are allocated among the Plans as follows:

- The salaries and fringe benefits of an employee are allocated based upon their time spent on each Plan.
- Revenues from processing fees, late charges and settlements are allocated among the plans based upon their relative amounts of employer contributions.

The net amount of administrative expenses allocated to the Plan at December 31, 2024 and 2023 was \$28,755 and \$33,507, respectively.

***(6) Commitments and Contingencies***

Effective November 1, 2017, the Plan entered into a long-term contract with BeneSys, Inc. (the "third-party administrator") for monthly administrative services through October 31, 2023. Subsequent to this date, the arrangement has been on a month to month basis. For the years ended December 31, 2024 and 2023, the third-party administrator was paid a fee on a monthly basis of \$6,620 and \$6,620, respectively. Third party administrator fees amounted to \$79,440 and \$79,490 for the years ended December 31, 2024 and 2023, respectively.

**(7) Tax Status**

The Plan obtained its latest determination letter dated August 1, 2015, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Plan Termination**

Although they have not expressed any intention to do so, the Trustees have the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, the participants will become 100 percent vested in their accounts.

**(9) Significant Participating Employers**

During the years ended December 31, 2024 and 2023, the Plan had the following employers which individually represented 10% or more of total contributions:

In the event these participating employers were to suspend contributions, the Plan would retain the risk of meeting current plan obligations until the appropriate adjustments were made.

**(10) Risks and Uncertainties**

**Investment Risk** - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.


