INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of

BBS Automation Chicago, Inc. 401(k) Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BBS Automation Chicago Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the BBS Automation Chicago, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 1989, is a defined contribution plan covering substantially all employees of BBS Automation Chicago, Inc. (the “Sponsor”) who are at least 21 years of age. Employees are eligible for matching contributions upon being enrolled in the Plan. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (“IRC”).

Contributions

Employees eligible to participate in the Plan (“participants”) may contribute, on a pre-tax basis or after-tax basis, in the form of a salary deferral, a percentage of compensation, as defined by the Plan, subject to IRC limitations, which are adjusted annually by the Internal Revenue Service (“IRS”). Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans. Eligible employees, who do not elect otherwise, are automatically enrolled in the Plan with a deferral rate of 6%.

The Sponsor, at its discretion, may provide matching contributions of participant contributions. The Sponsor, at its discretion, may also make profit-sharing contributions to the Plan annually on behalf of qualifying participants. Profit-sharing contributions are allocated amongst qualifying participants based upon the ratio that each qualifying participant’s compensation for the Plan year bears to the total compensation of all qualifying participants for the plan year. For the year ended December 31, 2024 the Sponsor matched 100% of participant contribution for the first 3% plus 50% matched on the next 2% of participant contribution. There were no discretionary profit-sharing contributions made during the year ended December 31, 2024.

Investment options

The Plan’s assets were held by John Hancock Life Insurance Company USA from until December 14, 2024 and Vanguard Group, Inc. from December 15, 2024 to December 31, 2024 (the “Custodians”), the custodians of the Plan’s investment assets. Under an arrangement with the Custodians and upon enrollment in the Plan, participants may direct employee contributions in any whole percentage increments to any of the available funds. Participants may change their allocation to the various investment options at any time.

Participant accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Sponsor’s contributions on behalf of the participant and (c) the earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions, rollovers, and earnings thereon. Vesting in Sponsor contributions and the earnings thereon is based on years of qualifying service, and is as follows:

Forfeited accounts

Forfeited non-vested accounts are used to pay administrative expenses or to reduce Sponsor matching contributions. Amounts forfeited during the year ended December 31, 2024 totaled \$22,929. Amounts used to reduce Sponsor matching contributions for the year were \$9,500. Accumulated forfeitures available to pay administrative expenses and reduce future Sponsor contributions totaled \$0 and \$5,856 at December 31, 2024 and 2023, respectively.

Notes receivable from participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. The maximum term of repayment for a loan is five years, or twenty-five years if the loan proceeds will be used to acquire the principal residence of the participant. A participant may only have three loans outstanding at a time. Interest rates on loans outstanding at December 31, 2024 and 2023 ranged from 3.25% to 8.50%.

Payment of benefits

Upon termination of employment or for reasons of death or disability, a participant may withdraw the vested balance of their account in the form of a lump sum. Participants still employed with the Sponsor may withdraw all or a portion of their account balance upon attainment of age 59½ or for reasons of financial hardship, as allowed under the IRC. A participant whose vested account balance does not exceed \$1,000 will receive a lump sum distribution of their vested account balance as soon as administratively feasible following termination. A participant whose vested balance exceeds \$1,000 but does not exceed \$5,000 and who does not elect otherwise will have their vested account balance distributed from the Plan directly to an individual retirement account in their name as soon as administratively feasible following termination.

Administrative fees

Administrative fees include fees related to the administration of notes receivable from participants and payments of benefits, as well as recordkeeping and asset management fees that are allocated to participants on a pro-rata asset basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes realized and unrealized gains and losses on investments purchased and sold, as well as held during the year. See Note 4 for discussion of fair value measurements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of benefits

Benefits are recorded when paid.

Refunds of excess contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions. The Plan will distribute the excess contributions to the applicable participants during 2025.

Subsequent events

The Sponsor has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodians, except for comparing such information to information included in the Plan's financial statements and supplemental schedule.

The following information included in the Plan's financial statements and supplemental schedule was prepared and certified as complete and accurate by the Custodians as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

4. RELATED PARTY TRANSACTIONS

The Sponsor incurs certain costs on behalf of the Plan and also provides recordkeeping and administrative services to the Plan at no cost.

Investments held by the Plan are managed by the Custodians. Accordingly, these transactions qualify as party-in-interest transactions as defined by ERISA.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used during the year ended December 31, 2024.

- Mutual funds and money market funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded.
- Common collective trust funds: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to the estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.
- Pooled separate accounts: Valued at the unit value of shares held by the Plan at year-end, as determined by the Custodians based on the net asset value ("NAV") of the underlying mutual funds. The NAV, as reported by the Custodians, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There are no changes in the methodology used during the year ended December 31, 2024. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. INCOME TAX STATUS

The Plan uses a non-standardized pre-approved profit sharing/money purchase/COPA plan document sponsored by the FIS Business Systems LLC. The Plan received a determination letter from the Internal Revenue Service ("IRS") dated June 30, 2020 stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress, and the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

8. PLAN AMENDMENT

On December 15, 2024, the Sponsor terminated its custodial agreement with John Hancock Life Insurance Company and entered into a new agreement with Vanguard Group, Inc. All assets were transferred on December 15, 2024. Upon restatement of the Plan document, no significant provisions of the Plan were changed.

9. PLAN TERMINATION

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

10. INVESTMENT RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
