INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
BASS Medical Group 401(k) Plan I

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of BASS Medical Group 401(k) Plan I, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BASS Medical Group 401(k) Plan I's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of BASS Medical Group 401(k) Plan I and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about BASS Medical Group 401(k) Plan I's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the BASS Medical Group 401(k) Plan I (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by BASS Medical Group, Inc. (the "Company", "Employer", or "Plan Sponsor") pursuant to Section 401(a) and related provisions of the Internal Revenue Code ("IRC"), was established effective January 1, 2007, and restated January 1, 2021. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination of employment, or financial hardship. The Plan covers all eligible employees of the Employer upon employment, as defined by the Plan. It is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act, related to participant loans and distributions. Additionally, an expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first plan year beginning on or after January 1, 2026 to amend the Plan for the changes related to CARES and SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of December 31, 2024.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee and custodial services are provided by John Hancock Trust Company LLC (the "Trustee," or "John Hancock"). Recordkeeping services are provided by John Hancock jointly with John Hancock Retirement Plan Services, LLC. Certain administrative expenses of the Plan are paid directly by the Company.

1. DESCRIPTION OF THE PLAN (continued)

Eligibility

Employees covered by the Plan generally include all employees except for union employees, nonresident aliens, independent contractors, and certain other employees. Employees who have attained twenty one (21) years of age and completed one year of service are eligible to participate in the Plan. If one year of employment is not completed, then the service requirement will be satisfied upon receiving credit of a year of service or 1,000 hours of service. Participants can enroll in the Plan on the first day of the Plan year, or on the first day of the seventh month of the Plan year, coinciding with or next following the satisfaction of eligibility requirements. The one year service eligibility requirement may also be met by an employee who has prior employment with certain other employers, as defined in the plan documents.

Contributions

Participants may contribute up to 100% of their annual eligible compensation subject to certain IRC limitations. The Plan allows participants to contribute on a pre-tax and/or Roth basis up to the amount allowed by the IRC. Maximum allowed deferral amounts were \$23,000 for 2024. Participants age 50 and older may also contribute an additional \$7,500 in catch-up contributions to the Plan in 2024. Participants may also contribute amounts representing distributions from other qualified benefit plans ("rollovers").

Participants direct the investment of all their contributions into various investment options offered by the Plan.

The Company may make a discretionary Employer matching contribution equal to a discretionary percentage of employee deferrals. There were no discretionary Employer matching contributions approved or made for 2024. The Company makes safe harbor nonelective Employer contributions of three percent (3%) of employee compensation. The Company determined that such contributions for the year ended December 31, 2024 were \$3,040,725, and recorded a receivable in this amount. In addition to the safe harbor nonelective Employer contribution, the Company may make a discretionary profit sharing contribution in an amount to be determined by the Company on an annual basis. The Company accrued for \$7,000,340 in discretionary profit sharing contributions and the Plan recorded a receivable in that amount as of December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, safe harbor nonelective Employer contributions, allocations of discretionary contributions and investment earnings, and is charged with an allocation of certain Plan losses, if any, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions and safe harbor nonelective Employer contributions plus actual earnings thereon. Vesting in the Company's discretionary Employer matching contributions and discretionary profit sharing contributions plus actual earnings thereon is based on years of continuous service.

The vesting schedule for discretionary Employer matching contributions and discretionary profit sharing contributions is as follows:

Payment of benefits

A participant's plan benefits will be distributed upon termination of employment, retirement, death, or disability. Normal retirement age is 65 years. Financial hardship distributions may be made under certain conditions of heavy financial need as defined in the plan documents and regulated by the Internal Revenue Service ("IRS"). Upon attaining the age of 59 ½, the participant may, while still employed by the Company, request a withdrawal from their account balance. The benefits will be paid to the participant or beneficiary in accordance with the provisions of the plan documents. If a participant dies while employed by the Company, one hundred percent (100%) of their account balance will be used to provide their beneficiary with a death benefit. If a participant's account balance is less than or equal to \$5,000 upon termination, the balance is distributed in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. If the account balance is over \$5,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents.

Notes receivable from participants

Participants may borrow from their fund accounts up to 50 percent (50%) of their total vested balance, subject to a minimum of \$1,000 and a maximum amount of \$50,000. The note (or "loan") is secured by the vested balance in the participant's account. Each loan bears interest at a rate equal to the prime interest rate plus 1%. Principal and interest is paid ratably through monthly payroll deductions, over a term not to exceed five years, unless the loan was obtained to acquire a principal residence, in which case payment terms may be extended. Interest rates on outstanding loans range from 4.25% to 9.50% for the year ended December 31, 2024, and have various maturity dates through December 2029.

Forfeiture accounts

Forfeitures of a terminated participant's non-vested account balances may be used to pay Plan expenses or to reduce discretionary Employer matching contributions or safe harbor nonelective Employer contributions. During the year ended December 31, 2024, forfeitures in the amount of \$402,014 were used to reduce the safe harbor nonelective Employer contributions attributable to December 31, 2023, funded during 2024. The unallocated forfeiture balance as of December 31, 2024 and 2023, was \$437,627 and \$402,014, respectively.

Administrative expenses

Administrative expenses are generally paid by the Company, but may, at the discretion of the plan administrator, be paid by the Plan. Transaction fees for certain participant initiated activity are charged to the specific account of the participant initiating any such transaction. The Plan is not required to reimburse the Company for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent liabilities. Actual results could differ from these estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on sale on investments bought and sold as well as held during the year.

Management fees and expenses charged to the Plan for investments in mutual fund accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as deemed distributions based upon the terms of the plan documents.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions or loan repayments have been separated from a participant's pay by the Company, which is the pay date. Company contributions, if any, are recorded in the year earned to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for contributions based upon contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the contributions are received by the Trustee.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available for issuance. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of the following information ("certified information"):

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024.
- Net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, and transfers from another Plan as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024, (the "supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the Plan's financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

4. FAIR VALUE MEASUREMENTS (continued)

The three levels of fair value hierarchy are as follows:

- *Level 1* - inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;
- *Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- *Level 3* - inputs are unobservable inputs for the asset or liability and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds and self-directed brokerage accounts- Investment securities traded on security exchanges are valued at closing market prices of the underlying assets, on the last business day of the Plan year. The mutual funds and self-directed brokerage accounts held by the Plan are deemed to be actively traded and are classified within Level 1 of the fair value hierarchy.

Collective investment trusts- Investments in the collective investment trusts (CITs) are valued at net asset value (NAV) as a practical expedient to fair value, based on the fair value of the underlying investments in the fund, minus fund liabilities, divided by the number of outstanding shares. Investments at NAV as a practical expedient to fair value are not disclosed within the fair value hierarchy.

As of December 31, 2024 and 2023, there were no restrictions on redemption or unfunded commitments for any of the major types of assets.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines a party-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (continued)

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management and shareholder services are paid through fund level revenue sharing arrangements. These fees reduce fund earnings, thereby impacting Plan revenue applied to participants' accounts.

The Trustee retains, as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Certain Plan investments are managed by John Hancock or an affiliate of John Hancock; therefore, these investment transactions qualify as exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participants' account become fully vested.

7. TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/Cash or Deferred Arrangement ("CODA") Plan (the "pre-approved plan"). The Internal Revenue Service has issued an opinion letter dated June 30, 2020, stating that the pre-approved plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
