## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of Steven-Robert Originals, LLC 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023**

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Steven-Robert Originals, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on August 1, 2014, to provide retirement benefits for employees of Steven-Robert Originals, LLC (the “Plan Sponsor”). The Plan covers all employees who have attained the age of twenty-one and have completed three months of service. The Plan is designed to comply with Section 401(k) of the Internal Revenue Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Voya Institutional Trust Company (“Voya”) serves as the custodian and Trustee.

**Plan Year**

The Plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

**Contributions**

The Plan allows for the following types of contributions:

***Participant Salary Deferral 401(k) Contributions***

The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Code. Employees are automatically enrolled into the Plan upon eligibility. The automatic enrollment contribution percentage is 4% of eligible compensation and the contributions will increase by 1% in the second through fourth year to a maximum 10%. Employees may voluntarily contribute up to 100% of their eligible compensation, subject to various nondiscrimination tests and limitations prescribed by the Code, and they may choose to opt out of the automatic enrollment and automatic increase features. Participants may also make Roth after-tax elective deferral contributions.

***Employer Discretionary Matching Contributions***

The Plan Sponsor may make discretionary matching contributions, equal to an amount, to be determined by the Plan Sponsor. The Plan Sponsor made discretionary matching contributions of \$199,879 and \$174,387 for the years ended December 31, 2024, and 2023, respectively.

***Employer Discretionary Profit Sharing Contributions***

The Plan Sponsor may make discretionary profit-sharing contributions to the Plan at the sole discretion of the Plan Sponsor. The Plan Sponsor elected not to make discretionary profit-sharing contributions to the Plan in 2024 and 2023.

***Rollover Contributions***

Participants may make rollover contributions from another qualified plan.

**NOTE 1: DESCRIPTION OF PLAN (Continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions, employer contributions and an allocation of Plan earnings, and an allocation of certain Plan expenses, as defined by the Plan document. The yield (interest, dividends, and net realized and unrealized gains and losses) on investments is allocated to each participant's account based on each participant's pro rata share of the total investments in the particular fund. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account.

**Allocations**

The Plan allows participants the ability to self-direct their accounts between various investment options. Participants are allowed to invest their accounts in any one account or combination of accounts. Investment earnings and losses are allocated based on the actual earnings and losses in participants' self-directed accounts.

**Vesting**

Participants are always 100% vested in their elective salary deferrals and investment gains and losses credited thereon. Employer discretionary matching and profit-sharing contributions, and gains/losses credited thereon, are also 100% vested.

**Forfeitures**

Forfeitures from employer contributions may be used to pay Plan expenses or reduce employer contributions. Forfeitures of \$0 in 2024 and \$9,736 in 2023 were used to reduce employer contributions. At December 31, 2024, and 2023, there were forfeitures of \$927 and \$136 respectively, available to pay Plan expenses or reduce employer contributions.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of their vested account balance, reduced by any outstanding loan balance. Principal and interest are paid ratably through monthly payroll deductions and loan periods range from one to five years, unless used for the purchase of a principal residence, then the loan period may not exceed ten years.

**Excess Contributions Payable**

Excess contributions payable represents amounts to be refunded to participants to comply with regulatory contributions limitations. Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits at December 31, 2024, and 2023, and as reductions to contributions in the statements of change in net assets available for benefits for the years then ended.

**Retirement**

Normal retirement under the Plan is the attainment of age 65.

**Payment of Benefits**

Payment of benefits may be made when one of the following conditions has been met: 1) normal retirement; 2) termination of employment of the participant; 3) upon demonstration of financial hardship; 4) death or disability of the participant; or 5) in-service upon reaching age of age 59 ½. Participants' vested accounts that do not exceed \$5,000 may be distributed upon severance from employment. The normal form of benefit payment is a lump sum distribution in the amount equal to the value of the participant's vested account balance, less any outstanding participant loan balance.

*NOTE 2:* **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan and the Plan Sponsor at the discretion of the Plan Committee. Expenses related to specific participant transactions are charged to the respective participant's account.

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition**

Pooled separate accounts and money market funds are stated at fair value, which is based on underlying quoted market prices when available. The guaranteed investment contract is a fully benefit-responsive investment contract and is stated at contract value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Changes in the unit values are reflected in each participant's self-directed account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Benefit Payments**

Benefit payments are recorded when paid.

**Income Taxes**

The Plan has obtained a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan is acceptable under Section 401(k) of the Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has determined that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 3: INFORMATION CERTIFIED BY THE CUSTODIAN**

**NOTE 4: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

**NOTE 5: GUARANTEED INVESTMENT CONTRACT**

Plan investments include an investment in a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company. Voya maintains contributions to the fund in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024, and 2023, the contract value of fully benefit responsive investment contract was \$95,006 and \$111,787, respectively. Participants may ordinarily direct the withdrawals or transfer of all, or a portion of, their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest is credited to the fixed account at an annual effective yield that is at least equal to the minimum guaranteed interest rate in the investment contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract permits the insurance company to terminate the agreement prior to the scheduled maturity date after five completed contract years.

**NOTE 6: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Pooled Separate Accounts:* Pooled separate accounts invest mainly in mutual funds both domestic and international. The underlying assets have level 1 quoted pricing inputs and observable level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets; valued at the net asset value (NAV) of units held in the pooled separate accounts. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

*Money Market Fund:* Underlying short-term investments with quoted prices in active markets to preserve the value of the investment at \$1.00 per share.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments such as pooled separate accounts, money market account, and the guaranteed investment contract are managed by the custodian and its affiliate as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are recorded in net appreciation in fair value of investments. Fees for certain expenses related to the administration of the Plan were paid by the Plan or the Plan Sponsor. Notes receivable from participants are considered party-in-interest transactions. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 10: SUBSEQUENT EVENTS**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued, and management has determined that no subsequent events have occurred that should be disclosed.
