The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and the period from November 17, 2023 through December 31, 2023, and the related notes to the financial statements.

### 1. Description of the Plan

The following brief description of The Bazooka Companies, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan, established November 17, 2023, covering substantially all employees of The Bazooka Companies, LLC (the Company or Employer) who are age 21 or older and have satisfied the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company controls and manages the operation and administration of the Plan. For the period from November 17, 2023 through August 31, 2024, Capital Bank and Trust (Capital Bank) served as the trustee and the recordkeeper of the Plan. Effective September 1, 2024, Fidelity Management Trust Company (Fidelity) became the trustee and recordkeeper of the Plan.

In October 2023, employees under the confectionery division of B-TDS, Inc. were terminated due to the sale of the division by B-TDS, Inc. and became employees of the Company. As a result of the sale, the Plan was established on November 17, 2023 and employees of the Company who were transferred from B-TDS, Inc. with account balances in The Bazooka 401(k) Savings and Investment Account (the B-TDS Plan) had their account balances transferred to the Plan. Participant accounts amounting to \$10,501,816, including investments of \$10,398,205 and loans in the amount of \$103,611, were transferred from the B-TDS Plan into the Plan in November 2023.

Effective February 23, 2024, the Plan sponsor name changed from The Bazooka Companies, Inc. to The Bazooka Companies, LLC; the Plan name changed from The Bazooka Companies, Inc. 401(k) Plan to The Bazooka Companies, LLC 401(k) Plan.

#### *Eligibility*

An employee is eligible for elective deferral contributions, employer matching contributions, and employer nonelective contributions on the first day of the calendar month, when the employee attains age 21 and completes 60 days of service. Effective September 1, 2024, the eligibility service requirement is amended to one month. Employees are eligible for employer nonelective contribution if they are employed on the last day of the contribution period and earn at least 1,000 hours of services during the Plan year.

#### *Contributions*

Each year, participants may contribute up to 80% of their eligible compensation, as defined in the Plan, subject to certain Internal Revenue Service (IRS) limitations. The Plan includes an auto-enrollment provision with the initial deferral rate set at 2% of eligible compensation. Contributions may be made to the Plan on a pre-tax and/or after-tax Roth basis. The participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant.

The Company may make a discretionary matching contribution. During 2024, the Company made discretionary matching contributions to each eligible employee equal to 75% of an employee's pre-tax and/or Roth contributions up to 6% of eligible compensation. The Company did not make any matching contribution in 2023.

The Company also may make other discretionary nonelective contributions, as defined in the Plan. There were no employer nonelective contributions made during the 2024 and 2023 Plan year.

### *Participant Accounts*

Individual accounts are maintained for each Plan participant. Each participant's account is credited with contributions; employer matching contributions; nonelective contributions, if any; and an allocation of investment earnings, and is charged with investment losses, withdrawals, and an allocation of expenses paid out of the Plan. Allocations are based on participant earnings, account balances, and specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Investment Options*

Participants may direct contributions in any investment options offered by the Plan.

### *Vesting*

Participants are 100% vested in their salary deferral and rollover contributions, plus actual earnings thereon.

Vesting in the Company's matching and nonelective portion of their accounts, plus actual earnings thereon, is as follows:

Years of Service	Vesting (%)
Less than 1	-
1 but less than 2	25
2 but less than 3	50
3 but less than 4	75
4 or more	100

Employees who are eligible for discretionary matching and discretionary nonelective contributions made prior to February 23, 2024 are 100% vested in such contributions.

### *Notes Receivable from Participants*

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance in their accounts during the prior 12-month period. All loans are required to be repaid within five years, unless the proceeds of the

loans are used for the purchase of a principal residence, in which case, the loan repayment period may not exceed ten years from the date of the loan. Additionally, the period of loan repayments could be extended for up to one year. The minimum loan amount is \$1,000. The loans bear interest at rates commensurate with local prevailing rates at loan origination, as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

A participant is eligible to receive a distribution of their vested account balance under the following circumstances: (a) termination of employment, (b) retirement, (c) disability, or (d) death. A participant also is eligible for in-service withdrawals upon the approval of the Plan administrator. Types of in-service withdrawals available under the Plan are: (a) hardship withdrawals, (b) withdrawals after age 59½, (c) withdrawals after age 70½, (d) withdrawals after normal retirement age, and (e) withdrawals of rollover contributions, and (f) required minimum distributions of the participant's vested interest by a single lump-sum payment or by direct rollover to an individual retirement account or other eligible retirement plan following severance from employment.

### ***Forfeitures***

Forfeitures of employer contributions are used to offset administrative expenses of the Plan. Any remaining forfeitures shall be used to reduce employer contributions otherwise payable to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$366 and \$0, respectively. No forfeitures were used to reduce employer contributions or plan expenses in 2024 or 2023.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of the Plan's financial statements, in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes the Plan's gains or losses on investments bought and sold, as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as distributions, based on the terms of the Plan document. Fees charged by the trustee relating to notes receivable from participants are paid from the participants' accounts and are included in administrative expenses and expensed when incurred.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Expenses related to processing fees for loans and service fees are deducted from the respective participants' accounts. Other expenses incurred in the administration of the Plan, including recordkeeping and trust fees, are paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Other investment-related expenses are included in the net appreciation in fair value of investments.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024 and for the period from November 17, 2023 through December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Fidelity, qualified institutions.

## **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.

- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund* - Valued at the daily closing price as reported by the fund.

*Mutual Funds* - These funds are valued at their daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

*Common Collective Trusts (CCT)* - The CCT is stated at fair value using the NAV practical expedient. This practical expedient is not used when it is determined to be probable that the fund will sell for an amount different than the reported NAV. The NAV of the CCT is determined using the market price of the underlying securities and the contract value of investment contracts held by the CCT, as determined by the trustee of the CCT. There are no restrictions on the redemption of the investment and no unfunded commitments. The CCT is a direct-filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the trustees. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan issues notes receivable to participants, which are secured by the vested balance in the participants' accounts. Notes receivables from participants also qualify as exempt party-in-interest transactions.

## 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### 8. Tax Status

For the period from November 17, 2023 through August 31, 2024, the Plan used a pre-approved plan document sponsored by Capital Group Retirement Plan Services and received an opinion letter from the IRS, dated June 30, 2020, which stated that the pre-approved plan document, as then designed, satisfied the applicable provisions of the IRC. Effective September 1, 2024, the Plan uses a pre-approved plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfied the applicable provisions of the Internal Revenue Code (IRC). Plan management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 9. Subsequent Events

Management evaluated subsequent events and transactions for the Plan through October 15, 2025, the date the financial statements were available to be issued. There were no material subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
