### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of JetBlue Airways Corporation Deferred Savings Plan for Puerto Rico Crewmembers (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.



We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Notes to the Financial Statements**

**1. Description of the Plan**

***General***

The JetBlue Airways Corporation Deferred Savings Plan for Puerto Rico Crewmembers (the “Plan”), a defined contribution plan, was established by JetBlue Airways Corporation (the “Company”) on July 1, 2002. The Plan was most recently amended and restated effective January 1, 2024. The Plan is administered by the Company. Empower Trust Company, LLC (“Empower”) is the recordkeeper and custodian of the Plan. The Plan is a profit-sharing plan covering eligible crewmembers of the Company. Eligible crewmembers include both bona fide residents of Puerto Rico, and persons who perform labor or services primarily within the Commonwealth of Puerto Rico, regardless of residence for other purposes, pursuant to section 1.501(a)-1(e) of the United States Internal Revenue Code of 1986, as amended (the “Code”). Crewmembers who are residents of Puerto Rico and whose employment location is based on the mainland United States are not eligible to participate in the Plan as they are covered by the Company’s U.S. 401(k) Plan. Eligible crewmembers of the Company may participate in the Plan immediately. Participation in the Plan is voluntary, and the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

Plan assets consist of mutual funds. Participants elect to have their contributions and related Company matching contributions invested in whole percentages in any or all of the funds offered by Empower. Transfers between the various mutual funds may be made daily by participants.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement Act (“SECURE 2.0 Act”) was signed into law to enhance the retirement savings system. Principle areas of the act addressed automatic enrollment, required minimum distributions (“RMD”), and catch-up contributions. All provisions required through 2024 have been adopted by the Plan. All provisions of the SECURE 2.0 Act with effective dates in 2025 and beyond will be evaluated and implemented in accordance with future regulations and guidance.

***Eligibility***

All crewmembers of the Company are eligible to participate in the Plan immediately. Interns, and nonresident aliens are not eligible to participate in the Plan, except as may otherwise be required to preserve the qualified status of the Plan.

***Contributions***

Participants may make voluntary contributions up to the lower of (a) 25% of eligible compensation out of pre-tax earnings or (b) up to the maximum allowed by the Internal Revenue Code for a New Puerto Rico (“IRC NPR”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a matching contribution of 100% of all crewmember contributions, up to the first 5% of annual compensation. Another component of the Plan is a Company discretionary 8% for certain non-managerial technicians and inspectors who perform labor or services primarily within the Commonwealth of Puerto Rico, referred to as *Retirement Non-Elective Licensed Crewmember* contributions. Profit-sharing is a discretionary incentive compensation payment by the Company that exceeds 5% of eligible compensation and relates to Company performance for a particular calendar year. Eligible crewmembers may elect to defer up to 75% of this amount to the Plan as a profit-sharing deferral contribution. There was no profit-sharing deferral contribution for the plan years 2024 and 2023. Prior to January 2024, another component of the Plan was a Company discretionary contribution of 5% of eligible non-management crewmember compensation, which was referred to as *Retirement Plus*. Certain non-

managerial technicians and inspectors who perform labor or services primarily within the Commonwealth of Puerto Rico, received an additional contribution of 3% of eligible compensation, which was referred to as *Retirement Advantage*. As of January 1, 2024, the Retirement Plus and Retirement Advantage programs ended and all Retirement Plus eligible crewmembers, except for FAA licensed crewmembers and System Controllers, received a 5% increase in pay which they have the option to contribute to their 401(k).

***Rollover Contributions***

Participants who have participated in other qualified retirement plans may make a rollover contribution to the Plan of certain distributions received from those other plans.

***Participant Accounts***

Participants have separate accounts for crewmember and employer contributions. Contributions are allocated to the participants' accounts as authorized by each participant. Plan earnings (losses) are allocated to participants daily based on the number of shares in their accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in employer matching contributions is based on the participant's vesting years of service with the Company. A year of vesting service is based on twelve consecutive months of employment, which equates to one year of service and nonconsecutive periods of service shall be aggregated.

Employer matching contributions become fully vested upon three years of service with the Company.

If termination from the Company is the result of death or disability, the participant is deemed 100% vested. All employer contributions are 100% vested upon three years of service or attainment of age 60, while still employed by the Company, whichever is earlier.

Profit-sharing contributions, if made by the Company, vest immediately.

***Notes Receivable from Participants***

Participants are able to borrow from their accounts up to the lesser of 50% of their vested balance or \$50,000 reduced by the highest outstanding loan balance in the preceding 12 months. Loans must be made for a minimum of \$1,000 and are repayable at the prime rate plus 1% at the date of issuance. Loan terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence and are secured by the balance in the participant's account. Principal and interest are paid ratably through regular payroll deductions.

***Payment of Benefits***

At age 59½ and thereafter, an active crewmember can withdraw funds from the vested balance of their account at any time. Participants eligible to receive a distribution from the Plan may elect a lump-sum payment or a series of installments over a period of less than ten years. Participants who reach age 73 are required to begin taking minimum distributions from their retirement account by April 1 of the year following the year they attain age 73. Upon termination of service, a participant or the participant's beneficiary may receive their Plan benefits in a lump-sum distribution.

While employed, participants may, upon written request and approval by the Plan administrator, withdraw all or a portion of their elective contributions and vested Company contributions. Withdrawals are only permitted for financial

hardship and if other resources are not available. The amount may be limited to certain subaccount(s) and/or vested amounts.

Effective January 1, 2025, the Plan allows for penalty-free withdrawals of up to \$10,000 (or 50% of the account balance, if less) for participants who self-certify that they are victims of domestic abuse.

***Forfeitures***

All forfeitures of the Company's contributions from terminated participants' non-vested accounts may be used by the Company to reduce future employer contributions or to pay Plan administrative expenses. Forfeitures of \$3,804 and \$3,667 were used by the Company to reduce its 2024 and 2023 contributions, respectively. At December 31, 2024 and 2023, there were unallocated forfeitures of \$4,640 and \$2,012 that are available to reduce future employer contributions or Plan administrative expenses.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participants who borrowed from their accounts are responsible for loan origination fees and maintenance fees, which are charged directly to their plan accounts.

**2. Summary of Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting. Benefit payments are recorded when paid.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Subsequent Events***

Subsequent events have been evaluated through October 15, 2025, the date the financial statements were available to be issued.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded against the participants' accounts as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions in accordance with the loan provisions of the Plan document.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is an exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. See Note 3 for a discussion of fair value measurements.

The Plan presents in the statements of changes in net assets available for benefits the net change in fair value of investments, which consists of realized gains or losses and unrealized appreciation or depreciation on those

investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

***Investment Fees***

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and, thus, are not separately presented as an expense in the accompanying financial statements.

**3. Fair Value Measurements**

Under the *Fair Value Measurements* topic of the Accounting Standards Codification ("ASC"), the framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – observable inputs, such as unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2 – quoted prices in active markets for similar assets and liabilities, and other inputs that are observable directly or indirectly for the asset or liability; or

Level 3 – unobservable inputs for the asset or liability, such as discounted cash flow models or valuations.

During the years ended December 31, 2024 and 2023, there were no changes in methodologies for determining fair value measurements and there were no transfers between fair value hierarchy levels.

The determination of where assets and liabilities fall within this hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Mutual Funds*** – Share prices or net asset values ("NAVs") for the Plan's mutual funds are generally obtained from the National Securities Clearing Corporation file feed, and/or directly from the fund house, or a secondary pricing source, such as the Interactive Data Corporation ("IDC").

**4. Income Tax Status**

The Plan received a letter from the Government of Puerto Rico Treasury Department in February 2020, stating the Plan qualifies under sections 1165(a), (e), and (g) of the IRCNPR. The Plan has been amended since receiving the Treasury Department letter to comply with the statutory and regulatory provisions of the Internal Revenue Code of 2011. The Plan administrator has evaluated the nature of these amendments and concluded that they do not constitute “qualification amendments” requiring a new determination letter. The Plan administrator believes the Plan is designed and being operated in compliance with all applicable requirements of both Title I of ERISA and the IRCNPR.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**7. Party-in-Interest Transactions**

The Plan issues loans to participants that are secured by the vested balance of the participants’ accounts that qualify as party-in-interest transactions.
