### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gregg Young Automotive Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

## **Note 1 - Description of Plan**

The following brief description of the Gregg Young Automotive Group 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a multiple employer defined contribution plan sponsored by Gregg Young Automotive Group (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer's management is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Employer is a member of a controlled group and the participating employers (collectively, the Employers) include:

- Gregg Young Chevrolet, Inc.
- Gregg Young Chevrolet of Norwalk, Inc.
- Gregg Young Plattsmouth, LLC
- Gregg Young Buick GMC, LLC
- GYDNT, LLC dba Gregg Young Auto Center
- Gregg Young Automotive Group Management Company
- Gregg Young Automotive of Ottumwa
- Gregg Young Automotive of Atlantic
- Gregg Young Automotive of Marshalltown
- All World Ford
- Chrysler World

Effective January 1, 2024, Gould Young Construction joined the Plan as a participating employer.

Effective January 18, 2024, GYTC, LLC dba Gregg Young Toyota of Columbus and GYCGC, LLC dba Gregg Young Chevrolet GMC Columbus joined the Plan as participating employers.

Effective April 1, 2024, Extra Mile Partners joined the Plan as a participating employer.

Effective May 9, 2024, Gregg Young Mitsubishi was removed from the Plan as a participating employer.

### **Eligibility**

All employees, except dealer trade drivers, of the Employers who are age 21 or older and have completed one year of service (defined as twelve consecutive months with 1,000 hours of service) are eligible to participate in the Plan.

### **Entry Date**

Employees may enter the Plan on the first day of the Plan year quarter coinciding with or next following date they satisfy the Plan's eligibility requirements.

### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Employers may make a discretionary matching contribution to each participant based on his or her elective deferrals in a percentage set by the Employers prior to the end of each Plan year. The Employers elected a matching contribution rate of 25% of the participant's contributions that do not exceed 5% of eligible compensation for the year ended December 31, 2024, (maximum Employers' matching contribution is 1.25% of eligible compensation).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect a different deferral rate or not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions (including rollovers) and the Employers' matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment to the Plan, a participant may direct deferrals and Employers contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the Employers contribution portion of their accounts is based on years of continuous service.

Vesting is based on years of credited service as set forth in the following table:

<u>Years of Service</u>	<u>Vesting Percentage</u>
One but less than two	25%
Two but less than three	50%
Three but less than four	75%
Four or more	100%

Separate provisions apply in the event of death or disability of the participant or reaching normal retirement age.

### **Forfeitures**

At December 31, 2024 and 2023, the available forfeiture balances were \$3,980 and \$2,284, respectively. These accounts will be used to reduce future Employers matching contributions. Employers matching contributions were reduced by \$9,031 of forfeited nonvested accounts in 2024.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence. A participant may have no more than 2 outstanding notes at one time. Interest rates range from 8.75% to 9.50% and the notes mature between May 2026 and December 2029.

### **Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, partial payments or annual installment payments as defined in the Plan document upon retirement, death or disability. For separation of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

### **Plan Termination**

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employers contributions.

## **Note 2 - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee.

The fair value of pooled separate accounts is determined by the net asset value (NAV) of the fund's underlying investments held at year end adjusted for any dividends or distribution received by John Hancock Life Insurance Company (U.S.A.) and the daily equivalent of any fee charged by John Hancock Life Insurance Company (U.S.A.) pursuant to the contract. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and the related Employers contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits payments to participants are recorded upon distribution.

**Expenses**

The Plan's expenses are paid by either the Plan or the Employers, as provided by the Plan document. Expenses that are paid directly by the Employers are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events occurring through October 15, 2025, the date which the financial statements were available to be issued.

**Note 3 - Investments Measured Using the Net Asset Value Per Share Practical Expedient**

(a) These funds provide a diversified exposure to stocks, bonds, and cash for those investors who have a specific date or investment strategy in mind for retirement or another goal. The target date portfolios aim to provide investors with an optimal level of return and risk, based solely on the target date. Over time, fund managers adjust the allocation among asset classes to more conservative mixes as the target date approaches. The lifestyle portfolios aim to provide investors with aggressive, growth, balanced, and conservative strategy goals.

(b) This class seeks to maximize long-term capital growth through the purchase of investments whose market values are generally traded below their intrinsic market value based on factors such as assets, earnings or potential growth.

(c) This class seeks capital appreciation through the purchase of investments whose market values are generally traded below their intrinsic market value based on factors such as assets, earnings or potential growth.

(d) This class seeks to provide both growth and income, with the stability of principal, through the investment in equities and fixed income accounts.

(e) This class typically invests in a strategic mix of global fixed income sectors to seek high income and diversification.

(f) This class seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

#### **Note 4 - Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the trustee of the Plan).

#### **Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by Benefit Plans, Inc. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Related Party and Party-in-Interest Transactions**

Certain Plan investments consist of pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A), the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in value in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefit.

**Note 8 - Subsequent Events**

Effective April 1, 2025, Pivot Prime joined the Plan as a participating employer.

Effective July 30, 2025, the Plan was formally amended to adopt certain provisions of SECURE Act and other legislative and regulatory changes. The Plan has also adopted certain provisions to comply with other recent legislative and regulatory changes, such as SECURE 2.0 Act, however, as allowed by those regulations, the Plan has not been formally amended.
