Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Steinberg Hart 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

1. DESCRIPTION OF PLAN

The following description of Steinberg Hart 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Steinberg Hart is the Plan Sponsor. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan’s provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan is a defined contribution plan covering all eligible employees of Steinberg Hart, RJC Architects, Inc., and Steinberg Hart New York (the “Companies”) as defined in the Plan Document. The Plan was originally established in 1987 and is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”), and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Employees who are at least 21 years of age and have completed at least three months of service are eligible to participate in the Plan. The Plan allows for employees to begin participating on the first day of the month coinciding with or following satisfaction of the eligibility requirements.

Contributions

Participants may elect to contribute on a before-tax basis, after-tax basis, or a combination of both, from 1% to 75% in whole percentages of their covered compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Eligible employees have the option to opt out of the automatic deferral election by making a contrary election. Automatically enrolled participants have their deferral rate set with an initial contribution rate of 6% of eligible compensation, increased annually by 1%, up to a maximum of 10%, and their contributions invested in a designated balanced fund until changed by the participant.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

The Plan Sponsor may make matching contributions to the Plan, with the percentage match determined by the Plan Sponsor. Matching contributions are calculated based on elective deferred contributions and compensation for the pay period, and are made for all active participants in the Plan during the particular payroll period. Total employer matching contributions for the year ended December 31, 2024 was \$462,103. In addition, the Companies may make a discretionary non-elective contribution each year as determined by the governing body of the Companies. There were \$847,673 of employer discretionary non-elective contributions (profit sharing contributions) for the year ended December 31, 2024.

Contributions (continued)

Participant and employer contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Investment Options

Participants direct the investment of their participant and employer matching and discretionary non-elective contributions into various investment options offered by the Plan. The Plan currently offers various funds in pooled separate accounts, mutual funds, collective investment trusts as investment options for participants. Participants can change their investment options at any time.

Participant Accounts

Individual accounts are maintained for each Plan participant to reflect the participant’s contributions, related employer matching and discretionary non-elective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their participant contributions and employer matching contributions, plus actual earnings thereon. Vesting in the Companies' discretionary non-elective contributions and earnings thereon is based on years of continuous service. If a participant terminates employment prior to normal retirement age (65 years of age) or any reasons other than death or permanent disability, the portion of the Companies' non-elective discretionary contribution that is vested is as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the value of their account balance. The loans are secured by the balance in the participant’s account. The loan interest rate, determined quarterly, is set at 1 percent above the prime rate, as defined. Loan terms range from one to five years for general purpose loans and up to 30 years for principal residential loans. Principal and interest is paid ratably through bi-weekly payroll deductions. Interest rates on participant loans range from 4.25% to 9.50% at December 31, 2024.

1. DESCRIPTION OF PLAN (Continued)

Participant Withdrawals and Payment of Benefits

Participants may withdraw all or any portion of their after-tax and rollover contributions. Participants may make full or partial withdrawals of funds in any of their accounts upon attaining age 59½ or for financial hardship, as defined, before that age. Participants may qualify for financial hardship withdrawals if they have an immediate and heavy financial need, as long as they meet the specific rules in the Plan Document.

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of time subject to the automatic distribution features below. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In the event the participant terminates service and the participant's vested interest in their account is less than \$5,000, excluding amounts contributed as rollover contributions to the Plan, the participant has the ability to elect to have a distribution paid directly to an eligible retirement plan (specified by the participant) in a direct rollover. If no such election is made, then the Plan Administrator will pay the distribution in a direct rollover to an individual retirement plan designated by the Plan Administrator for the benefit of the participant.

In the event the participant terminates service and the participant's vested interest in their account is greater than \$5,000, excluding amounts contributed as rollover contributions to the Plan, the participant has the ability to elect to have a distribution paid directly to an eligible retirement plan (specified by the participant) in a direct rollover or to receive the distribution directly in accordance with Plan Document, or, can elect to defer or receive the account in installment payments.

Forfeited Accounts

Forfeited nonvested accounts will be used to reduce any employer contributions and/or pay Plan administrative expenses. At December 31, 2024 and 2023, the unallocated forfeited balances in the Plan were \$1,016 and none, respectively. For the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or pay plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s realized and unrealized gains or losses on investments bought and sold as well as held during the year.

Other Assets

Life insurance policies, held separately through New York Life Insurance Company, are valued at the net cash surrender value. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are either included in net appreciation of fair value of investments or in administrative expenses.

3. INVESTMENTS CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants, except for the other assets of \$246,773 and \$232,792 as of December 31, 2024 and 2023, respectively, disclosed in the accompanying financial statements and supplemental schedule, which include investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by The Principal Trust Company (“The Principal”), the custodian of the Plan, in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments in Level 1 include listed equities and other securities held in the name of the Plan, and exclude listed equities and other securities held indirectly through commingled funds.

Level 2 - Pricing inputs, including broker quotes, are generally those other than exchange quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value is determined through the use of models or other valuation methodologies.

Level 3 - Pricing inputs are unobservable for the investment and include situations where there is little, if any market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. Investments that are included in this category generally include privately held investments and partnership interests.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

4. FAIR VALUE MEASUREMENTS (Continued)

Pooled Separate Accounts ("PSAs"): The fair value of the underlying mutual fund the PSA is invested in is a publicly quoted pricing input which used in determining the net asset value ("NAV") of the pooled separate account, which is not publicly quoted. For those PSAs investing in mutual funds or domestic equity securities, the investments are valued at NAV using quoted prices in active markets for identical assets. For those PSAs directly investing in fixed maturity securities, the investments are valued based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This fund contains conventional guaranteed investment contracts valued using a discounted cash flow methodology, as well as synthetic investment contracts comprised of underlying investment and contractual components which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Although contract value is the relevant measurement for the portion of the net assets of a collective investment trust attributable to fully benefit-responsive investment contracts, this fund is stated at fair value because all contracts are between the fund and the issuers, and not directly with the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by The Principal, the custodian of the Plan. Fees incurred by the Plan for the investment management services and retirement plan benefits administration/consulting services are included in either net appreciation in fair value of the investments or in administrative expenses. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. The Plan made direct payments to the custodian, investment advisor, and retirement plan benefits administrator of \$86,557 for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations, including, but not limited to: audit and legal fees.

6. INCOME TAX STATUS

The Plan obtained an opinion letter for the prototype plan on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS

In preparing these financial statements, the Plan administrator has evaluated subsequent events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.
