INDEPENDENT AUDITORS' REPORT

To the Trustees of the
Impact Tax Deferred Annuity Plan,

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Impact Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Impact Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1: DESCRIPTION OF PLAN

The following description of the Impact Tax Deferred Annuity Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Principles, Inc. dba Impact Drug & Alcohol Treatment ("Company"). Employees are eligible for salary reduction upon employment commencement with the Company with a Plan entry date on the first day of each calendar month coinciding or following their first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Per the Plan Document, participants may elect to contribute up to 100% of their pre-tax annual compensation up to the annual maximum allowable under the Internal Revenue Code. The Plan also provides for transfers from other eligible plans. The Plan calls for an Employer Non-Elective Contribution. The percentage of the Employer Non-Elective Contribution is at the Company's discretion and determined each year. For Plan year ended December 31, 2024, the Company did not make any Non-Elective Employer Contribution.

The Plan also calls for Employer Matching Contributions. Under this provision, Plan Sponsor makes matching contributions to the Plan equaling 100% of participant's deferrals up to 6% of their eligible compensation. These contributions vest immediately. For Plan year ended December 31, 2024, Employer Matching Contributions totaled \$643,819.

Participant Accounts

Each participant is credited with the participant's contributions and allocations of (a) the Company's contribution, when applicable and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employer Non-Elective Contributions, Employer Matching Contributions and participants contributions including rollover contributions, plus actual earnings thereon are immediately vested.

Notes Receivables from Participants

The Plan does not permit notes receivable from participants.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments not to exceed the participant's (and beneficiary's, if applicable) life expectancy. If a participant's vested benefit in the Plan does not exceed \$5,000, then their distribution will be in a lump-sum payment. A participant may make a hardship withdrawal from the participant's account subject to certain ERISA provisions.

Forfeited Accounts

Per the Plan Document, Company contributions as a result of inclusion of ineligible employees, or distribution payables to participants and their beneficiaries that cannot be located may be used to reduce future Company contributions. There were no forfeitures of employer matching contributions during the year ended December 31, 2024.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. The Company and the Plan management determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company.

Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Company pays all costs for administering the Plan, with the exception of benefit payment fees which are specifically allocated and deducted from the participants' accounts. Commissions paid by the insurance carrier to the broker at the Plan Custodian amounted totaled \$16,958 for the year ended December 31, 2024.

NOTE 3: CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in investments and interest for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the Custodian of the Plan.

NOTE 4: PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS

Certain of the Plan's investments are funds managed by the Custodian and related entities. Therefore, these transactions qualify as party-in-interest transactions. The Company paid fees for investment management services directly.

NOTE 5: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Pooled Separate Accounts: Valued at the accumulation unit value (AUV) multiplied by the accumulation units held. The AUV is based on the net asset value of the underlying mutual fund, the fund's dividends, and the contract's separate account changes. The AUV is not a publicly quoted price in an active market.

NOTE 6: GUARANTEED ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan holds a portfolio of annuity contracts issued by Voya Retirement Insurance and Annuity Company ("Voya"), the Custodian of the Plan. These annuity contracts guarantee principal and a guaranteed minimum interest rate for the life of the portfolio as well as featuring two declared interest rates, one current rate determined monthly, and a guaranteed minimum floor rate declared for a defined period, currently one calendar year.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023, were \$3,079,674 and \$2,837,060, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7: PLAN TERMINATION

The Company anticipates that the Plan will continue without interruption but reserves the right to discontinue the Plan at any time. In the event of discontinuance of the Plan, all participants will become 100% vested in their account balances and the net assets will be allocated among the participants and beneficiaries of the Plan.

NOTE 8: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue code ("Code"). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the code to maintain the tax-exempt status for plan participants under Section 403(b).

NOTE 8: TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income examinations for years prior to 2022.

The Plan is in the process of being amended to stay in compliance with the current laws and regulations.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan provides for various investment options in money market funds, mutual funds, and a collective investment trust. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the various risk factors, in the near term, could materially affect participants' account balances and amounts reported in the financial statements.

NOTE 10: RECONCILIATION TO FORM 5500

There are no material differences between the financial statements and the information included on Forms 5500 as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

NOTE 11: SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued and concluded there are no subsequent events to report.
