### Note 1: Description of Plan

The following description of the Sterling Products, Inc. 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Sterling Products, Inc., AEC, Inc., and Wabash Metal Products, Inc., (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Custodian of the Plan is Matrix Trust Company (Matrix). The Recordkeeper of the Plan is OneAmerica Retirement Services LLC.

#### Eligibility

Substantially all employees, excluding leased employees and those covered under a collective bargaining agreement, are eligible to participate in the Plan upon attaining age 18 and completing one month of service. Interns and temporary employees are eligible to participate upon attaining age 21 and completing one year of service. Employees are eligible to enter the Plan on the first day of the month subsequent to or coinciding with satisfaction of these requirements.

#### Contributions

Each year, participants may contribute 1% to 75% of pre-tax annual compensation, as defined by the Plan, not to exceed the annual maximum allowable by the Internal Revenue Service (IRS). The Plan has a provision for automatic pretax elective deferral contributions at 6% of an employee's eligible compensation, unless another affirmative election is made. The Plan has a provision to require automatic participant deferral increases of 1% per year up to a maximum of 15% of a participant's compensation, unless the participant elects to opt out of the increase. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers) and make Roth deferrals.

The Company may make a discretionary matching contribution to the Plan. During 2024, the Company made a discretionary match equal to 50% of each participant's contribution, up to 6% of eligible compensation. Additional discretionary contributions may be contributed at the option of the Company's Board of Directors. There were no additional discretionary contributions in 2024.

#### Investment Options

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants direct their contributions and all of their account balances among the Plan's investment alternatives. All investments are participant-directed and participants may change their investment options at any time.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service. A participant is 100% vested after 5 years of credited service, with 20% vesting credited to the participant per year of service. A participant also becomes 100% vested upon the attainment of age 60.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$48,258 and \$83,637, respectively. Forfeitures may be used to pay administrative expenses or reduce future Company contributions. During 2024, \$88,298 of forfeitures were used to reduce Company contributions.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. A participant may not have more than one note outstanding at any given time. Note terms may not exceed five years unless the purpose of the note is to acquire a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Upon termination of service, including death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. In-service distributions from the participant's elective contribution portion of their account are permitted once a participant reaches the age of 59 1/2.

Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes and penalties) from the participant's elective contribution portion of their account.

### **Note 1: Description of Plan (Continued)**

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### **Secure 2.0**

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Investment Committee determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

#### Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued as determined by the issuer of the common collective trust using NAV per share measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The objective is to maintain safety of principal while generating a level of current income exceeding that of a money market. The Stable Value Fund seeks to maintain a stable \$1.00 unit value although there is no guarantee it will be able to do so. The Stable Value Fund invests in traditional and synthetic guaranteed income contracts with various crediting formulas. The Stable Value Fund manager may limit withdrawals in order to maintain sufficient liquidity.

Investments in the common collective trust can be purchased and sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

### **Note 4: Information Prepared and Certified by Custodian**

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held, noninterest-bearing cash, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Matrix.

### **Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 6: Tax Status**

The Plan has received a favorable determination letter dated January 27, 2015, from the IRS stating that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and, accordingly, believes the Plan is exempt from federal and state income taxes.

### **Note 7: Party-In-Interest Transactions**

The Plan holds investments in funds and accounts managed by the Recordkeeper of the Plan, pays fees to the Custodian, and holds notes receivable from participants. These transactions are party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
