## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Paragon Healthcare 401(K) Plan  
Plano, Texas

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Paragon Healthcare 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets (in liquidation) as of November 5, 2024, statement of net assets available for benefits as of December 31, 2023 (Ongoing), and the related statement of changes in net assets (in liquidation) for the period ended November 5, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Paragon Healthcare 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 5, 2024 and December 31, 2023, and for the period ended November 5, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Paragon Healthcare 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 1 to the financial statements, the Plan Sponsor of Paragon Healthcare 401(K) Plan approved a plan for liquidation on March 11, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the accrual basis of accounting for an ongoing plan used in presenting the 2023 financial statements to the liquidation basis of accounting used in preparing the 2024 financial statements. Our opinion is not modified with respect to this matter.



## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Paragon Healthcare 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering full-time employees of Paragon Healthcare, Inc. (the Company) immediately upon hire. There is no age or service requirement. Plan entry dates are the first day of the month coinciding with eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan Sponsor.

On March 11, 2024 (termination date), the Company approved the termination of the Plan as the result of the March 11, 2024 acquisition by Elevance Health, Inc. Pursuant to this acquisition, the Company's participant accounts were fully vested as of the Plan's termination date and the Plan has subsequently distributed all assets to participants. As of the termination date, no additional service benefits were accrued. As of November 5, 2024 all Plan assets had been distributed.

**PLAN ADMINISTRATION**

The Custodian of the Plan is Voya Retirement Insurance and Annuity Company (Voya). Voya is responsible for managing the Plan's investment assets. Voya also serves as the Third-Party Administrator (TPA) and performs the Plan's administrative duties such as preparation of the Form 5500, participant recordkeeping, compliance testing, and transaction processing. Employees of the Company may perform certain other administrative functions; however, such employees receive no compensation from the Plan.

**CONTRIBUTIONS**

Prior to the acquisition, participants could elect to contribute amounts from eligible compensation not to exceed the limits of Internal Revenue Code (IRC) Section 401(k). In addition, participants that reached age 50 before the close of the Plan year could make catch-up contributions. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered various pooled separate accounts and an insurance company general account fund as investment options for participants. The Company matched 100% of the first 3% of eligible compensation contributed by participants and 50% of the next 2% of eligible compensation, which qualified as safe harbor matching provisions. Contributions were subject to Internal Revenue Service (IRS) limitations.

**PARTICIPANT ACCOUNTS**

Prior to the acquisition, each participant's account was credited with the participant's contribution, the Company's matching contribution, and an allocation of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Prior to the termination of the Plan, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of the participant's account balance or \$50,000. Participants may have no more than two loans outstanding at any time. Notes were secured by the balance in the participant's account and bear interest at a rate of 5.25% - 10.50%. Principal and interest are paid ratably through payroll deductions or additional payments can be made directly through Voya.

**PAYMENT OF BENEFITS**

Prior to the termination date of the Plan, participants were entitled to the benefits that could be provided from their individual account balances, subject to vesting, upon retirement, death, hardship, or termination. Payment is required to be made as soon as administratively feasible after one of these events occurs. The participant may elect to defer distribution until April 1 of the calendar year following the calendar year in which such a participant reaches 72 years of age. The vested portion of the participant's benefits may be distributed to the participant or his beneficiary in the form of a single lump-sum payment, partial withdrawals, installments (for required minimum distributions), or as a direct rollover to an IRA.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**FORFEITED ACCOUNTS**

Prior to the termination date of the Plan, forfeitures could be used to reduce employer contributions. For the periods ended November 5, 2024 and December 31, 2023, there were no forfeitures.

**VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the employer safe harbor matching contributions. As of March 11, 2024, all participants became fully vested due to the Plan termination.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

Effective March 11, 2024, the Company, as Plan Sponsor, elected to terminate the Plan. Accordingly, the Plan changed its basis of accounting from the accrual basis of accounting for an ongoing plan used in preparing the 2023 financial statements to a liquidation basis of accounting used in preparing the 2024 financial statements, in conformity with accounting principals generally accepted in the United States of America (GAAP). This change in basis of accounting had no material effect on the Plan's financial statements.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of November 5, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments, and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

As of November 5, 2024, the Plan had no assets or liabilities. As a result of the termination of the Plan, the Plan's investments were stated at liquidation value as of the termination date, which approximated fair value, except for the fully benefit-responsive contract, which was recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the Plan Custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Prior to the termination of the Plan, participants could invest in a general insurance account through the Voya Fixed Income Fund (the Fund), which is sponsored by Voya. The Fund invested in fully benefit-responsive investment contracts through a general insurance account. Benefit responsive features are carried at cost plus accrued interest (contract value). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**EXPENSES**

The Company, at its sole discretion, may pay the administrative expenses (i.e., custodian fees, fund fees, loan fees, recordkeeping fees, and other similar expenses) of the Plan. If such expenses are not paid by the Plan Sponsor, they are paid out of Plan assets. Investment-related expenses are included in net appreciation in the fair value of investments.

**TRANSFERS OUT**

Transfers out of the Plan represent outstanding participant loan balances as of the termination date of the Plan. These loan balances were transferred to the acquiring entity's TPA instead of being distributed, and are recorded as transfers out on the accompanying financial statements.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 5, 2024 and December 31, 2023.

*Mutual Funds:*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the funds. As of November 5, 2024 and December 31, 2023 the plan had \$- and \$39,037,685, respectively, invested in open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded and considered Level 1 investments.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements and supplemental schedules.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan had fully benefit-responsive investment contracts with Voya totaling \$- and \$3,238,320 at November 5, 2024 and December 31, 2023, respectively. Voya maintains the contributions in a general insurance account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. At November 5, 2024 and December 31, 2023, the average yield earned by the fund and the average rate credited to participants was 1.50% and 1.38%, respectively.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY - CONTINUED**

Since the contract is an obligation of Voya, the occurrence of an event that limits the ability of the investment to transact at contract value between Voya and a participant holding the investment is not probable.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya. Third party administration of the Plan is provided by Voya. Voya is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan totaled \$106,445 for the period ended November 5, 2024.

**NOTE 7 - TAX STATUS**

The Plan Sponsor has adopted a prototype plan which received a favorable tax opinion letter from the IRS that qualifies under IRC Section 401(a) and the Plan is therefore not subject to tax under present income tax law. The Plan Administrator and tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets in liquidation.
